
Control Panel



- 1. SOURCE TOUCHPAD: Select an audio source Bluetooth, COAXIAL, OPTICAL, AUX
- 2. SOURCE INDICATOR
- EQ TOUCHPAD: Select an EQ mode from STANDARD, MOVIE, MUSIC or NEWS.
- 4. EQ INDICATOR
- 5. STANDBY/MUTE INDICATOR
- 6. STANDBY/MUTE TOUCHPAD: Switch on the Sound bar or switch to STANDBY mode
- VOLUME + / TOUCHPAD: Increase or decrease the output volume.
- 8. REMOTE CONTROL RECEIVER
- 9. WALL-MOUNT BRACKETS: Use these brackets to fix the Sound bar to a wall.
- 10. SERVICE PORT: Not for user access.

- **11. AUX AUDIO INPUT (3.5mm):** Connect the analogue audio output from an MP3 player or similar using a 3.5mm audio cable.
- 12. COAXIAL AUDIO INPUT (RCA): Connect the digital audio output from a TV, DVD or Blu-ray player.
- **13. OPTICAL AUDIO INPUT:** Connect the digital optical audio output from a TV, DVD or Blu-ray player.
- **14. MAINS POWER DC INPUT:** Connect the supplied power adapter.
- **15. SUBWOOFER MAIN POWER DC INPUT:** Connect the supplied power adapter.
- **16. SYNC BUTTON:** Press and hold for 3 seconds to connect the soundbar to the **wireless** subwoofer.
- 17. SUBWOOFER INDICATOR: Indicates the current working status of the wireless subwoofer.

Muting Voice Confirmation

Set to AUX Mode, then press and hold the PLAY button for more than 5 seconds to turn off the voice confirmation function.

The voice confirmation will be muted the next time you turn your unit on.


To reactivate the voice confirmation function repeat the above steps.

Making the connections

Follow the below connection guide to connect the soundbar to a TV with or without a digital output, a Bluray/ DVD player or an audio source such as an MP3 player.

Only one digital connection to a TV is required. Use either the coaxial **or** optical connections DO NOT power on the mains until all other connections are made.





Installing the remote battery

1. Turn the battery cover counter clockwise using a coin to open the battery compartment.



 Insert the CR2032 battery into the battery compartment with the + symbol facing upwards.



3. Replace the battery compartment cover and turn clockwise using the a coin to close.



Battery disposal advice

- Dispose of used batteries with regard to the recycling regulations in your area.

Using your Soundbar

Let's get started

Standby mode

This unit is designed to enter STANDBY mode automatically after 20 MINUTES (approximately) of inactivity. Press the STANDBY touchpad to wake the unit.

- Press the STANDBY touchpad on the unit (6) or press the STANDBY button on the remote to put the system into standby mode.
- 2. To resume normal operation press either again.

Switching inputs

Follow the below steps to switch inputs between : Auxiliary, Coaxial, Bluetooth or Optical.


- **1.** Ensure the Sound bar is powered ON. If not press the STANDBY touchpad on the unit (6) or remote.
- Press the SOURCE touchpad on the unit (1) or remote repeatedly until you reach the required input mode.



When switching inputs there will be a 2 second pause after selecting BT while the unit scans for paired devices.

Syncing subwoofer with soundbar

- 1. Power the unit ON using the STANDBY touchpad.
- If the connection between the subwoofer and the soundbar is lost, both the indicator on the back of the subwoofer and the indicator of current SOURCE (2) will blink slowly.





- Press the SOURCE touchpad on the unit (1) or remote repeatedly until you reach the Bluetooth mode.
 - DO NOT attempt to connect your Bluetooth device with the soundbar before the subwoofer has been synced.
- 4. Press the **SYNC** button on the back of the subwoofer for 3 seconds.

If the syncing succeeds, both the indicator on the back of the subwoofer and the indicator of current **SOURCE** will stop blinking and remain solid.

If the syncing failed, both the indicator on the back of the subwoofer and the indicator of current **SOURCE** will blink slowly.

Repeat step 3 again to attempt syncing once more.

 The operation range of wireless subwoofer is approximately 6 meters (20 Feet). Any obstacles in the path between devices may reduce this range

Adjusting the volume

- To increase the volume level press the VOLUME+ touchpad on the main unit (7) or remote repeatedly or press and hold for fast adjustment. The STANDBY INDICATOR (5) will blink accordingly.
- To decrease the volume level press the VOLUMEtouchpad on the main unit (7) or remote repeatedly or press and hold for fast adjustment. The STANDBY INDICATOR(5) will blink accordingly.

EQ presets

 Press the SOUND EQ touchpad on the main unit (3) or remote control repeatedly to cycle through the EQ sound modes. The EQ INDICATOR (4) will change color accordingly. Choose between : STANDARD, MOVIE, MUSIC or NEWS.

Bass enhancement

- 1. To increase the bass press the BASS + button on the remote. The STANDBY INDICATOR (5) will blink accordingly.
- 2. To decrease the bass press the BASS button on the remote. The STANDBY INDICATOR (5) will blink accordingly.

The BASS levels range from -3 to +5.

Mute function

- Pressing the MUTE button on the remote will temporarily silence the audio output. The STANDBY INDICATOR (5) will flash.
- 2. Press the MUTE button again to resume the audio output. The STANDBY INDICATOR (5) will be off.

Using your Soundbar

Let's get started

Pairing a bluetooth device

Before you can use the sound bar with your phone or other bluetooth capable device you will need to pair the device to the sound bar.

- 1. Press the SOURCE touchpad on the main unit (1) or remote repeatedly until you see the blue LED.
- When selected the SOURCE INDICATOR (2) will flash while the unit tries to connect to previously paired devices. If no devices are found the SOURCE INDICATOR (2) will remain flashing to indicate it is ready for pairing a new device.
- Enable the Bluetooth function on your audio device and search for a device labelled 'MONSTER ARENA' in the available list.
- Select and enable pairing for the 'MONSTER ARENA' device. If prompted for a password enter '0000'.
- 5. If pairing is successful the sound bar will beep and the SOURCE INDICATOR (2) will stop flashing.
- If the connected device goes out of range, the sound bar will attempt to connect for 2 minutes. When the device comes into range the sound bar will reconnect again automatically.
- To remove a paired device, press and hold the II PLAY/PAUSE button on the remote control for 5 seconds. The SOURCE INDICATOR (2) will begin flashing once more.

Controlling a paired device

Once connected you can either use the controls on the audio device to begin playback, skip tracks etc. Or you can use the control buttons on the remote.

- The ►II PLAY/PAUSE button on the remote when pressed will begin playback of the selected track on the audio device. Press again to pause playback.
- 2. To skip to the next track press the SKIP ➡ button on the remote.
- 3. To skip to the previous track press the SKIP ⊯ button on the remote.
- **4.** Any further operations must be done from the audio device.

The volume output is effected by the volume level on the audio source EG: Phone or laptop, so make sure that is set to about 70-80% (not too loud to avoid distortion).

Bluetooth notes


- The operation range of bluetooth is approximately 10 meters (30 Feet). Any obstacles in the path between devices may reduce this range.
- Only one Bluetooth device can be paired at a time.
- Not all Bluetooth devices are compatible.

Wall mounting the soundbar

- Screw the two wall-brackets (supplied) to the back of the soundbar with the screws supplied in the locations shown below.
- Insert 2 screws (not supplied) into the holes and tighten. Take care to leave 5mm between the screw heads and the wall.



 Align the Sound bar in the chosen location. Use a pencil to mark the drilling positions (620mm /24.4") apart.




The Sound bar should be located 2-3" (5-8CM) below the TV.

3. Drill holes as marked in STEP2.



You will need to ensure the screws are long enough to sufficiently grip the wall while allowing 5mm between screw head ϑ wall.

5. Hook the Sound bar into the screws. For secure mounting ensure the screw heads slide firmly into the narrow part of the brackets.



- In order to avoid damage to the unit and personal injury you should get a qualified person to drill the fixing surface and fit the appropriate wall fixings.
- Take care not to allow the main unit to fall while attempting to hook onto the wall mount brackets.
- Before mounting, check the wall strength, if it is not clear then consult relevant qualified personnel.
- When drilling into walls, always check that there are no hidden wires or pipes etc.
- Make sure the screws & wall plugs are suitable for supporting the unit.

Care & maintenance

After using the Soundbar

Set to Standby.

Switch the unit off at the mains and unplug it if you are leaving it unattended for a long period (holidays etc).

Avoid leaving the battery fitted in the remote control if you leave the unit unattended for long periods. It may leak and damage the remote control.

Troubleshooting

No power.

- Ensure the mains plug is connected to a power supply, and is switched ON.
- Make sure there is power to the mains socket.

Optical cable does not fit well

Remove the clear rubber cap from each end before use.

No sound?

- Make sure if playing from the AUX input, the external
- source has the volume turned up and is playing a track.
- Make sure the volume is turned up.
- If using a digital coaxial or optical connection ensure the source DIGITAL output is set to PCM, LPCM, PCM 2Ch stereo or PCM downmix
- Bluetooth device not paired. Check 'Pairing a bluetooth device' on page 9.

No response from the Soundbar.

Unplug the power cable for 1 minute then plug back in again.

Care & cleaning

All care and cleaning operations should be carried out with the unit unplugged from the mains power.

Occasionally wipe the cabinet with a lint free duster. Never clean the unit with liquids or solvents.

I don't hear sound from my subwoofer.

- Verify that subwoofer is plugged into a power source.
- Check the white light on the back of the the subwoofer. If it is flashing white, you need to sync the subwoofer to the sound bar using the instructions on page 7.

Remote control does not work.

- · Reduce the distance between the remote and main unit
- Check the batteries are installed correctly.
- Replace the batteries
- Aim the remote directly at the Sound bar

Unit powers off after 20 minutes.
