Aquatic/Self-Righting Design

The ROAM has been designed to float to the surface when immersed in a body of water. This means you can safely use the speaker in a swimming pool, lake, or other similar areas.



 When floating in water, the speaker's built-in counterbalance will force it to face upwards. This allows the button interface to be accessible and prevents the audio from being muffled underwater.



The input/output port hole must be sealed before immersing the speaker in water. Make sure the twist cap is firmly in place and in the "closed" position. Leaving the cap detached or in the 'open" position may allow water to seep into the input/ output ports and permanently damage the speaker.


