#### **SET-UP AND OPERATION**


- 1. Place the AH-CO2THD cradle in the desired location with the optional mounting screws(2). Cradle can be mounted directly to drywall or ceiling tiles.
- 2. Press the button located on the bottom side of the Temperature Sensor AH-CO2THD to activate device.
- 3. An optional screw can be used to lock the Smart Switch in the cradle.




## **MECHANICAL (REAR VIEW)**
