The information provided by the sensor is used to determine whether lights should remain on or turned off to reduce energy consumption. The product has a 25-year battery life design and will not require AC or DC line power, providing building owners and occupants placement flexibility.

SET-UP AND OPERATION

- 2. Press the button located on the bottom side of the Occ/Vac Sensor VSW1301 to activate device.
- 3. An optional screw can be used to lock the Smart Switch in the cradle.




