

## 7.2 Antenna Requirement

### Standard requirement

15.203 requirement:

For intentional device. According to 15.203. an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.



- 3. Set the spectrum analyzer: RBW >= 1% of the 20dB bandwidth VBW >= RBW. Sweep = auto; Detector Function = Peak, Trace = Max Hold.
- 4. Mark the peak frequency and -20 dB points bandwidth.

## 7.4 Carrier Frequencies Separated

**Test Requirement:** FCC Part 15 C section 15.247

(a),(1) Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. 





### Middle Channels: Carrier Frequencies Separated




