





Channel 0:2.402GHz:



Channel 20:2.442GHz:







Channel 0:2.402GHz:



Channel 20:2.442GHz:




Channel 0:2.402 GHz:

30 MHz to 1GHz





Test Procedure:

Test site with RF absorbing material covering the ground plane that met the site validation criterion called out in CISPR 16-1-4:2007 was used to perform radiated emission test above 1 GHz.

The receiver scanned from the lowest frequency generated within the EUT to 25GHz. When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes.
