





- 3. Set the spectrum analyzer: RBW:1% ~5% of the 20dB bandwidth ,VBW >=3 RBW. Sweep = auto; Detector Function = Peak. Trace = Max Hold.
- 4. Mark the peak frequency and -20 dB points bandwidth.




Figure 3. Above 1 GHz

1) Below 30 MHz emissions:





#### **Test Procedure:**

Test site with RF absorbing material covering the ground plane that met the site validation criterion called out in CISPR 16-1-4:2010 was used to perform radiated emission test above 1 GHz.

The receiver scanned from the lowest frequency generated within the EUT to 25GHz.When an emission was found, the table was rotated to produce the maximum signal strength. While maintaining all of the other instrument settings. This peak level, once corrected, must comply with the limit specified in Section 15.209. If the dwell time per channel of the hopping signal is less than 100 ms, then the average field strength reading obtained with the 10 Hz VBW may be further adjusted by a "duty cycle correction factor", derived from 20log(dwell time/100 ms), in an effort to demonstrate compliance with the 15.209 limit.
