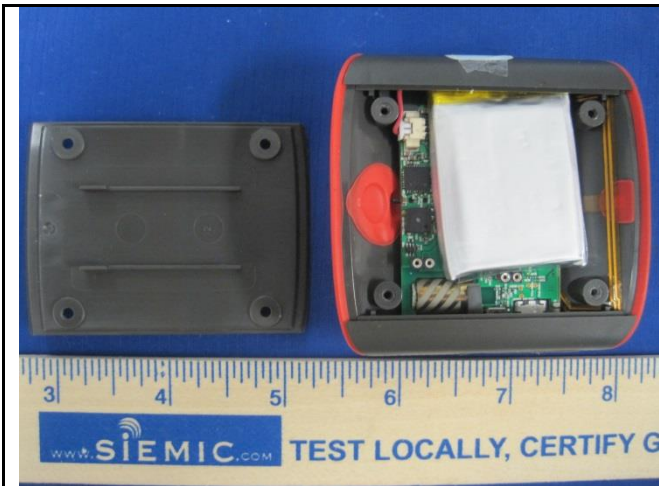

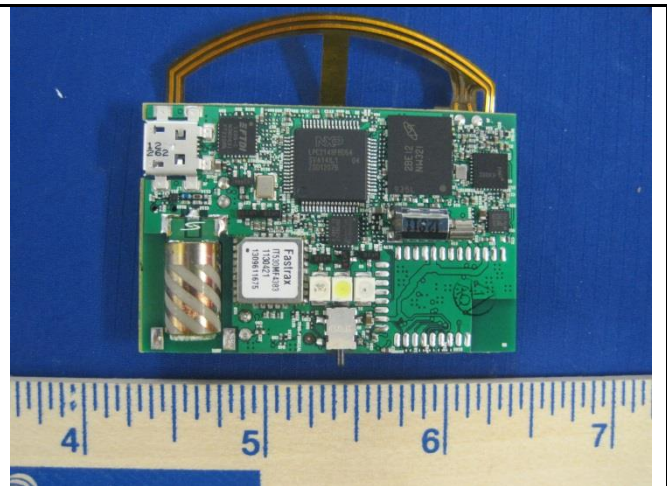

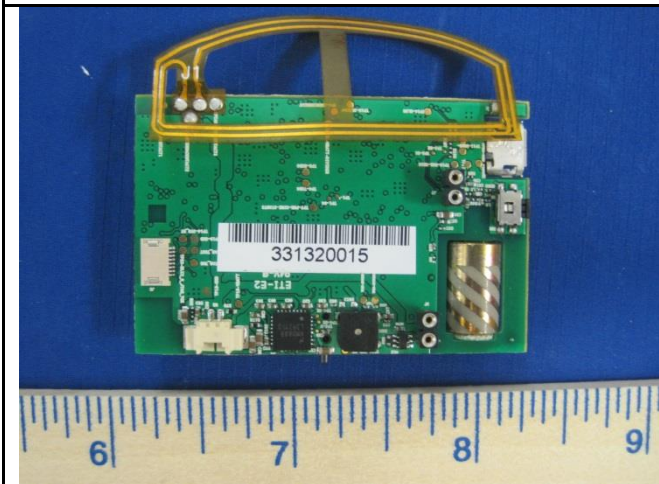

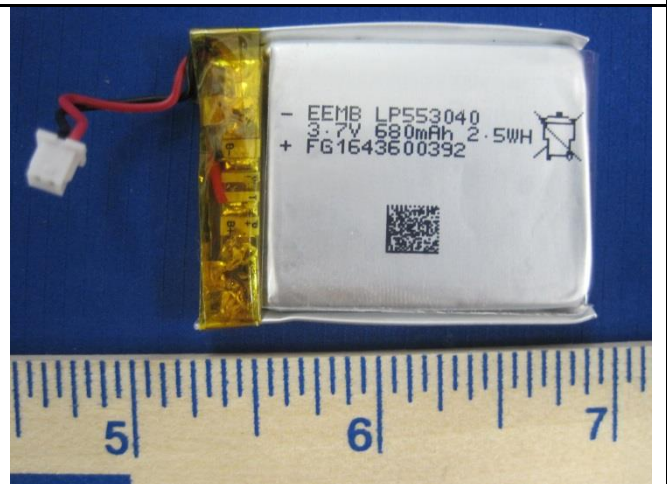

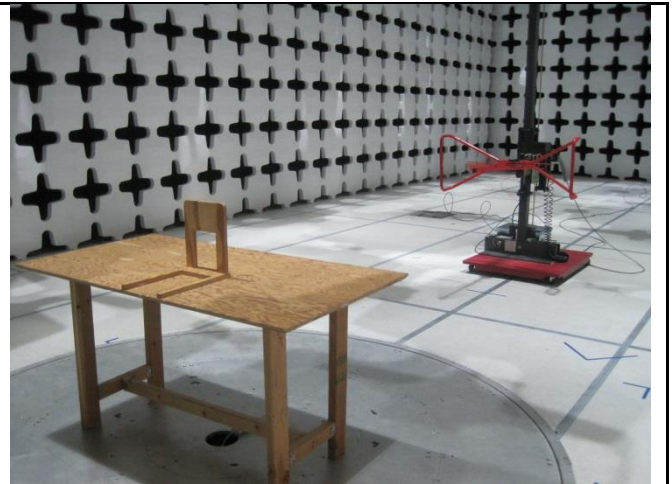

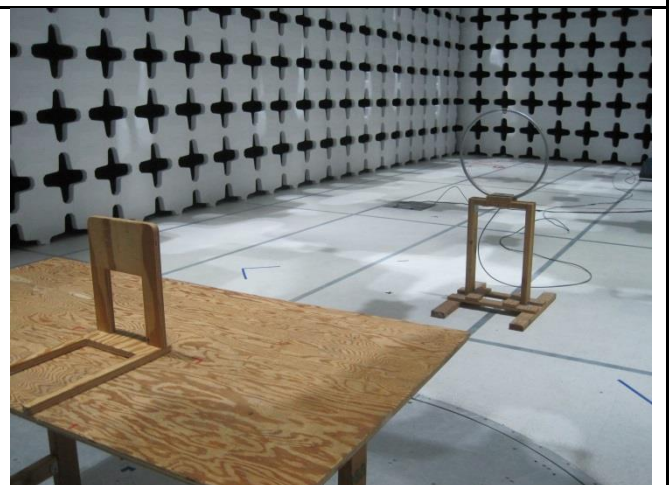
Radiated Emission Test setup (<1GHz) - Front



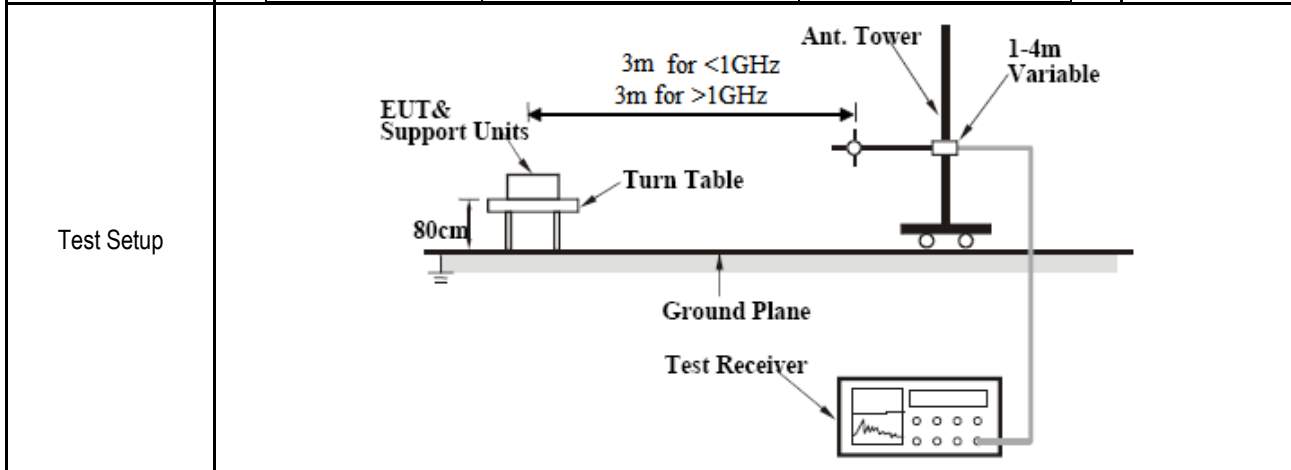

Procedure	1. The EUT was switched on and allowed to warm up to its normal operating condition.
	2. The test was carried out at the selected frequency points obtained from the EUT characterisation. Maximization of the emissions, was carried out by rotating the EUT, changing the antenna polarization, and adjusting the antenna height in the following manner: <ol style="list-style-type: none"> Vertical or horizontal polarisation (whichever gave the higher emission level over a full rotation of the EUT) was chosen. The EUT was then rotated to the direction that gave the maximum emission. Finally, the antenna height was adjusted to the height that gave the maximum emission.
	3. A Quasi-peak measurement was then made for that frequency point.

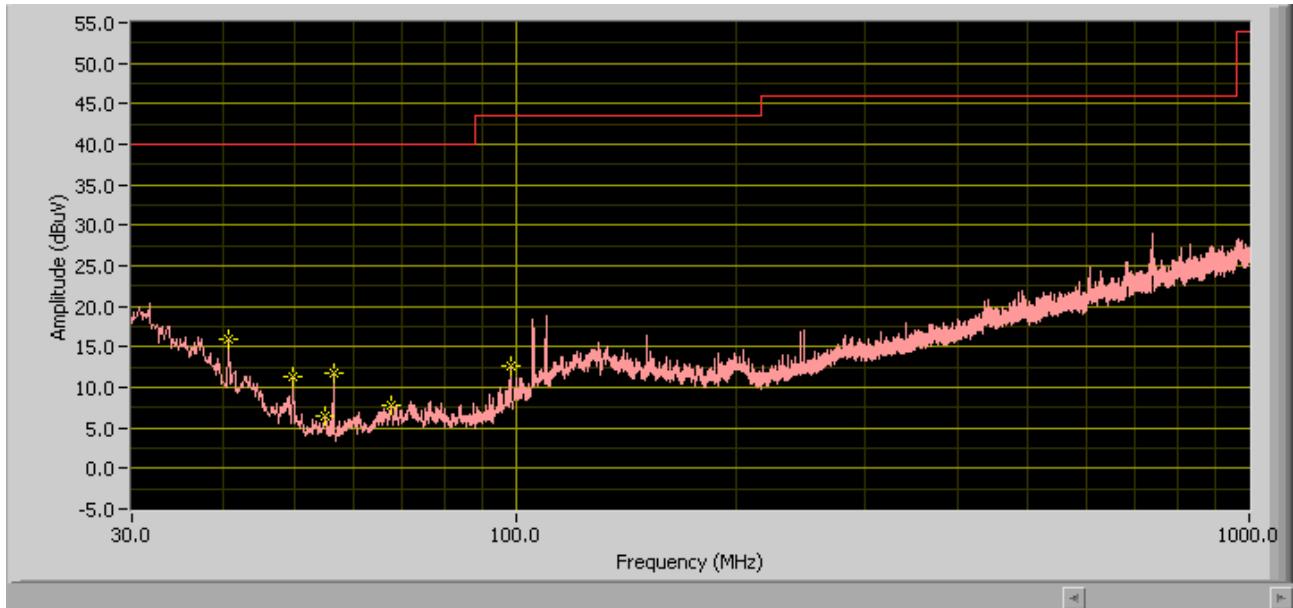

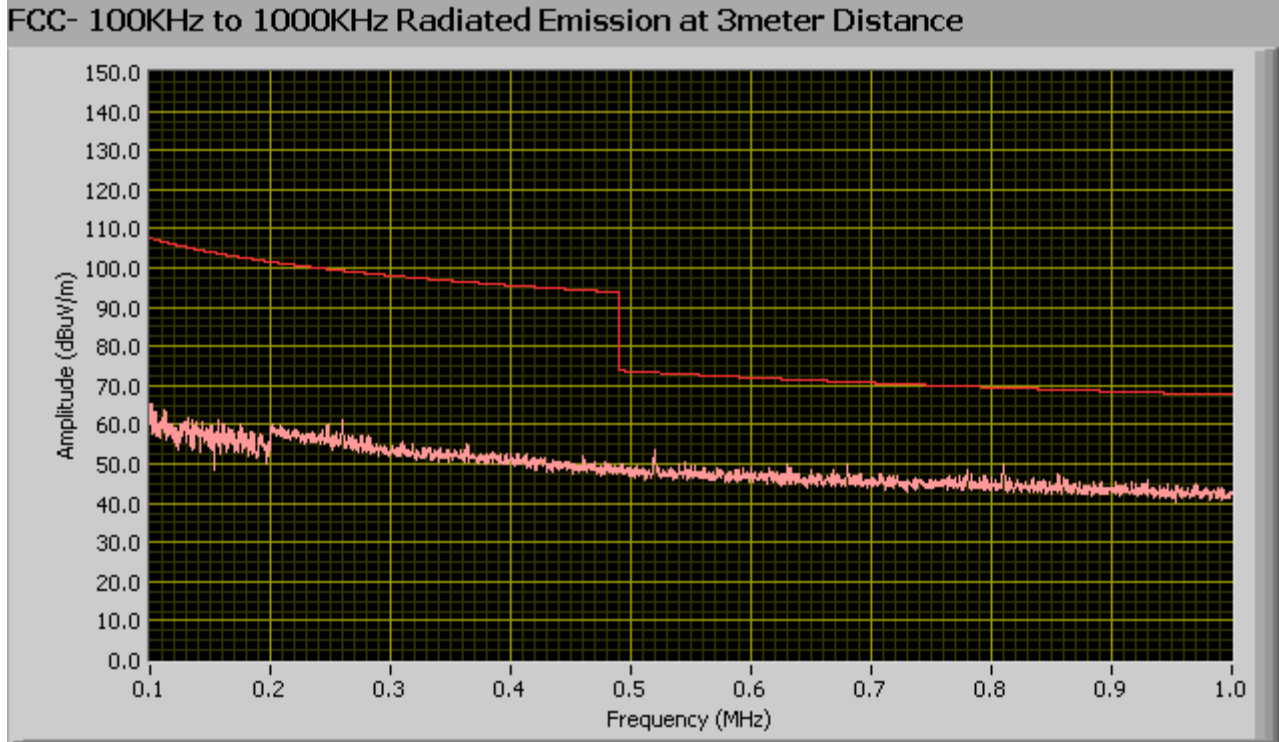

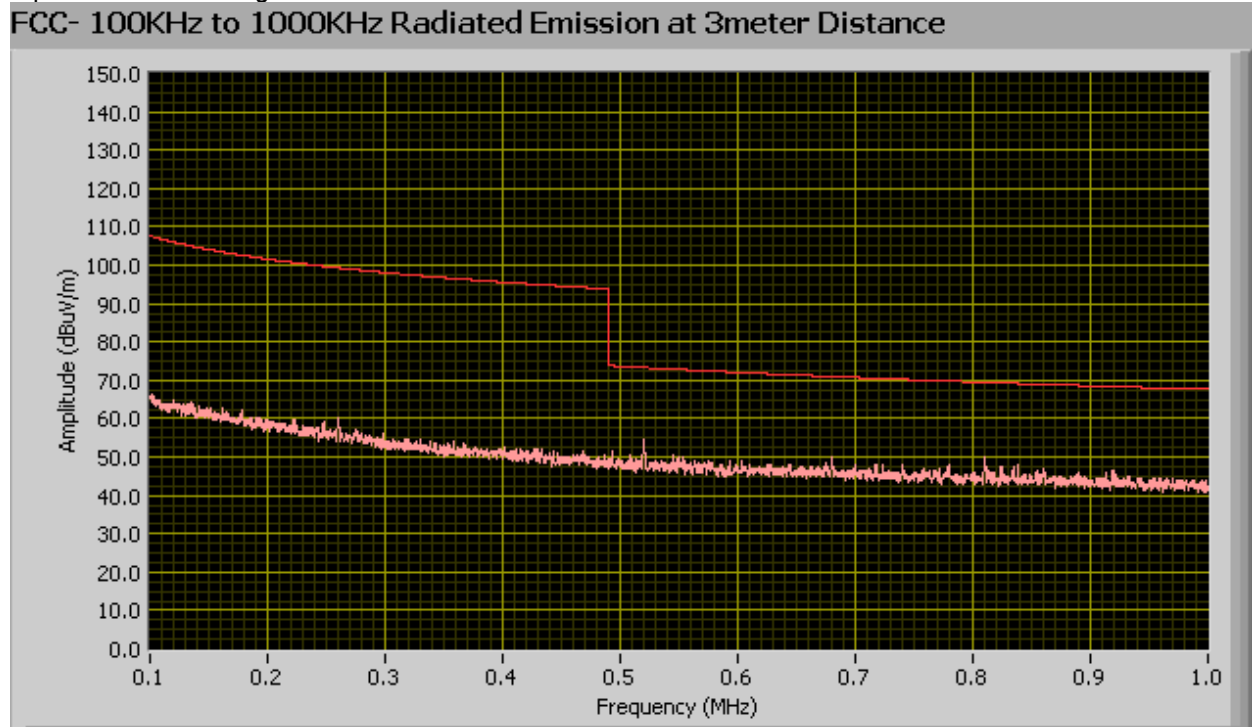
Plot: 100 kHz - 1 MHz

Loop Antenna at 90 degree

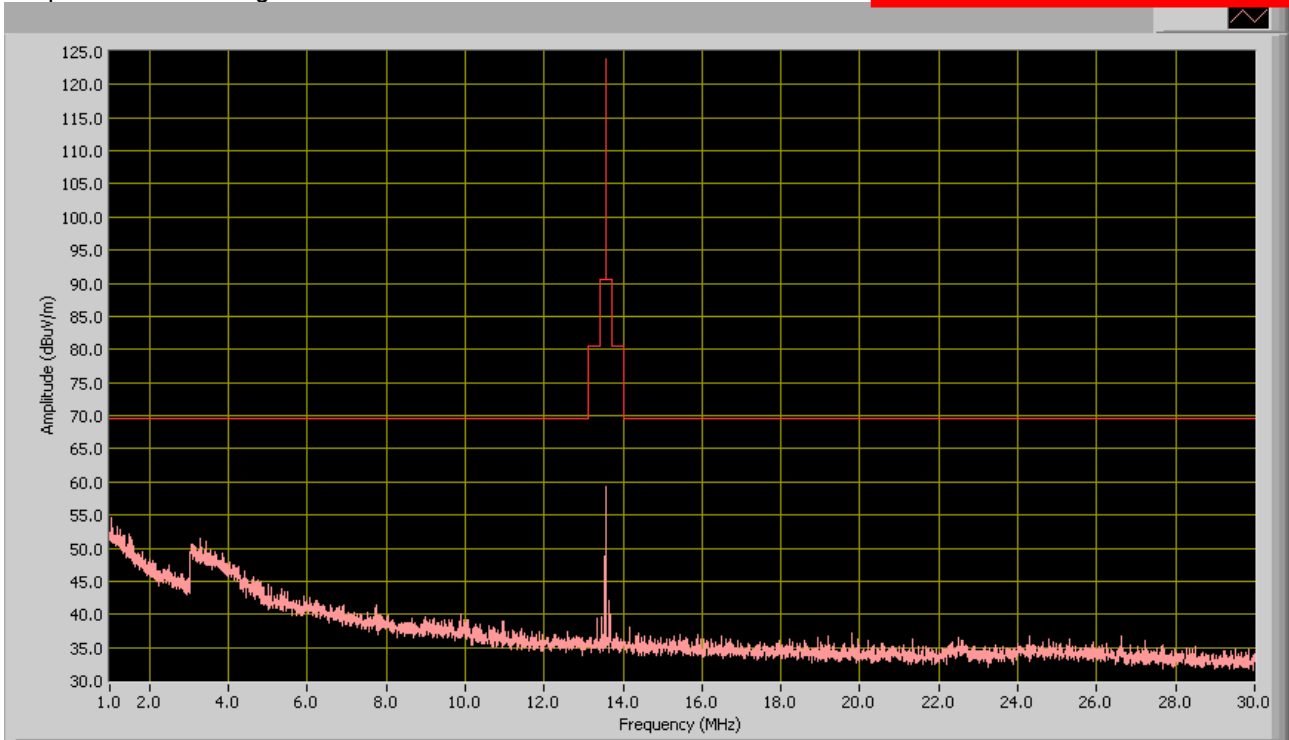

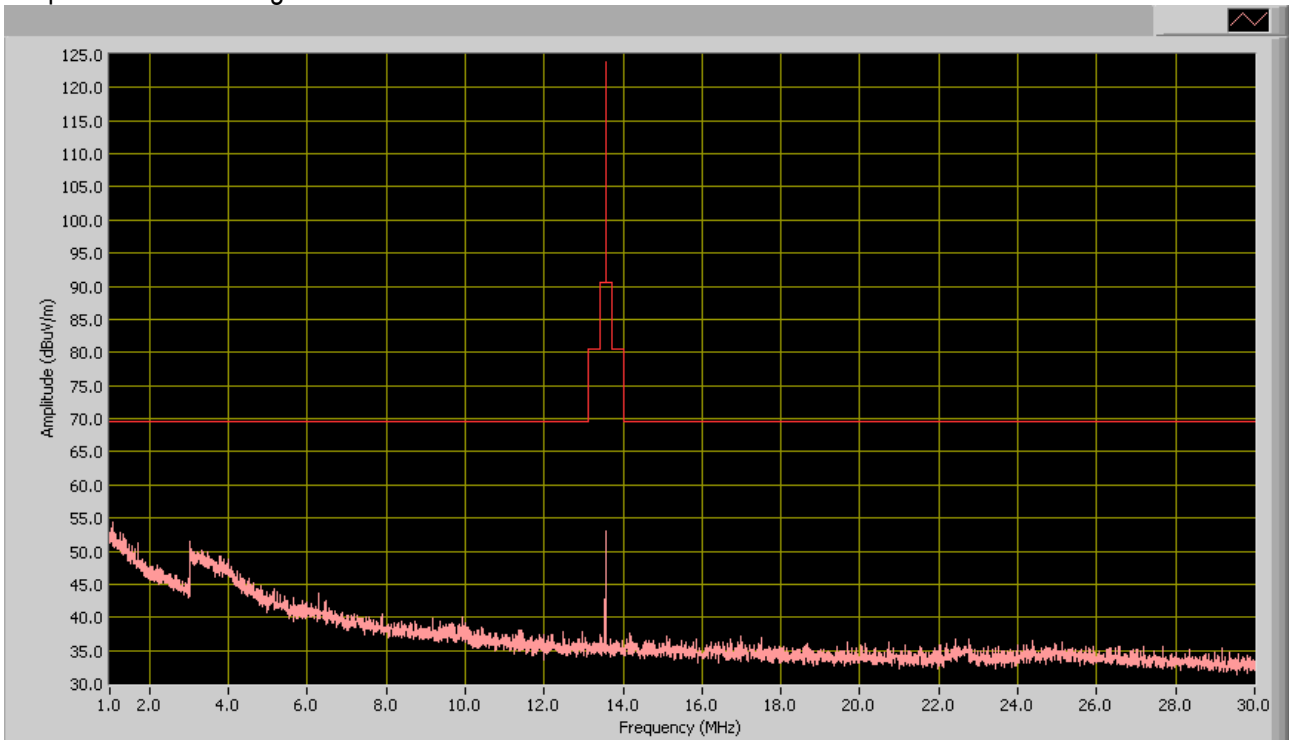
Plot: 1MHz-30MHz

General Emission Limit @ 3 meter

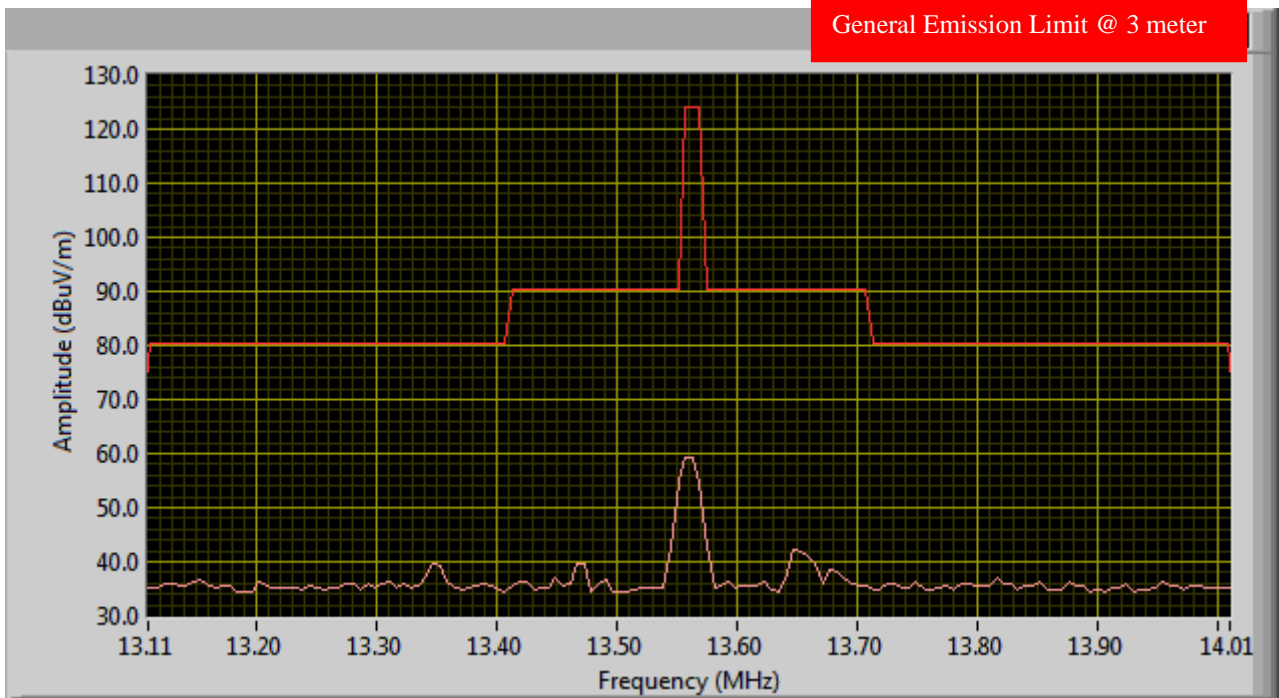


Loop Antenna at 90 degree



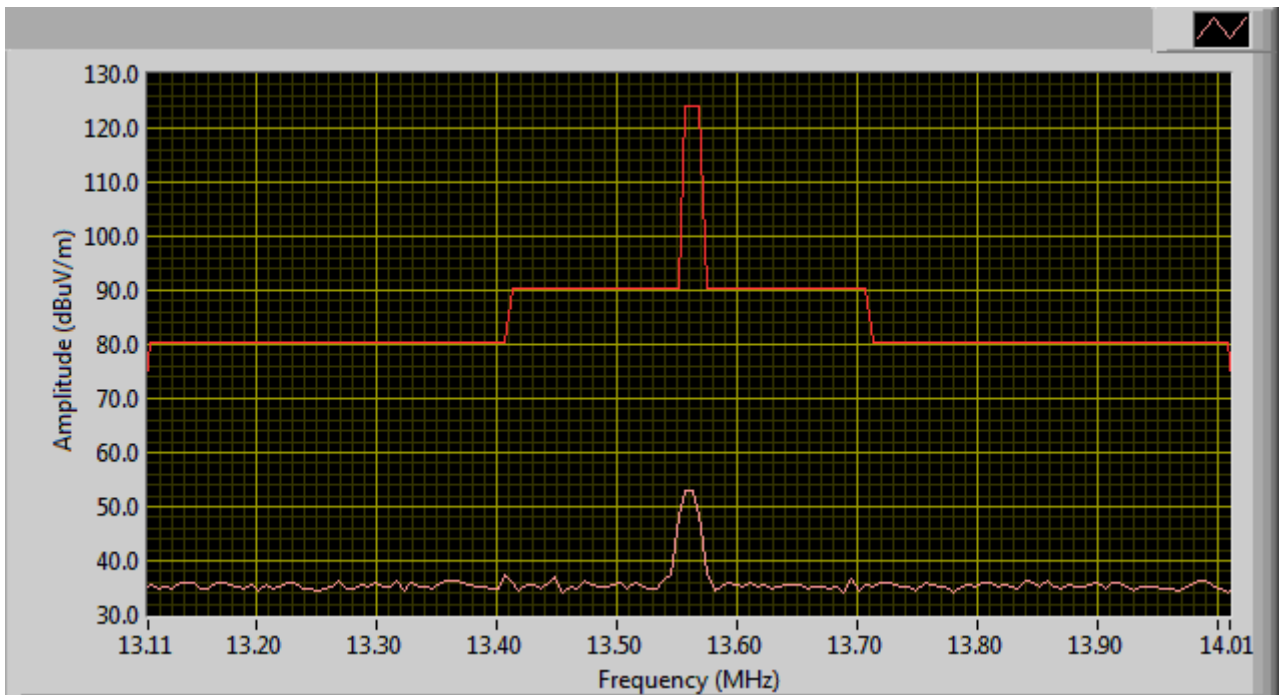

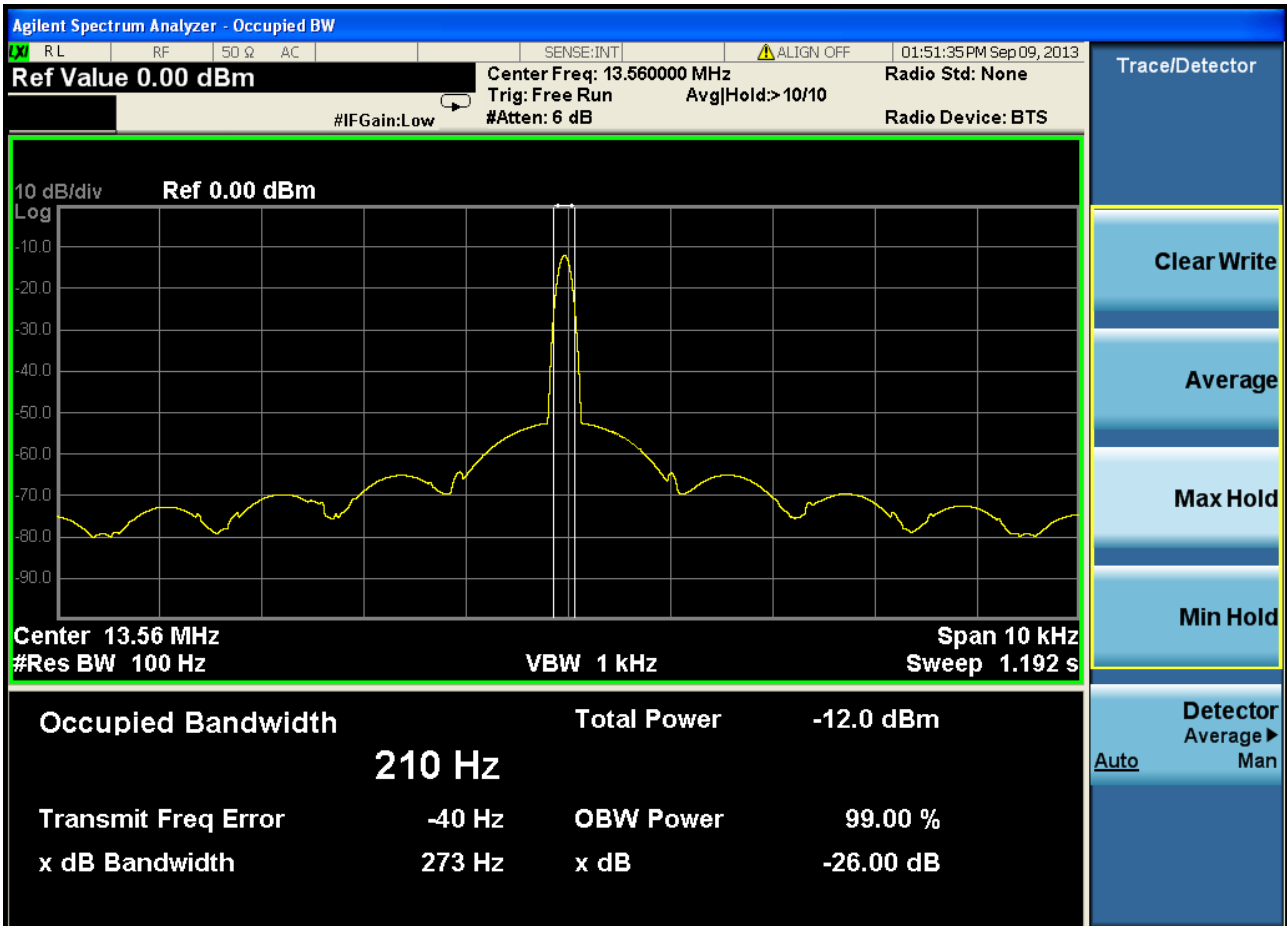
