## 4.1. Antenna requirement

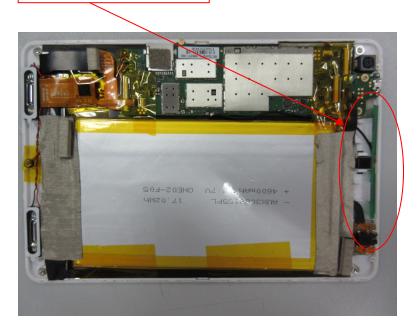

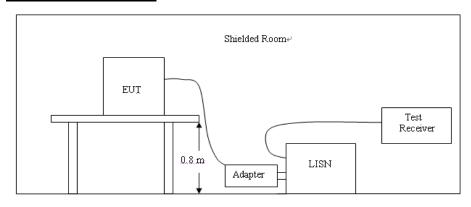

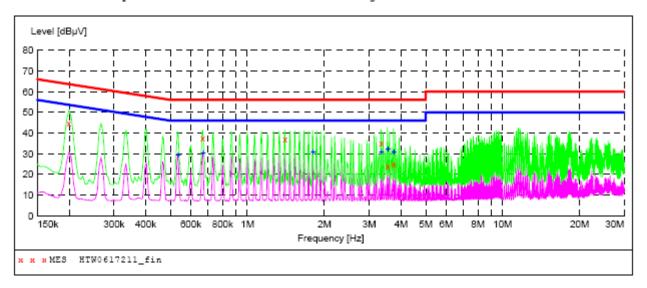
#### **TEST PROCEDURE**

- 1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10-2009.
- 2. Support equipment, if needed, was placed as per ANSI C63.10-2009
- 3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10-2009
- 4. The EUT received DC5V power from the adapter, the adapter received AC120V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5. All support equipments received AC power from a second LISN, if any.
- 6. The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7. Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
- 8. During the above scans, the emissions were maximized by cable manipulation.

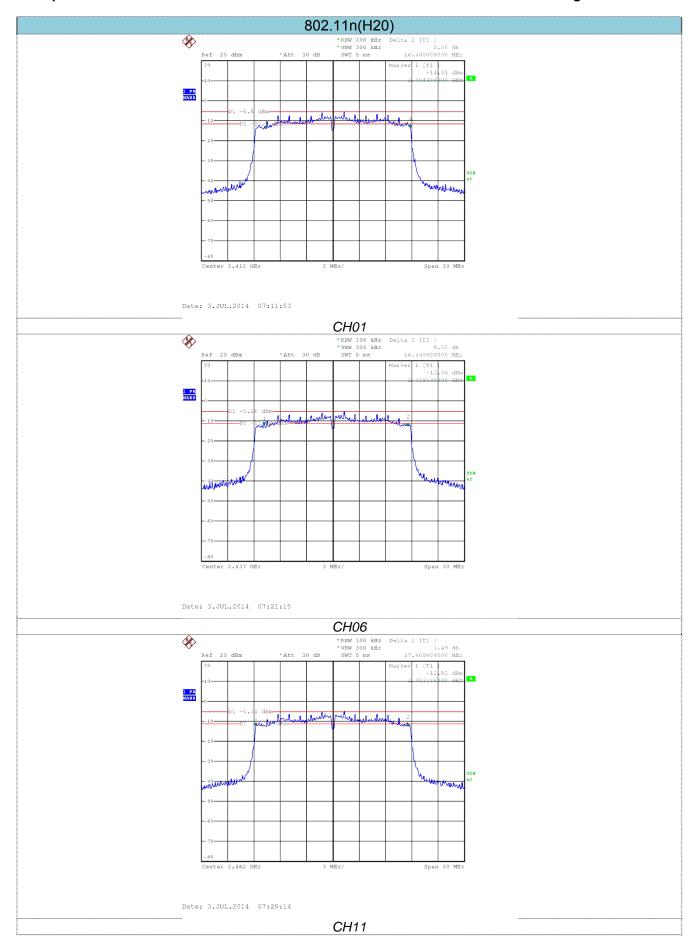
- 1. The transmitter output was connected to the spectrum analyzer through an attenuator. The bandwidth of the fundamental frequency was measured by spectrum analyzer

## 4.6. Band Edge

#### **LIMIT**

FCC CFR Title 47 Part 15 Subpart C Section 15.247 (d):

#### **TEST PROCEDURE**

- According to KDB 558074 D01 V03R02 for Antenna-port conducted measurement. Antenna-port
  conducted measurements may also be used as an alternative to radiated measurements for
  demonstrating compliance in the restricted frequency bands. If conducted measurements are performed,
  then proper impedance matching must be ensured and an additional radiated test for cabinet/case
  spurious emissions is required.
- 2. Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to a EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Low Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.
- 3. Set both RBW and VBW of spectrum analyzer to 100 kHz with a convenient frequency span including 100kHz bandwidth from band edge, for Radiated emissions restricted band RBW=1MHz, VBW=3MHz for peak detector and RBW=1MHz, VBW=10Hz for average detector.
- 4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
- 5. Repeat above procedures until all measured frequencies were complete.
- 6. Measure the conducted output power (in dBm) using the detector specified by the appropriate regulatory agency
- 7. Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level
- 8. Add the appropriate maximum ground reflection factor to the EIRP level (6 dB for frequencies ≤ 30 MHz, 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive and 0 dB for frequencies > 1000 MHz).
- 9. For devices with multiple antenna-ports, measure the power of each individual chain and sum the EIRP of all chains in linear terms (e.g., Watts, mW).
- 10. Convert the resultant EIRP level to an equivalent electric field strength using the following relationship: E = EIRP 20log D + 104.8 where:

 $E = electric field strength in dB\mu V/m$ ,

EIRP = equivalent isotropic radiated power in dBm

D = specified measurement distance in meters.

- 11. Since the out-of-band characteristics of the EUT transmit antenna will often be unknown, the use of a conservative antenna gain value is necessary. Thus, when determining the EIRP based on the measured conducted power, the upper bound on antenna gain for a device with a single RF output shall be selected as the maximum in-band gain of the antenna across all operating bands, or 2 dBi, whichever is greater. However, for devices that operate in multiple frequency bands while using the same transmit antenna, the highest gain of the antenna within the operating band nearest in frequency to the restricted band emission being measured may be used in lieu of the overall highest gain when the emission is at a frequency that is within 20 percent of the nearest band edge frequency, but in no case shall a value less than 2 dBi be used.
- 12. Compare the resultant electric field strength level to the applicable regulatory limit.
- 13. Perform radiated spurious emission test dures until all measured frequencies were complete.

### **TEST PROCEDURE**

1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter camber. The table was rotated 360 degrees to determine the position of the highest radiation.

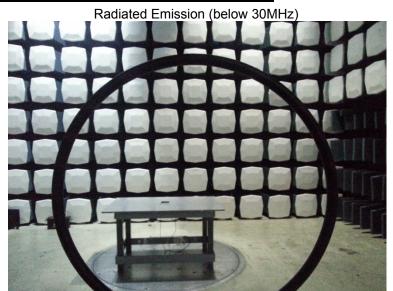

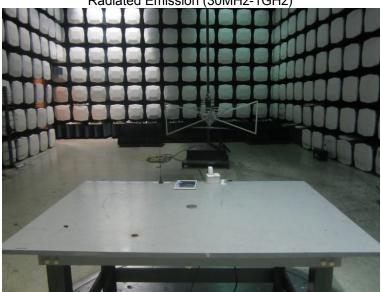

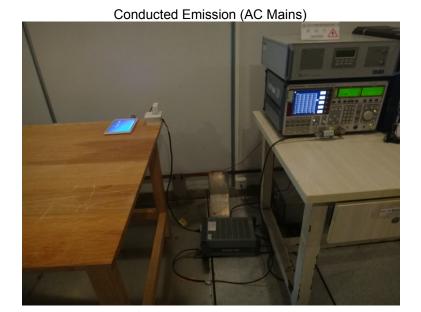
Radiated Emission (30MHz-1GHz)
