Channel 1:2.402GHz:



Channel 1:2.402 GHz:




Channel 20:2.440GHz:







Channel 1: 2.402 GHz




Channel 20: 2.440 GHz







- Test Procedure: (1) The receiver was scanned from 0.009MHz to 25GHz.When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pretest three orthogonal planes. For intentional radiators, measurements of the variation of the input power or the radiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage. 


