



VIFA LIMITED WARRANTY This warranty applies for products (each a "Product") made by Vifa Denmark A/S ("Vifa"), Vifa warrants ("Limited Warranty") that the Product is free of defects in materials and workmanship at the time of its original purchase from an authorized reseller by the end-user (the "Customer" or "you").

#### WHAT IS COVERED BY THIS WARRANTY

All defects in material and workmanship. This Limited Warranty covers the functionality of the Product for its normal, intended use in an environment as specified in the Owner's Manual only and does not cover malfunctions that result from improper or unreasonable use or maintenance, e.g. accident, excess moisture, improper packing, lightning, power surges, or unauthorized tampering, alteration or modification not authorized by Vifa.

This Limited Warranty is limited to the repair or replacement of the Product at Vifa's decision, and neither costs for transportation, removal, nor installation of a Product is covered

### FOR HOW LONG

Unless otherwise explicitly stated in documents provided in connection with the purchase, the guarantee period is 24 months / 2 year.
