Thank you for purchasing the Heart Shaped Wireless Mouse, item WM-ES14-ST. A 2.4GHz USB receiver is included inside of your mouse. Please read this manual carefully FIRST in order to get the most out of your mouse.

INSERTING THE BATTERY

In order to operate your mouse successfully, you will need to insert 1 AA battery (not included). To do so, follow the steps below.

1. Push the battery compartment cover sideways to reveal the battery compartment. The battery compartment cover is located on the bottom of your mouse.
2. Insert 1 AA battery inside the battery compartment, making sure to insert it with the correct polarity (+,-) as shown on the battery compartment.
3. Once your battery is properly inserted, you can put the battery compartment cover back on your mouse.

BATTERY WARNING:

- Do not mix old and new batteries.
 - Do not mix alkaline, stand (carbon-zinc) or rechargeable (nickel-cadmium) batteries.
 - Batteries are not to be inserted with the wrong polarity.
 - Exhausted batteries are to be removed.
 - The supply terminals are not to be short-circuited.
- Please recycle or dispose of the battery properly. Contact local recycling facilities and/or the manufacturer of your battery for further information

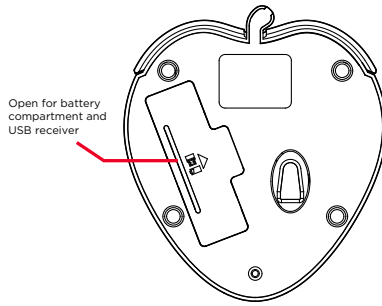
MOUSE SETUP

In order to connect your mouse to your computer, follow the steps below:

1. Remove the USB receiver from the storage slot inside the battery compartment on the bottom of your mouse.
2. Insert the USB receiver into one of your computer's USB ports.
3. Make sure that your computer is powered on.

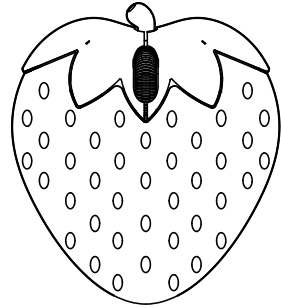
