INSERTING THE BATTERY

In order to operate your mouse successfully, you will need to insert 1 AA battery (not included). To do so, follow the steps below.

- 1. Push the battery compartment cover down to reveal the battery compartment. The battery compartment cover is located on the bottom of your mouse.
- 2. Insert 1 AA battery inside the battery compartment, making sure to insert it with the correct polarity (+,-) as shown on the battery compartment.
- Once your battery is properly inserted, you can put the battery compartment cover back on your mouse.

MOUSE SETUP

In order to connect your mouse to your computer, follow the steps below:

- 1. Remove the USB receiver from the storage slot inside the battery compartment on the bottom of your mouse.
- 2 Insert the USB receiver into one of your computer's
- 3. Make sure that your computer is powered on.

-The mouse will stop working once you pull the receiver out of the USB port or the computer is turned off.
