Thank you for purchasing the Vivitar Wireless Party Speaker, item V60027BT. Bring the party to any event with this Bluetooth speaker, compatible with most mobile devices and tablets. For the best experience, please read this manual carefully before using your speaker.

## Important Safety Precautions

When using your Vivitar Wireless Party Speaker, basic safety precautions should always be followed including:

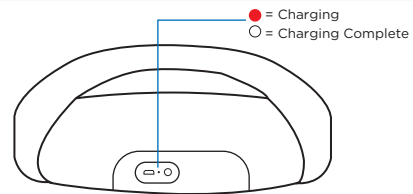
## Charging Your Speaker



1. Insert the included USB charging cable's Micro USB plug into the Micro USB port on the back of the speaker.



2. Insert the USB charging cable's standard USB end into the USB port of a computer or suitable USB charging adapter.



3. The LED Indicator turns red while the speaker is charging and turn off when charging is complete.

### NOTES:

--Remove the charging cable once charging is complete.

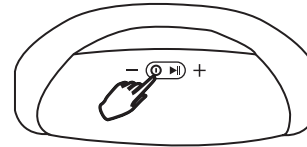
--Overcharging could reduce the life of the battery.

--A charged battery will lose its capacity if it is not used on a regular basis.

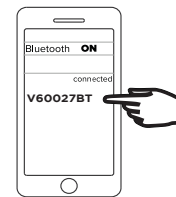
Important: To avoid a complete discharge of the battery, charge your speaker at least once every six months.

## Bluetooth Pairing

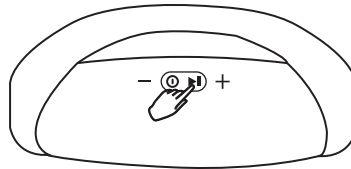
1. Press the Power button to turn the speaker ON. Once ON, the speaker will automatically go into Bluetooth mode.



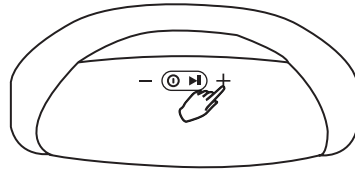
2. Go to the Bluetooth settings page on your phone. Make sure that Bluetooth is turned on. Connect to the available device "V60027BT".



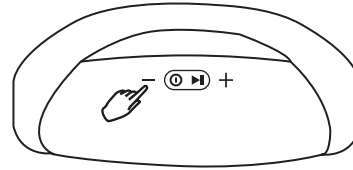
## Speaker Controls



Press the play/pause button to play & pause music and answer & end phone calls. Press and hold the button for two seconds to reject an incoming call.



Press the plus button to go to the next track. Press and hold the button to increase the speaker's volume.



Press the minus button to go to the previous track. Press and hold the button to decrease the speaker's volume.
