Where: S = power density (in appropriate units, e.g. mW/cm²)

- P = power input to the antenna (in appropriate units, e.g., mW).
- G = power gain of the antenna in the direction of interest relative to an isotropic radiator, the power gain factor, is normally numeric gain.
