To DIN EN ISO/IEC 17025. Furthermore, component and process variability of devices similar to that tested may result in additional deviation. ## 1.8 Description of Test Modes

Bluetooth operates in the unlicensed ISM Band at 2.4GHz. With the introduction of the enhanced data rate (EDR) feature, the data rates can be up to 2 Mb/s. An increase in the peak data rate beyond the basic rate of 1 Mb/s is achieved by modulating the RF carrier using GFSK techniques, resulting in an increase of two to three times the number of bits per symbol. The 2 Mb/s EDR packets use a  $\pi/4$ -DQPSK modulation. The following operating modes were applied for the related test items. For radiated measurement, the test was performed with EUT in X, Y, Z position and the worse case was found when EUT in X position. All test modes were tested, only the result of the worst case was recorded in the report.

Worst-case mode and channel used for 150 kHz-30 MHz power line conducted emissions was the mode and channel with the highest output power that was determined to be TX (1Mbps-Hopping Mode).

Worst-case mode and channel used for 9kHz-1000 MHz radiated emissions was determined to be TX-Low Channel (2402MHz, 1Mbps).

\*\*\*Note: Using a temporary antenna connector for the EUT when the conducted measurements are performed.

For pre-testing, when performed with AC power adapter charger, the input Voltage/Frequency AC 120V/60Hz and AC 240V/60Hz were used. Only recorded the worst case in this report.

# 2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10: 2013, FCC CFR PART 15C 15.207, 15.209, 15.247 and DA 00-705.

### 2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 2.2 EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209, 15.247 under the FCC Rules Part 15 Subpart C.

#### 2.3 General Test Procedures

#### 2.3.1 Conducted Emissions

According to the requirements in Section 6.2 of ANSI C63.10: 2013, AC power-line conducted emissions shall be measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turn table and the turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10: 2013





## 5.2 Frequency Separation and 20 dB Bandwidth

#### 5.2.1 Limit

According to §15.247(a)(1), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. 

## 5.5 Conducted Spurious Emissions and Band Edges Test

#### 5.5.1 Limit

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a)is not required. In addition, radiated emissions which fall in the restricted bands, as defined in§15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see§15.205(c)).


# 7. LINE CONDUCTED EMISSIONS

## 7.1 Standard Applicable

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolt (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). ## 7.2 Block Diagram of Test Setup









# 8. ANTENNA REQUIREMENT

## 8.1 Standard Applicable

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

## 8.2 Antenna Connected Construction

### 8.2.1. Standard Applicable

According to § 15.203 & RSS-Gen, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

### 8.2.2. Antenna Connector Construction

The directional gains of antenna used for transmitting is 2dBi, and the antenna is connected to PCB board and no consideration of replacement. Please see EUT photo for details.

### 8.2.3. Results: Compliance.

#### Measurement

The antenna gain of the complete system is calculated by the difference of radiated power in EIRP and the conducted power of the module.

Conducted power refers ANSI C63.10:2013 Output power test procedure for frequency-hopping spread-spectrum (FHSS) devices.
