
# **BLUETOOTH SPEAKER**

### Functions:

- 1. Mic/Speaker
- AUX Port 2. Vol+/Next Track Reset Button
- Play/Pause/Phone 8. Micro USB Port 4. Vol-/Previous Track
- 5. Power Button

- Instructions:
  (Be sure to fully charge the speaker before using for the first time).
- 1. Charging the Speaker
- Connect the provided charging cable to a power source and to the micro USB port on the speaker (8).

  \* The LED indicator light will glow red when
- charging and turn off when fully charged.
- Bluetooth® Setup:
- Long press "Power Button"(5) to turn on and start pairing.
- When pairing, the BLUE light will flash quickly, look for "Wells Outdoor" on your Bluetooth
- device and select it to pair with device. Once pairing is successful the blue light will flash slowly.
- Long press again to turn OFF the device.
- 3. Playing Music:
- Short press (3) "Play/Pause/Phone" key to pause music. A second short press will
- resume playing music again.

   Long press (4) "Previous track/Vol-", the
- speaker will play the previous track.

   Short press to reduce speaker volume.
- · Long press (2) "Next track/Vol+", the speaker
- will play the next track.
- Short press to increase speaker volume.
   AUX Function:
- Find the speakers AUX-IN port, plug in supplied 3.5mm AUX cable into the port and connect to the mobile device
- Call Function:
   Short press "Play/Pause/Phone" (3) to answer a incoming call, press again to end call
- Press and hold to reject the call.
- Press "Power Button" twice to redial last called number from the speaker.
