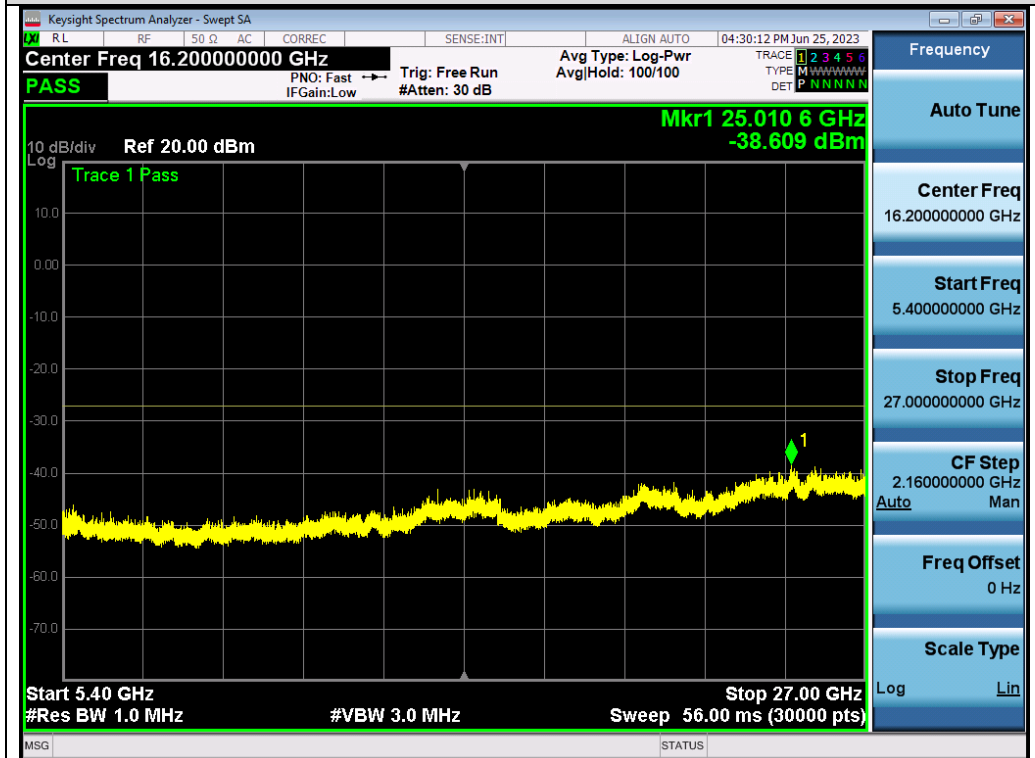
Test Graphs of Spurious Emissions outside of the 5.15-5.35 GHz band for transmitters operating in the 5.25-5.35 GHz band

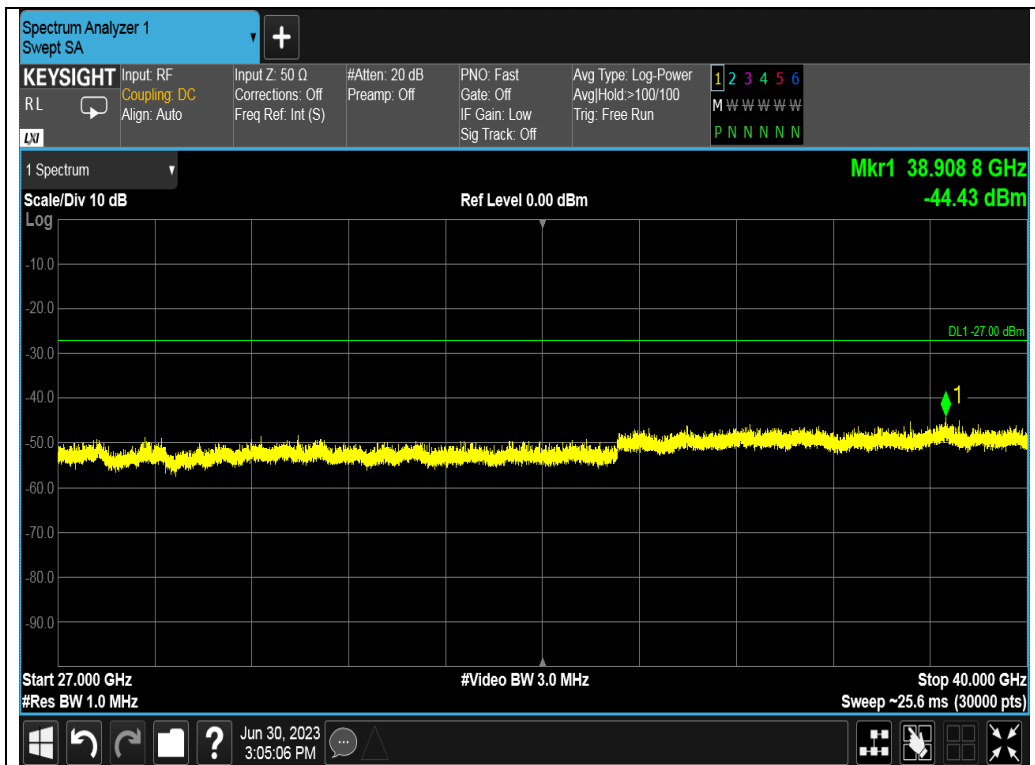


Test_Graph_802.11a_ANT2_5260_6Mbps_Frequency Band 3

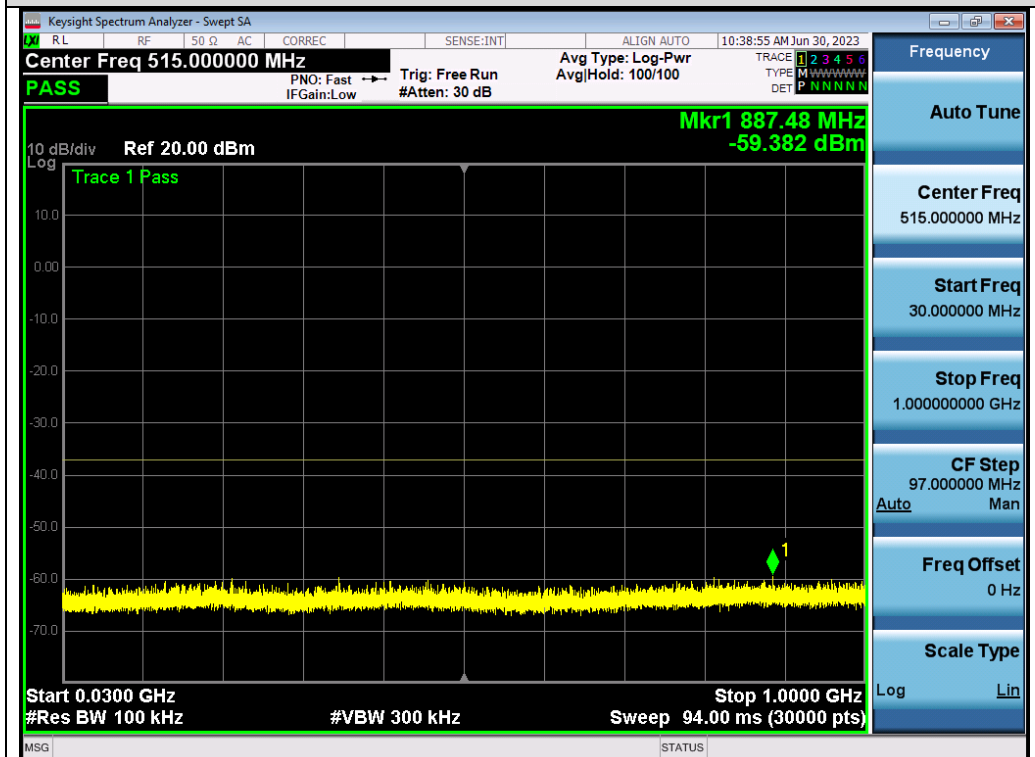

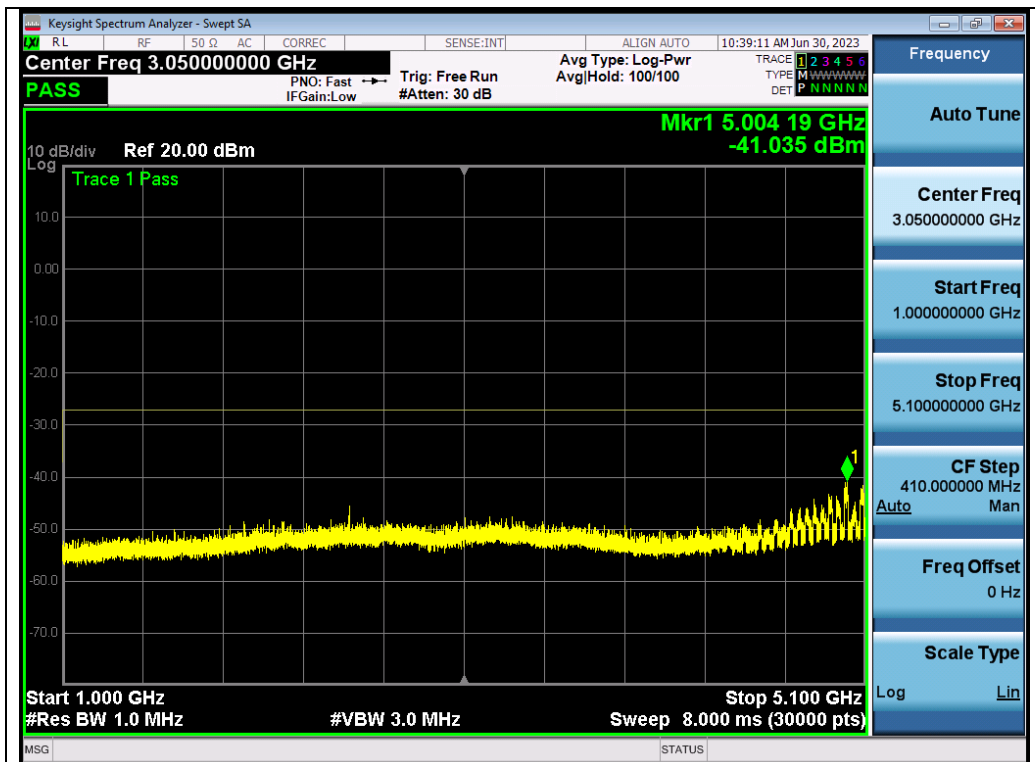


Test_Graph_802.11a_ANT2_5260_6Mbps_Frequency Band 5

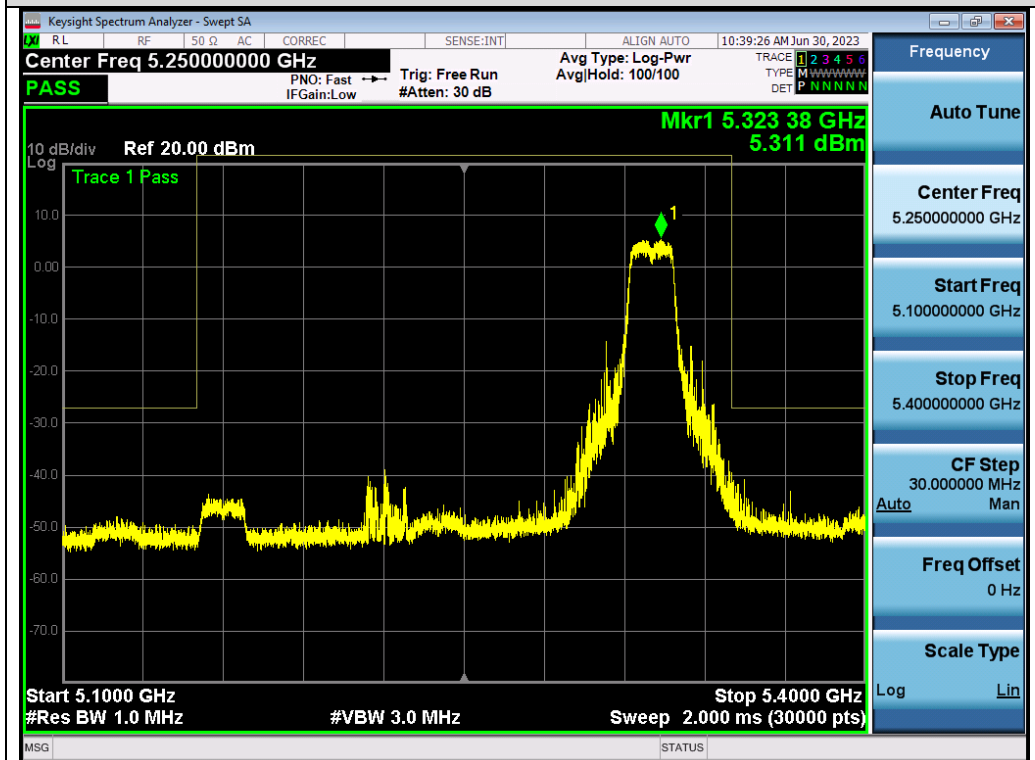

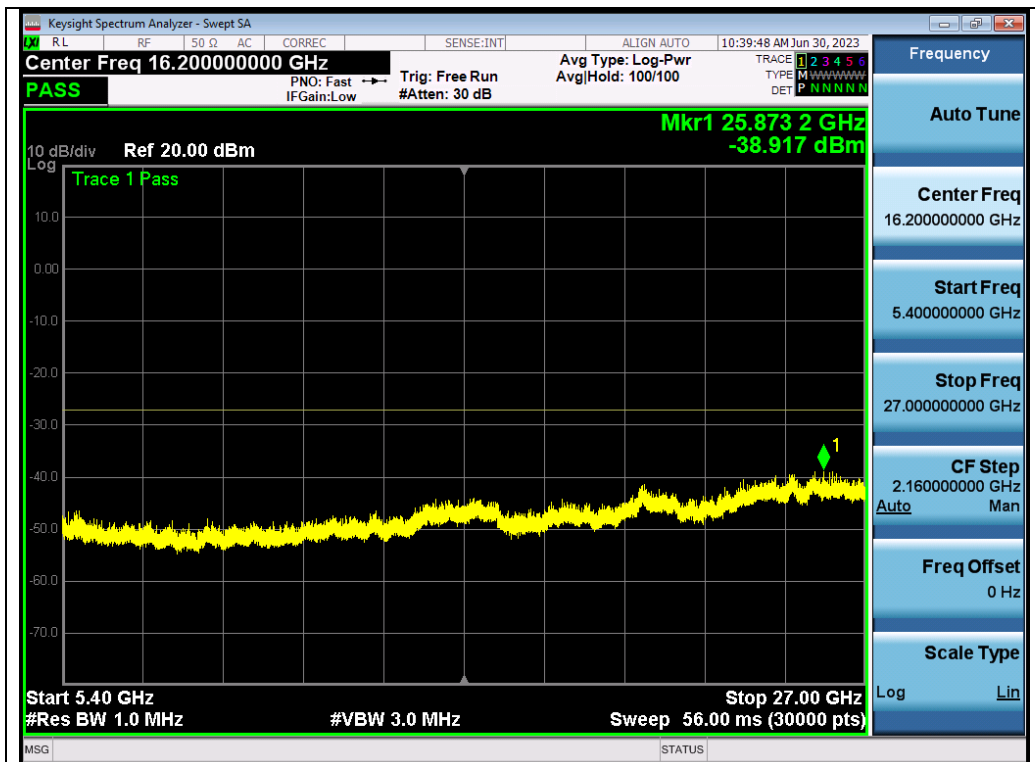


Test_Graph_802.11a_ANT2_5320_6Mbps_Frequency Band 2

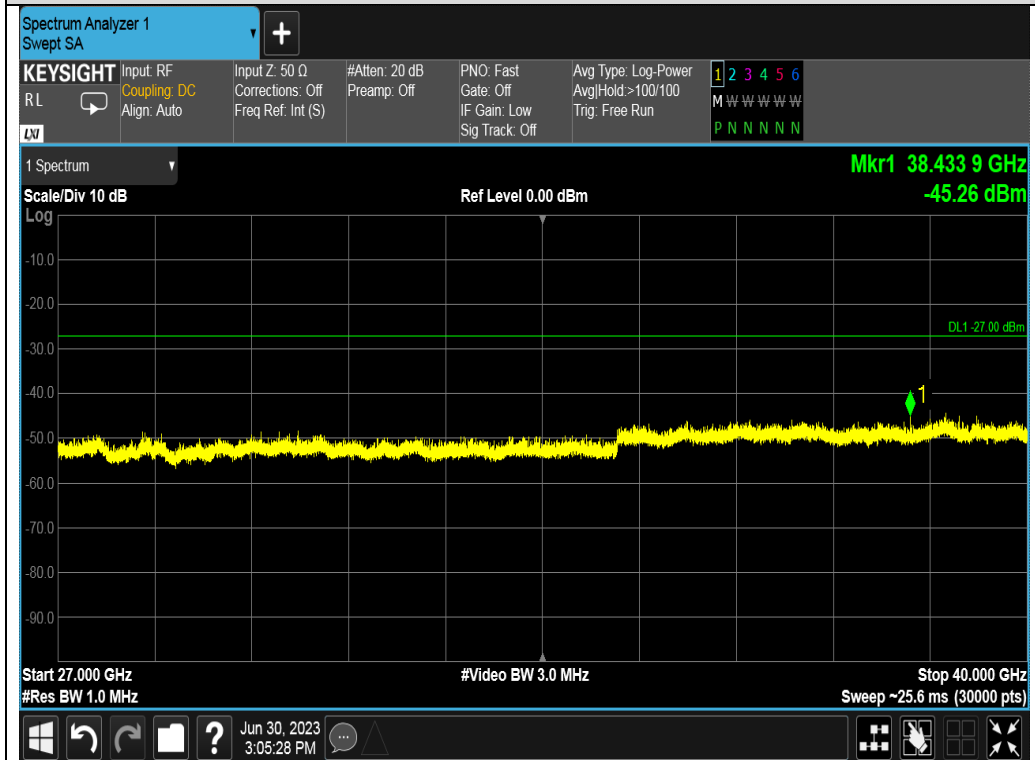

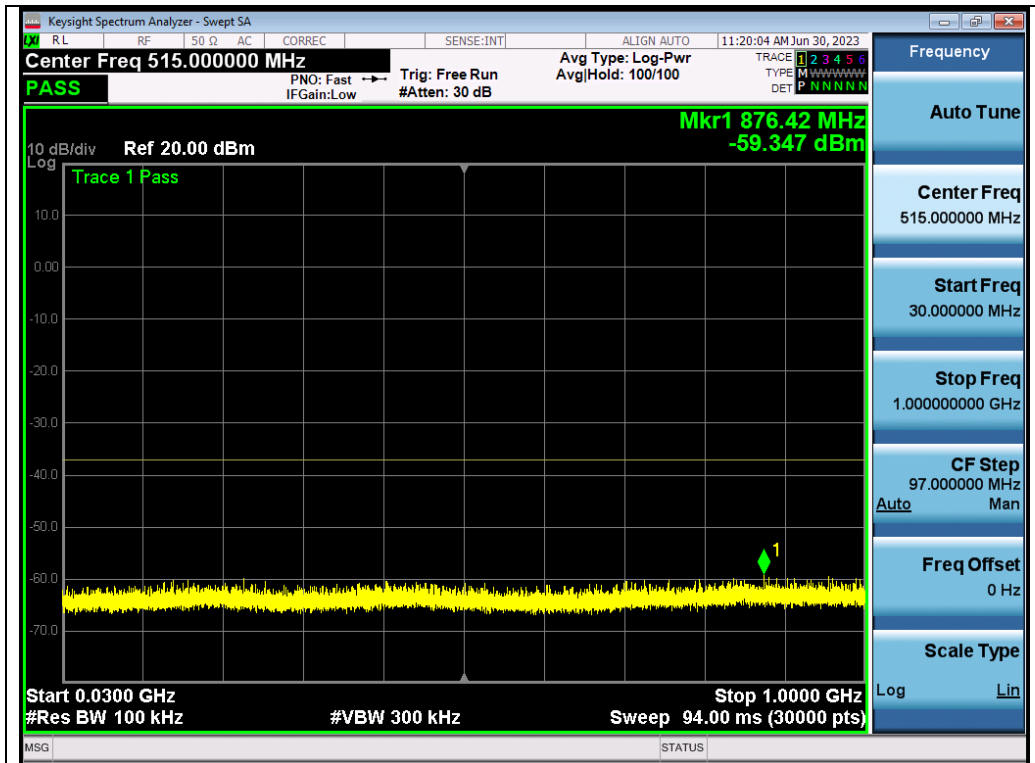


Test_Graph_802.11a_ANT2_5320_6Mbps_Frequency Band 4

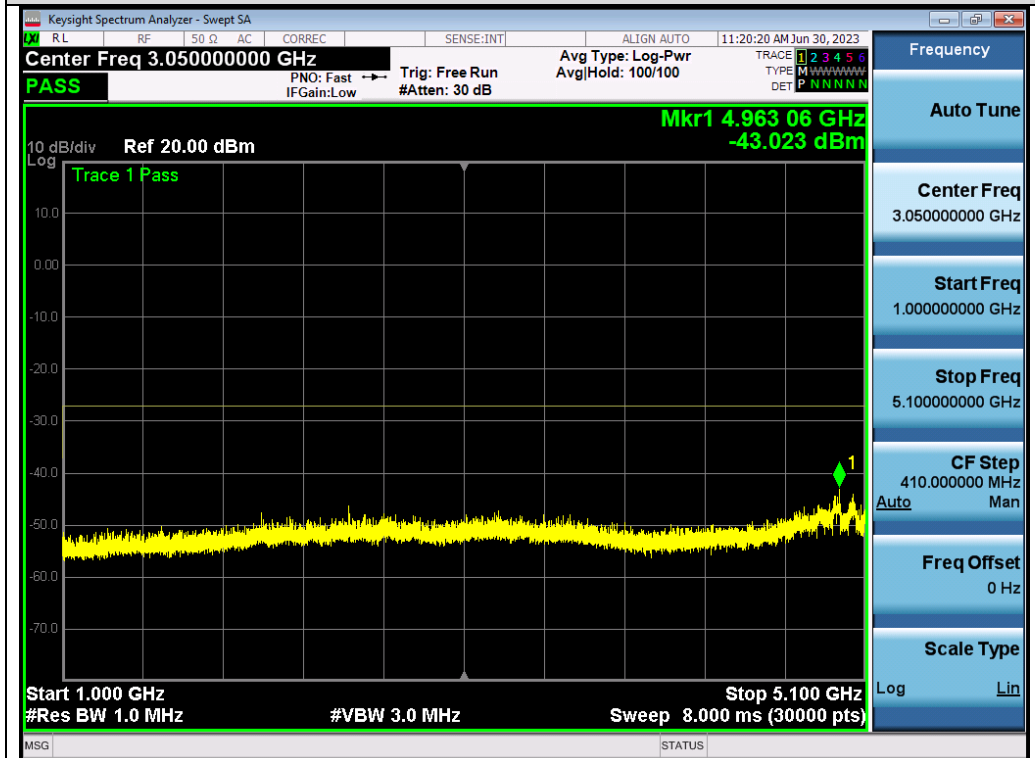

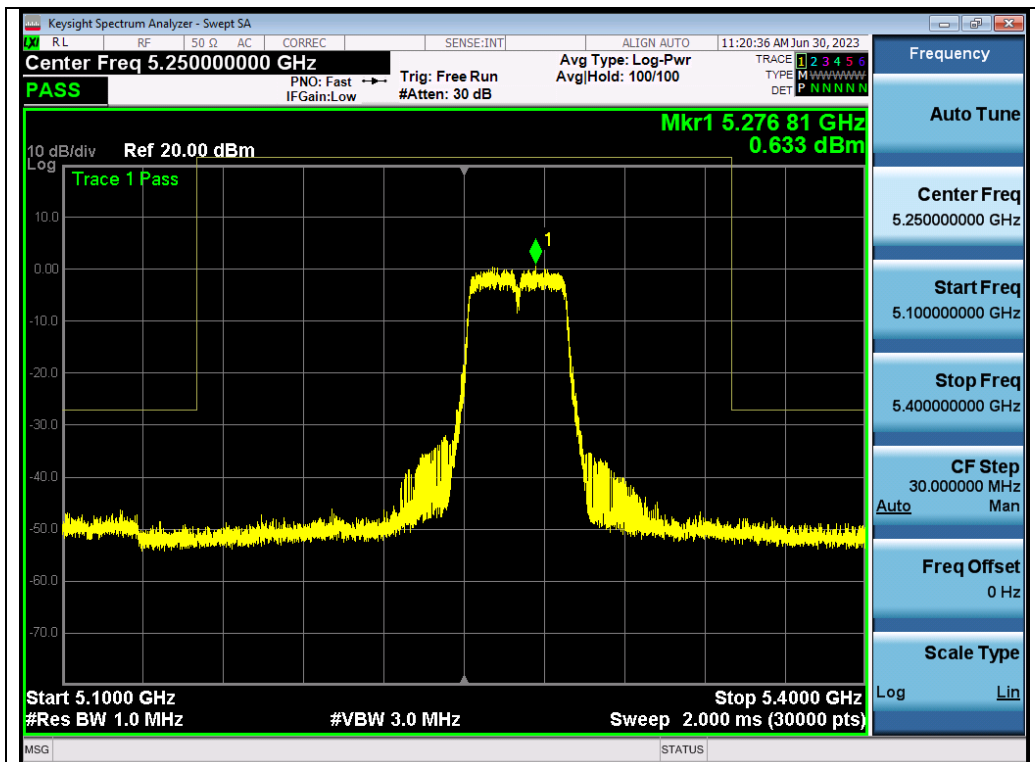

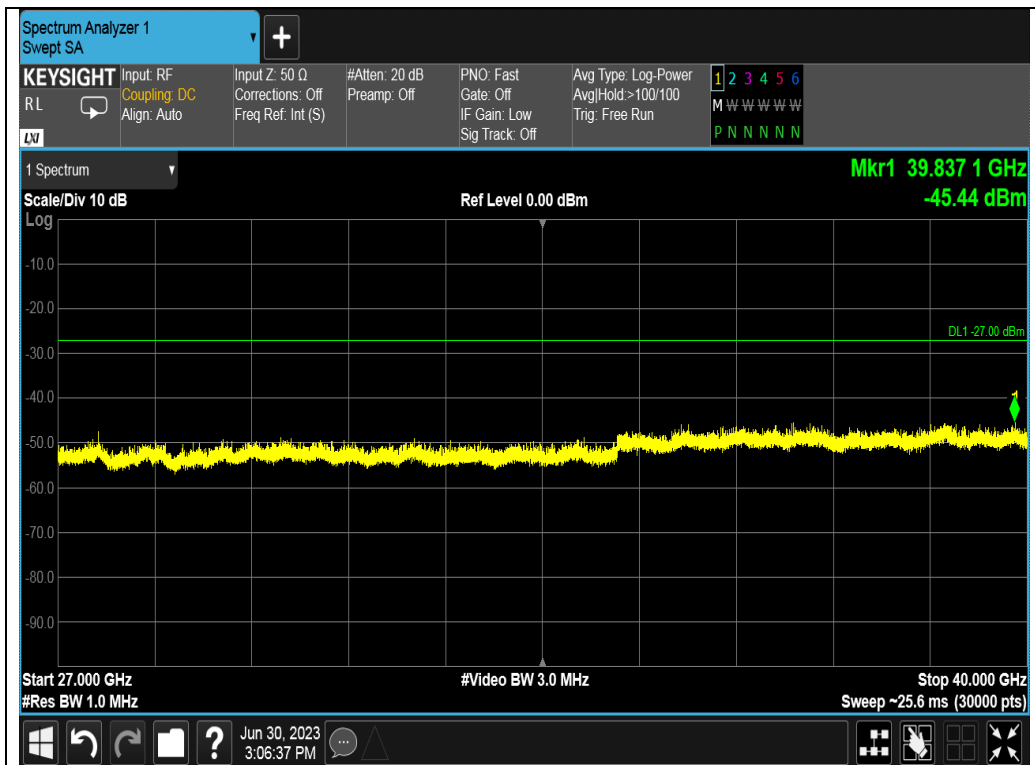


Test_Graph_802.11n40_ANT2_5270_MCS0_Frequency Band 3

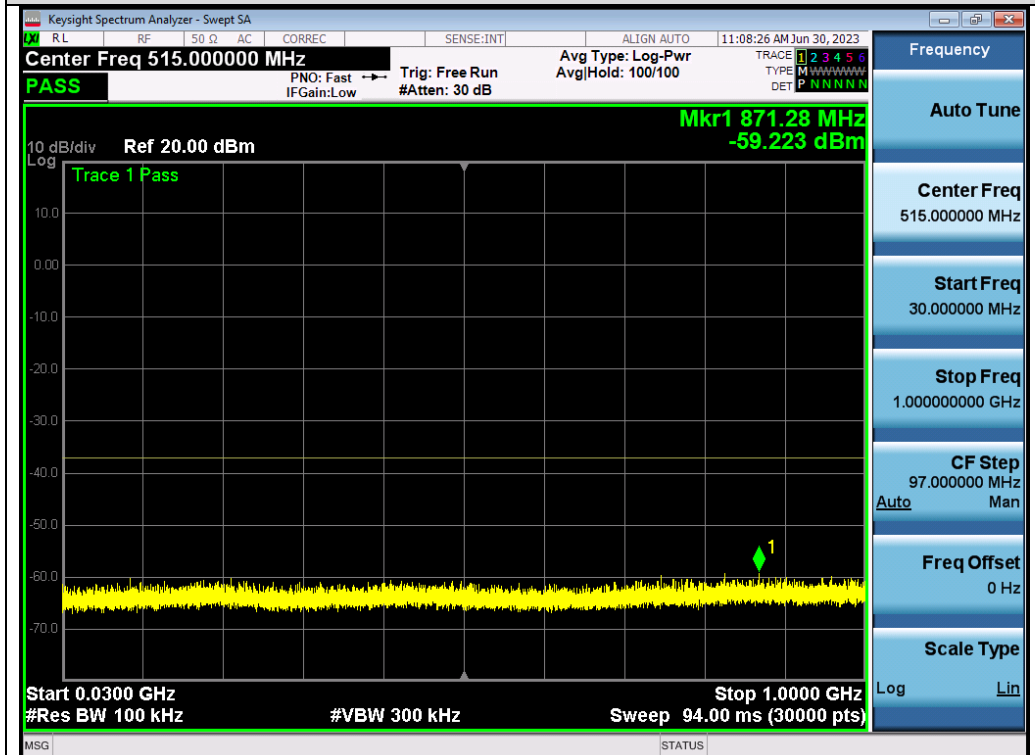

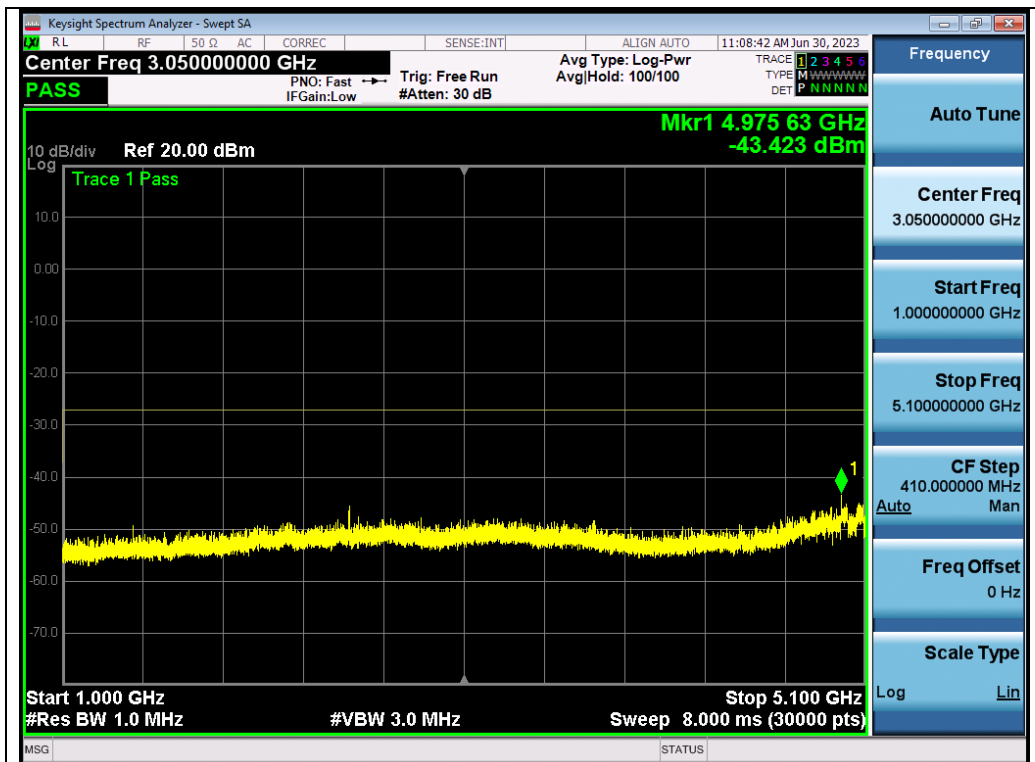


Test_Graph_802.11n40_ANT2_5270_MCS0_Frequency Band 5

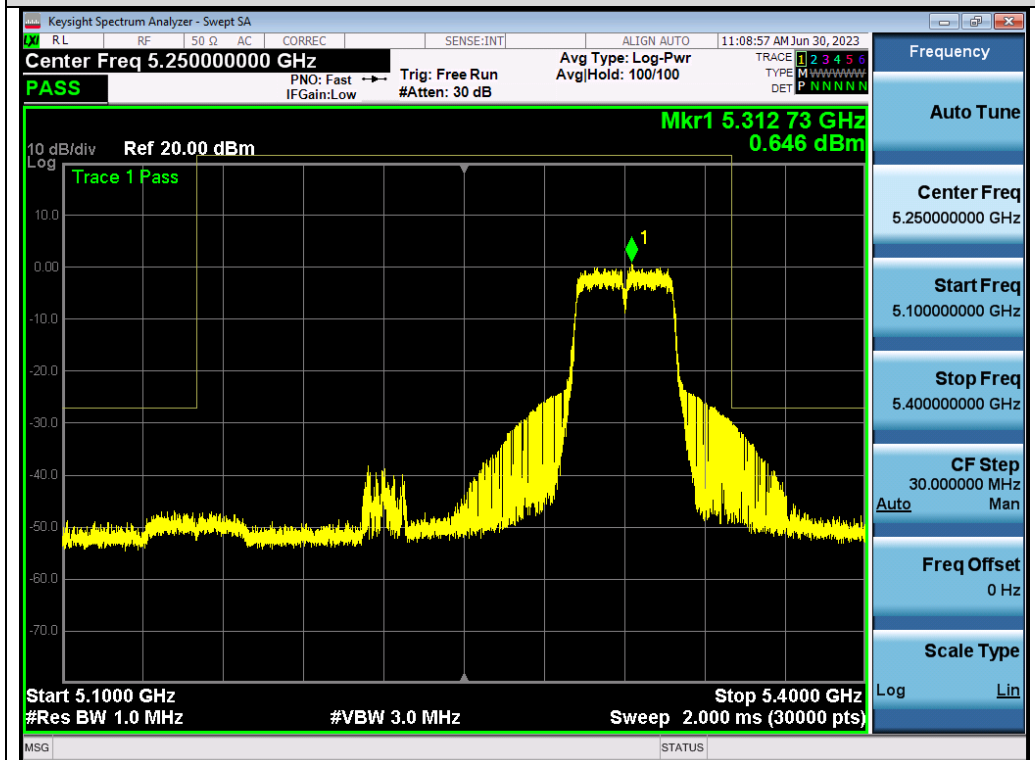
