And also in the exhibition Users manual, there are instructions give to the OEM on how to label the end product.</p>

The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. A copy of these instructions must be included in the application for equipment authorization.</p>	<p>Y</p> <p>The EUT is compliant with all applicable FCC rules. Details instructions for maintaining compliance are give in the User Manual.</p>

For example, FCC Rules in sections 2.1091, 2.1093 and specific Sections of Part 15, including 15.319(i), 15.407(f), 15.253(f) and 15.255(g), require that Unlicensed PCS, UNII and millimeter wave devices perform routine environmental evaluation for RF Exposure to demonstrate compliance.
