The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

2.1.2. Result: Compliant

2.2. Peak Output Power

2.2.1. Requirement

According to FCC section 15.247(b)(3), For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: The maximum peak conducted output power of the intentional radiator shall not exceed 1 Watt.

2.2.2. Test Description

The measured output power was calculated by the reading of the spectrum analyzer and calibration.

The EUT (Equipment under the test) which is powered by the Battery is coupled to the Spectrum analyzer; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading, all test result in Spectrum analyzer.






(Plot A: Channel 0: 2402MHz)


2.4. 6dB & 99%Bandwidth

2.4.1. Requirement

According to FCC section 15.247(a) (2), Systems using digital modulation techniques may operate in the 902 - 928 MHz, 2400 - 2483.5 MHz, and 5725 - 5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

2.4.2. Test Description

A. Test Set:



The EUT which is powered by the Battery, is coupled to the Spectrum Analyzer; the RF load attached to the EUT antenna terminal is 500hm; the path loss as the factor is calibrated to correct the reading.

Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. In order to make an accurate measurement, set the span greater than RBW.





(Plot C: Channel 39: 2480MHz)




2.5. Conducted Spurious Emissions and Band Edge

2.5.1. Requirement

According to FCC section 15.247(d), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

2.5.2. Test Description

A. Test Set:



The EUT which is powered by the Battery, is coupled to the Spectrum Analyzer; the RF load attached to the EUT antenna terminal is 500hm; the path loss as the factor is calibrated to correct the reading.

Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 100 kHz. In order to make an accurate measurement, set the span greater than RBW.








(Plot A.1: Channel = 0, 30MHz to 25GHz)




(Band Edge@ Channel = 0)






(Plot B.1: Channel = 19, 30MHz to 25GHz)

(Band Edge@ Channel = 39)




2.6. Power spectral density (PSD)

2.6.1. Requirement

According to FCC section 15.247(e), the same method of determining the conducted output power shall be used to determine the power spectral density. If a peak output power is measured, then a peak power spectral density measurement is required. If an average output power is measured, then an average power spectral density measurement should be used.


2.7. Restricted Frequency Bands

2.7.1. Requirement

According to FCC section 15.247(d), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, In addition, radiated emissions which fall in the restricted bands, as defined in 15.205(a), must also comply with the radiated emission limits specified in 15.209(a).

2.7.2. Test Description

A. Test Setup



The Module is located in a 3m Semi-Anechoic Chamber; the antenna factors, cable loss and so on of the site as factors are calculated to correct the reading.

For the Test Antenna:

Test Antenna is 3m away from the EUT. Test Antenna height is varied from 1m to 4m above the ground to determine the maximum value of the field strength.








(Plot A1: Channel = 0 PEAK)




(Plot A2: Channel = 0 AVG)

2.8. Conducted Emission

2.8.1. Requirement

According to FCC section 15.207, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency within the band 150kHz to 30MHz shall not exceed the limits in the following table, as measured using a $50\mu H/50\Omega$ line impedance stabilization network (LISN).



2.9. Radiated Emission

2.9.1. Requirement

According to FCC section 15.247(d), radiated emission outside the frequency band attenuation below the general limits specified in FCC section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in FCC section 15.205(a), must also comply with the radiated emission limits specified in FCC section 15.209(a).

According to FCC section 15.209 (a), except as provided elsewhere in this subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:







The test site semi-anechoic chamber has met the requirement of NSA tolerance 4dB according to the standards: ANSI C63.4 (2009). The EUT was set-up on insulator 80cm above the Ground Plane. The set-up and test methods were according to ANSI C63.4.

The Module is located in a 3m Semi-Anechoic Chamber; the antenna factors, cable loss and so on of the site as factors are calculated to correct the reading. During the measurement, the EUT is activated and controlled by the Wireless Router via a Common Antenna, and is set to operate under hopping-on test mode.

For the Test Antenna:

- (a) In the frequency range of 9kHz to 30MHz, magnetic field is measured with Loop Test Antenna. The Test Antenna is positioned with its plane vertical at 1m distance from the EUT. The center of the Loop Test Antenna is 1m above the ground. During the measurement the Loop Test Antenna rotates about its vertical axis for maximum response at each azimuth about the EUT.
- (b) In the frequency range above 30MHz, Bi-Log Test Antenna (30MHz to 2GHz) and Horn Test Antenna (above 2GHz) are used. Test Antenna is 3m away from the EUT. Test Antenna height is varied from 1m to 4m above the ground to determine the maximum value of the field strength. The emission levels at both horizontal and vertical polarizations should be tested.

2.9.3. Test Result

According to ANSI C63.4 selection 4.2.2, because of peak detection will yield amplitudes equal to or greater than amplitudes measured with the quasi-peak (or average) detector, the measurement data from a spectrum analyzer peak detector will represent the worst-case results, if the peak measured value complies with the quasi-peak limit, it is unnecessary to perform an quasi-peak measurement.







(Plot A.2: Antenna Horizontal, 30MHz to 25GHz)




(Plot A.3: Antenna Vertical, 30MHz to 25GHz)


(Plot B.1: 9kHz to 30MHz)


(Plot B.2: Antenna Horizontal, 30MHz to 25GHz)




(Plot B.3: Antenna Vertical, 30MHz to 25GHz)








(Plot C.1: 9kHz to 30MHz)

Routine SAR evaluation refers to the specifically required by § 2.1093, using measurements or computer simulation. When routine SAR evolution is not required, the portable transmitters with output power greater than the applicable low threshold SAR evolution to qualify for TCB approval.

Result:

This is portable device and the Max conducted peak output power is 1.395dBm, the maximum gain of antenna is 2.5dBi, the maximum output power is 3.895dBm (2.452mW). which is lower than the exclusion threshold 10mW, at frequency 2450MHz, and distance is 5mm.

The maximum TUNE UP power is 5dBm(3.162mW), also lower than the exclusion threshold.

The SAR measurement is not required.
