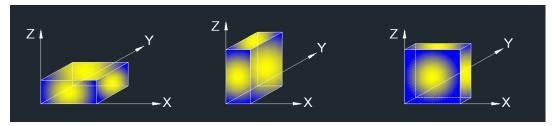

Duty Cycle Correction Factor=10log (1/x).


Where: x is Duty Cycle (Linear)
