


# **Patio Mate Quickstart Guide**

#### Features

## Front Panel



- Power/Charging LED: The LED will be solid green when powered on, flash red when the battery is low, and solid red when charging. If the unit is powered on while charging, the LED will turn green when battery charging is completed. If the unit is powered off while charging, the LED will turn off when charging is completed.
- Pairing LED: This LED will blink blue when pairing. The LED is solid blue when pairing is established.
- Power: Hold this button for 2 seconds to power the unit on or off. If the unit is on, with LEDs turned off and no audio playing, the unit will power off after 5 minutes.
- 4. Bluetooth: Press and release this button to disconnect a currently paired Bluetooth device and start pairing to another device. Patio Mate will pair to the nearest previously connected Bluetooth device when powered on.
- Light Control: Press this button to adjust the brightness settings for the lights: LED high, LED low, and off.
- 6. -: Press this button to adjust the volume down.
- 7. +: Press this button to adjust the volume up.
- Charge/Aux: Open this rubber door to access these 2 input ports. The micro-USB port charges the unit and the 1/8" (3.5 mm) Aux input connects to linelevel devices such as media players, tablets, or CD players.

Note: Bluetooth sources and the Aux input cannot be used at the same time.

## **Top Panel**



- Clamp: Attach this to an umbrella pole between 1.0"-1.6" (25-41 mm) in diameter.
- 2. Lights: Provides different levels of brightness set by the Light Control button.
- 3. Speakers: Outputs the audio from a paired Bluetooth device.
- Open Latch: Press this to open the latch and fit the clamp on an umbrella pole. To close, press the latch while inserting it into the locking mechanism.
- Strap Mounts: Pass the included strap through these mounts and secure Patio Mate to a cantilever style umbrella.

#### Operation

## **Quick Setup**

Press the Open button on Patio Mate and fit the base to a pole style umbrella. The clamp fits 1.0"–1.6" (25–41 mm) diameter umbrella poles. Use the included strap with a cantilever style umbrella. Pass the strap through the mounts and fold the flap over the hook and loop strips to hang from a cantilever umbrella.

#### Pairing a Bluetooth Device

- 1. Turn on your Bluetooth device.
- Power on Patio Mate and it will automatically go into pairing mode to search for Bluetooth devices.

**Note:** Voice notifications will be heard when operating Patio Mate (e.g., "Power On", "Bluetooth Pairing", "Bluetooth Connected"). If you wish to disable these, hold the **Light Control** button for 4 seconds. To enable voice notifications again, hold the **Light Control** button for 4 seconds.

- Navigate to your Bluetooth device's setup screen, find Patio Mate and connect.
   Note: If your Bluetooth device prompts for a pairing code, enter 0000.
- 4. Press and release the Bluetooth button to disconnect a paired Bluetooth device.
- 5. Repeat step 3 to pair to another Bluetooth device.

# **Safety & Warranty Information**

## **Product Warranty**

(for products purchased in the U.S.A.)

## 1. What is covered and for how long?

All Products: ION Audio, LLC ("ION Audio") warrants to the original purchaser that ION Audio products and all other accessories are free from defects in material and workmanship under normal use and service for the period commencing upon the date of purchase from an authorized ION Audio dealer and continuing for the following period of time after that date for ninety (90) days. ION Audio warrants factory-refurbished merchandise to be free of material and operational defects for a period of ninety (90) days from the original date of retail sale. This refurbished merchandise warranty is not transferable

- 2. What is not covered? This Limited Warranty is conditioned upon proper use of the product by the purchaser. This Limited Warranty does not cover: (a) damage caused by improper installation or improper connection to any peripheral; (b) damage caused by an external electrical fault; (c) damage from use of parts not manufactured or sold by ION Audio; (d) product purchased from anyone other than an ION Audio authorized dealer; (e) modifications to product not approved in writing by ION Audio; (f) equipment that has the serial number removed or made illegible; (g) normal cosmetic and mechanical wear; (h) damage or loss during transit to an Authorized ION Audio Repair Center; or (i) units that are purchased and/or located outside
- 3. What are ION Audio's obligations? During the applicable warranty period, ION Audio will repair or replace, at ION Audio's sole option, without charge to the purchaser, any defective component part of the product. To obtain service under this Limited Warranty, purchaser must first contact ION Audio and obtain a return merchant authorization ("RMA") number. Purchaser must then return the product to ION Audio in an adequate container for shipping, accompanied by purchaser's sales receipt or comparable proof of sale showing the date of purchase, the serial number of the product, and the seller's name and address. To obtain an RMA number and assistance on where to return the product, contact ION Audio customer service at 401-658-3743. Upon receipt, ION Audio will repair or replace the defective products. ION Audio may, at ION Audio's sole option, use rebuilt, reconditioned, or new parts or components when repairing any product or replace a product with a rebuilt, reconditioned, new or comparable product. Repaired products will be warranted for a period equal to the remainder of the original Limited Warranty on the original product or for 90 days, whichever is longer. All replaced parts, components, boards, and equipment become the property of ION Audio. If ION Audio determines that any product is not covered by this Limited Warranty, purchaser must pay all parts, shipping, and labor charges for the repair or return of such product.

## Return Information

- A return merchant authorization number must be obtained from your local ION Audio representative. For your representative go to **ionaudio.com**.

  A copy of the original sales receipt must also be included for the equipment to be repaired under warranty.
- The faulty equipment must be packed in its original packaging.
- One additional outer layer of packaging must be included to ensure product safety. Failure to do so may inadequately protect the equipment in transit and therefore jeopardize the warranty.
- ION Audio will not accept COD shipments and no call tags will be issued for merchandise return.
- ION Audio will not return repaired merchandise to customers by priority service except by written request at the customer's cost. Requests must be submitted in writing with returned merchandise.
- The defective ION Audio equipment should be sent freight prepaid with the return merchant authorization number printed clearly on the outer packaging and original sales receipt enclosed to your local service

## Important Safety Instructions
