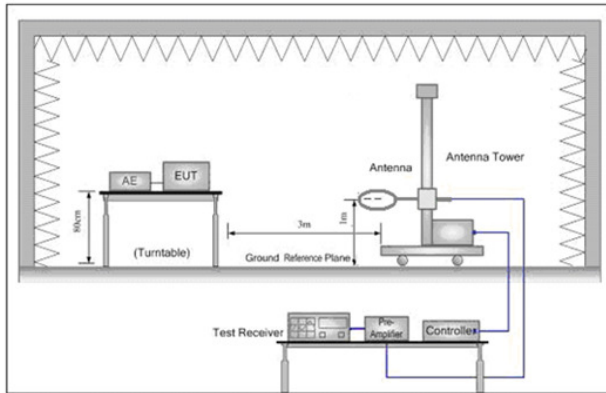


Figure 1. Below 30MHz

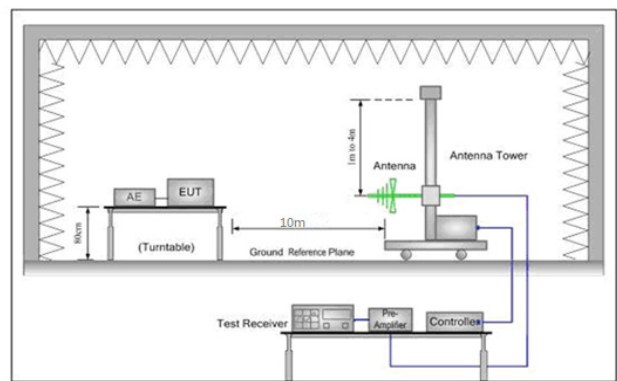


Figure 2. 30MHz to 1GHz

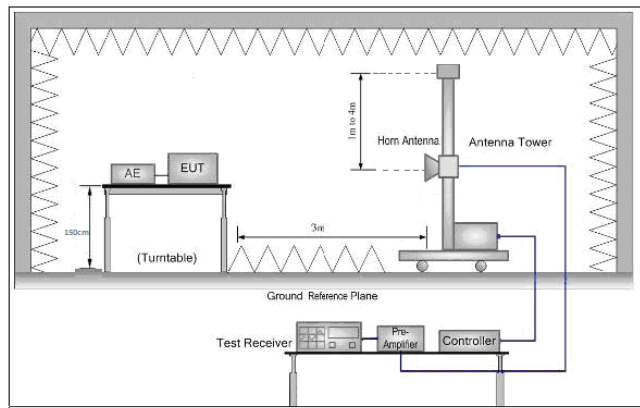


Figure 3. Above 1 GHz

**Test Procedure:**

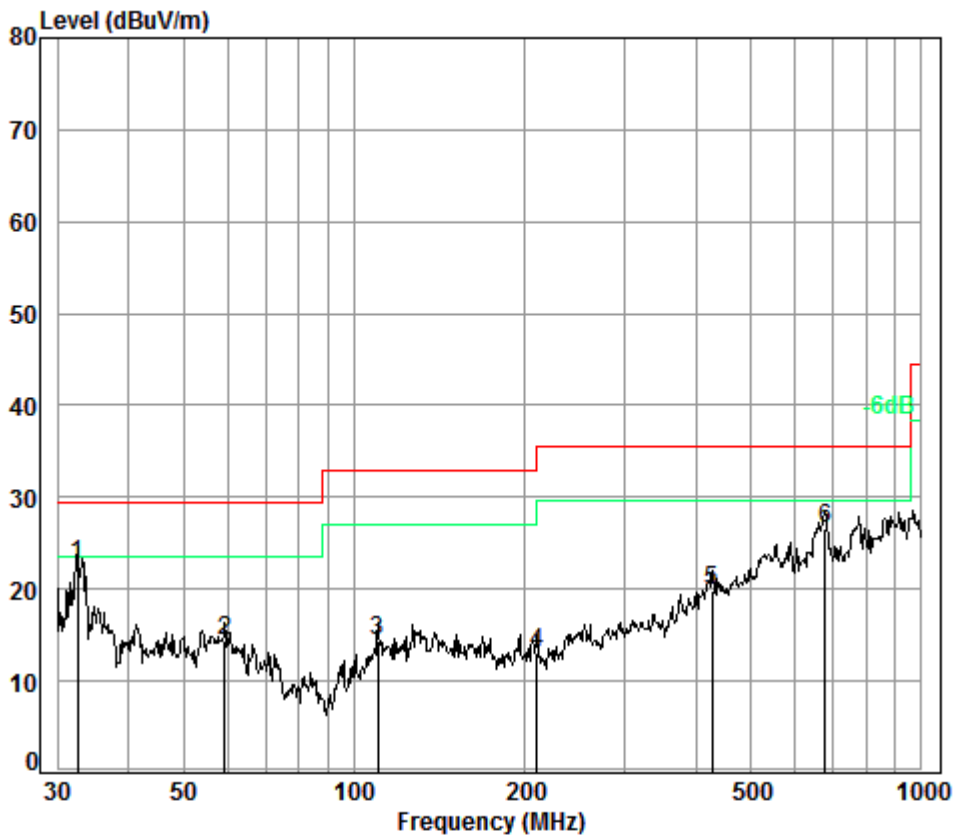

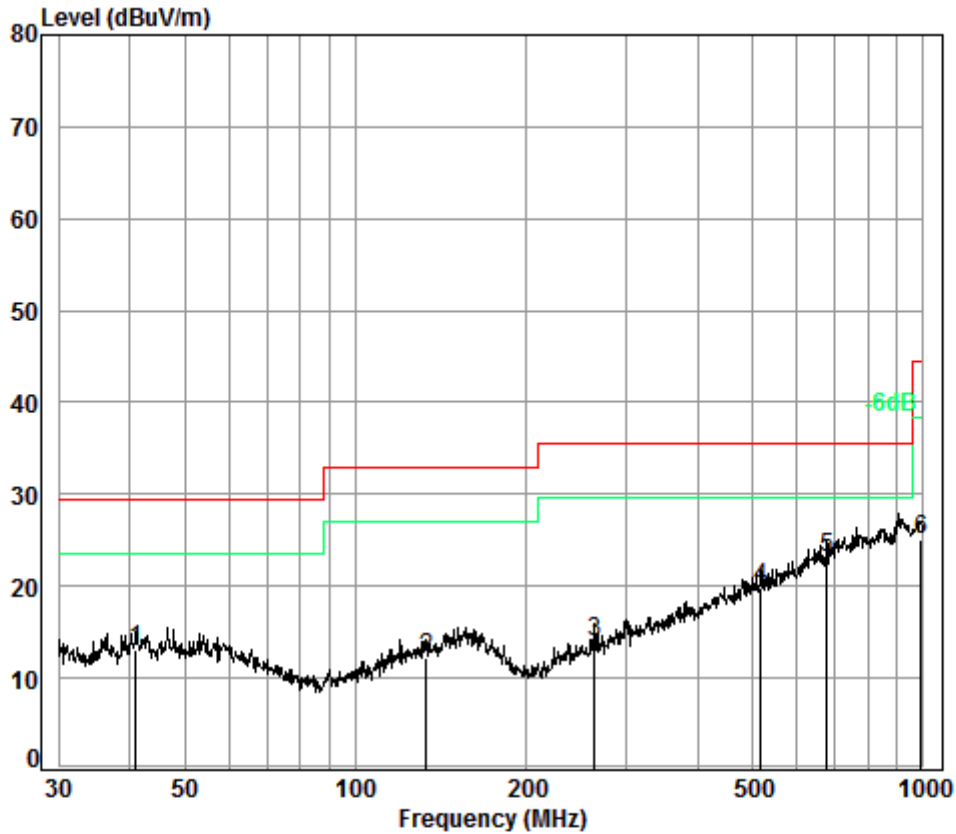

The amplitude of spurious emissions from the radiator which are attenuated more than 20dB below the limit need not be reported.
- 3) As shown in this section, for frequencies above 1GHz, the field strength limits are based on average limits.

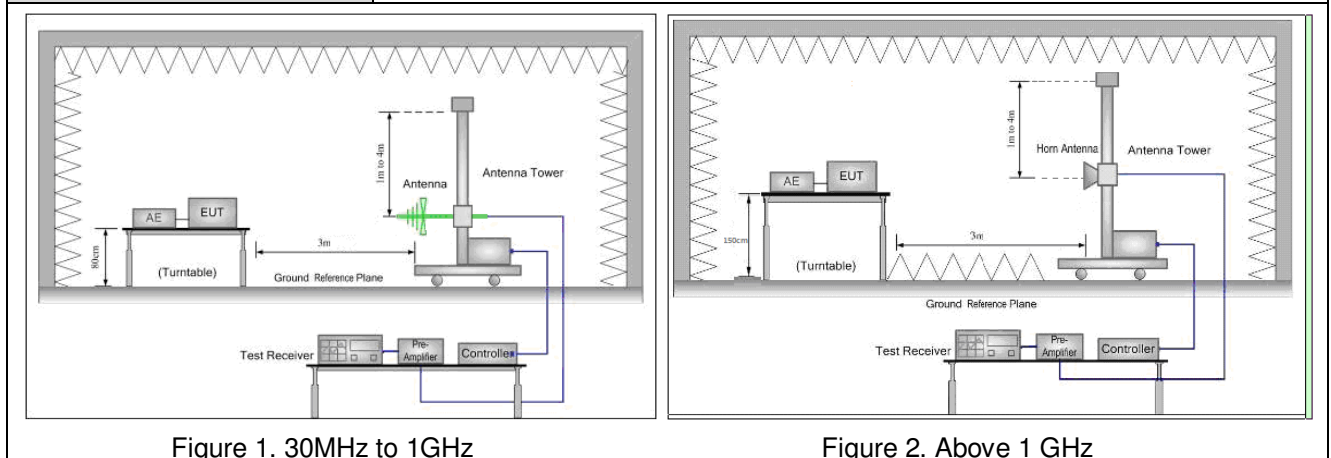


Figure 1. 30MHz to 1GHz

Figure 2. Above 1 GHz

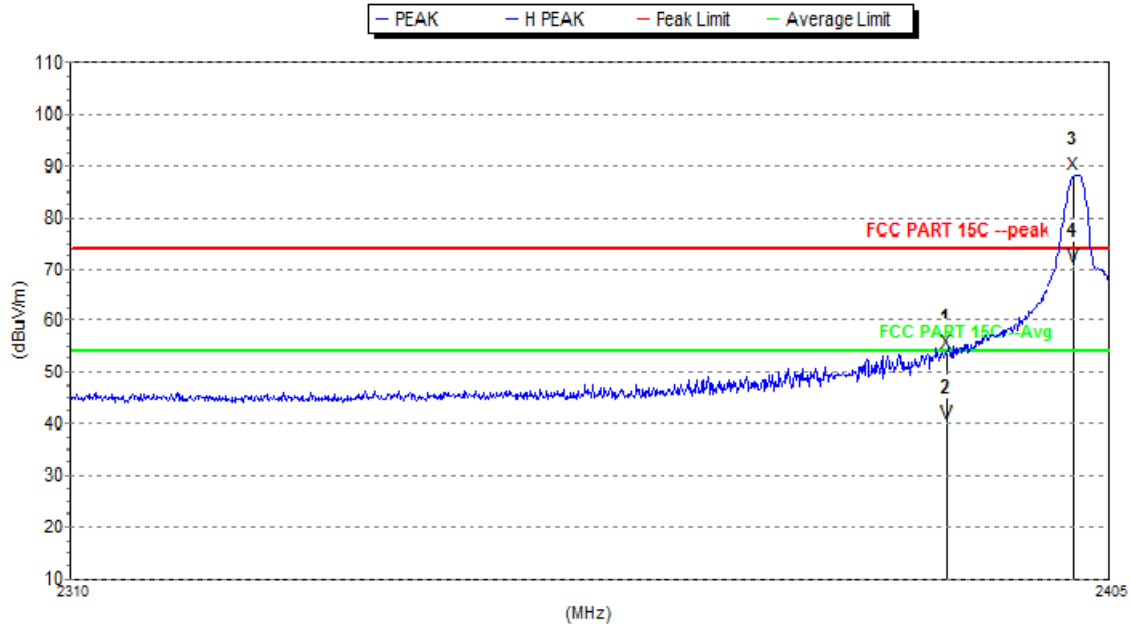
