Test Polarization: Vertical

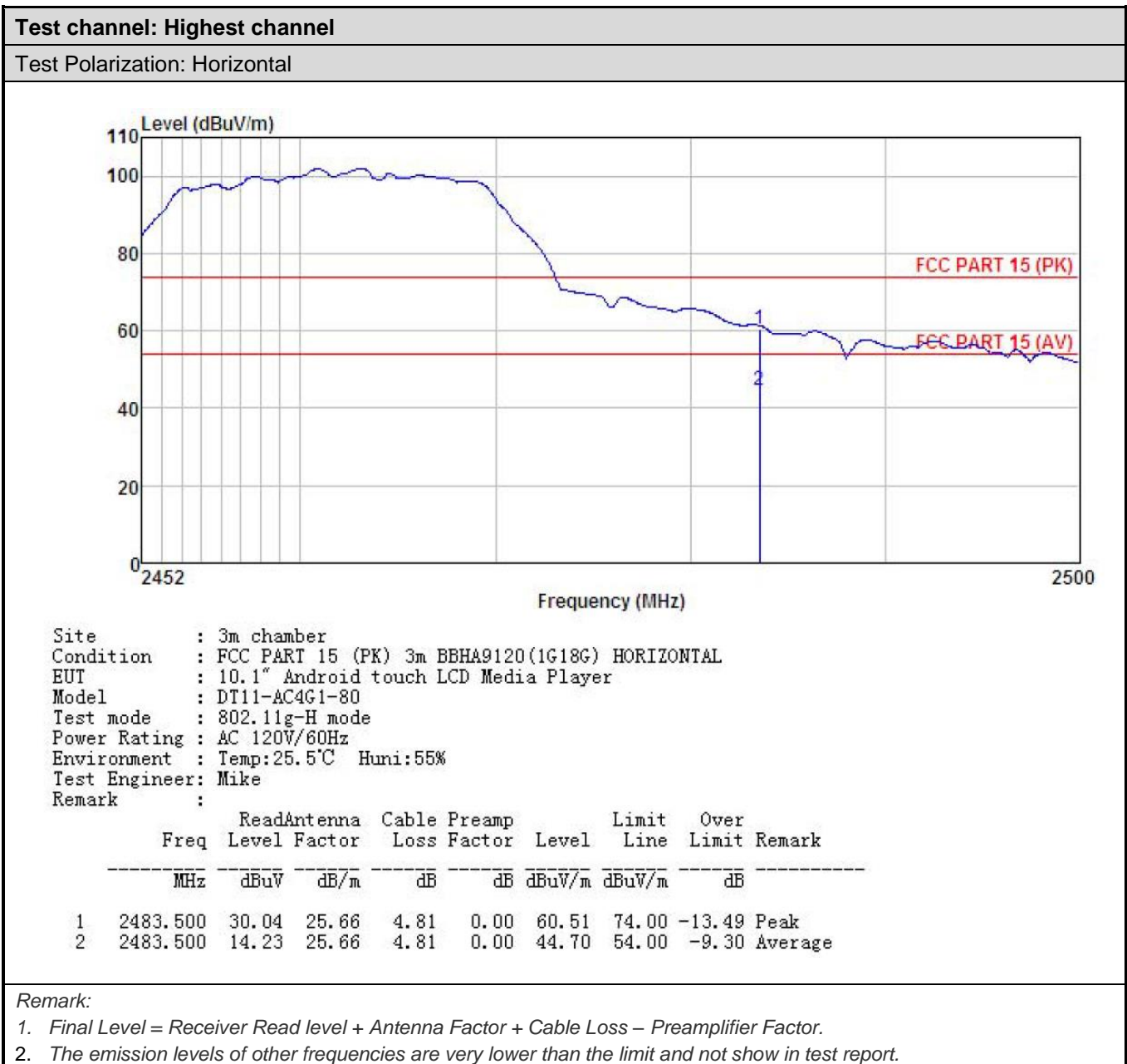

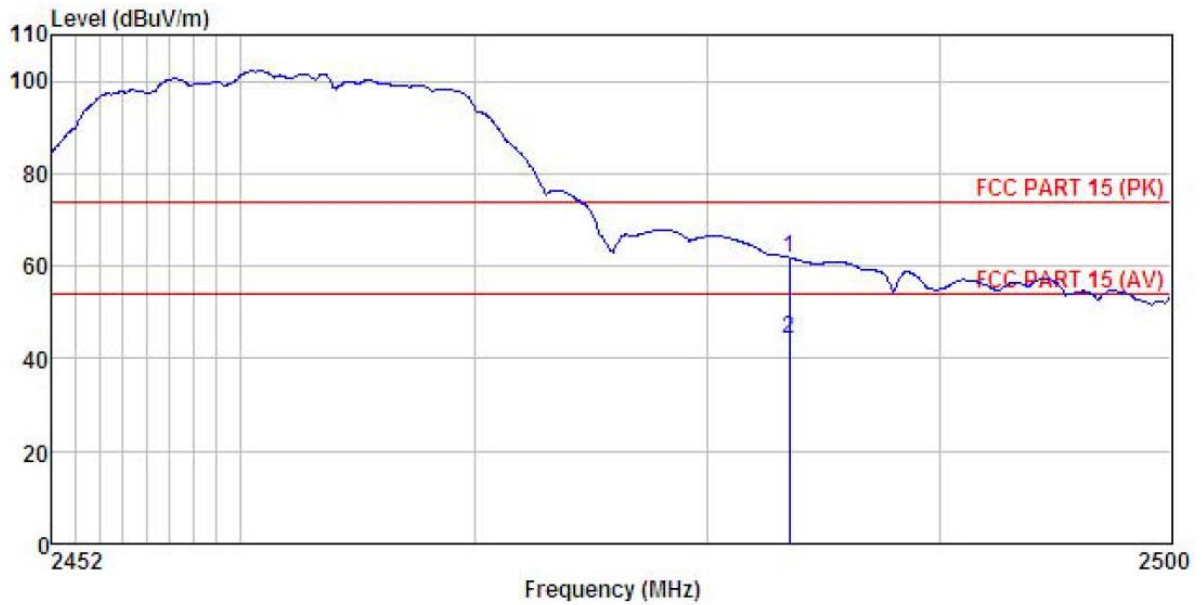

Test Polarization: Vertical

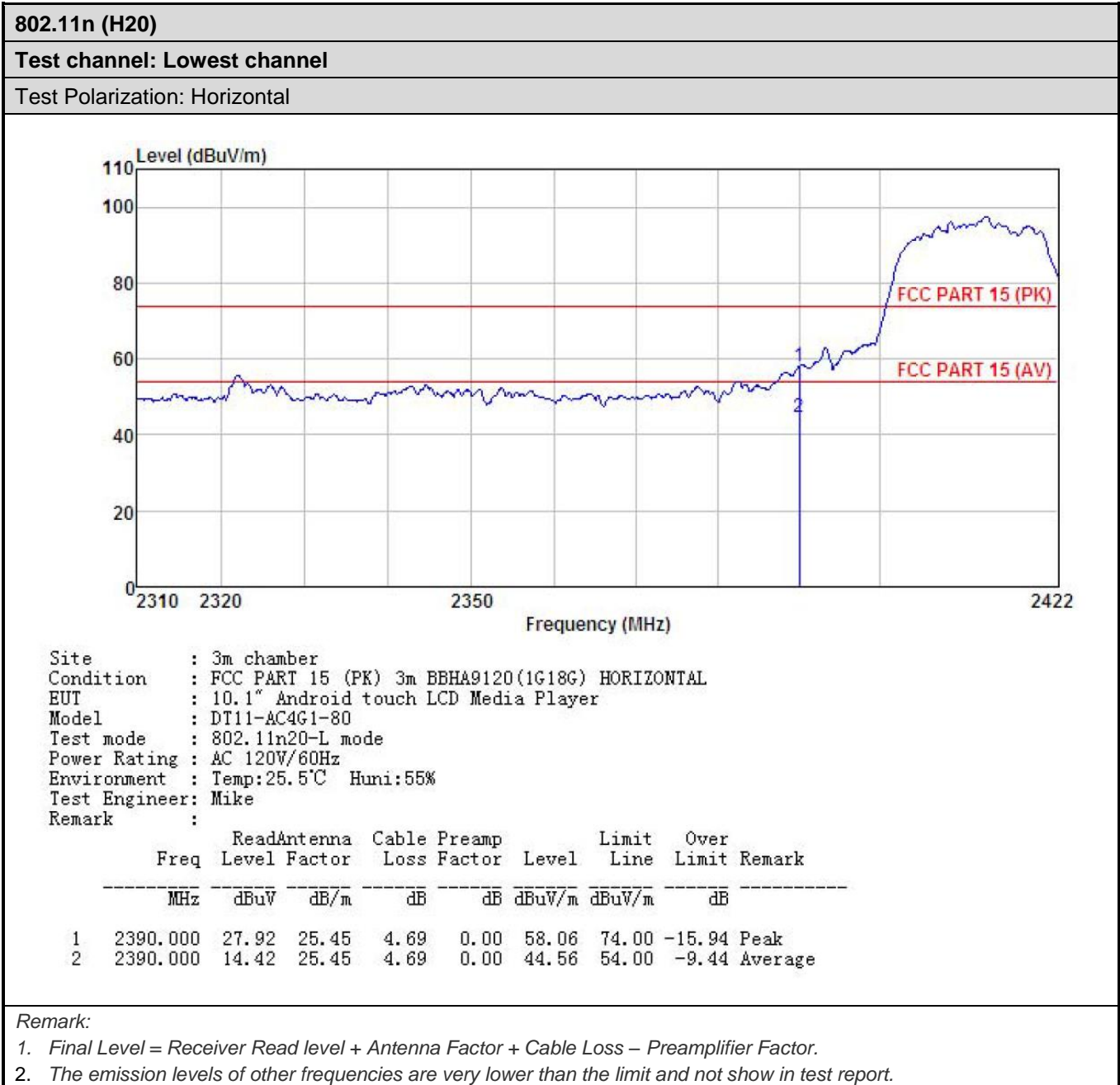
