2. Device Category and RF Exposure Limit

Per user manual, this device is a Wall Control for HRV unit P/N: 99-MX01. Based on 47CFR 2.1093, this device belongs to portable device category with General Population/Uncontrolled exposure.

Portable Devices:

47CFR 2.1093(b)

For purposes of this section, a portable device is defined as a transmitting device designed to be used so that the radiating structure(s) of the device is/are within 20 centimeters of the body of the user.

GENERAL POPULATION / UNCONTROLLED EXPOSURE

4. RF Exposure Evaluation

Standalone transmission SAR evaluation:

- According to KDB 447498 section 4.3.1, the 1-g SAR test exclusion thresholds at test separation Distances≤ 50 mm are determined by: [(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)]·[√f(GHz)] ≤ 3.0.
 - f(GHz) is the RF channel transmit frequency in GHz
 - · Power and distance are rounded to the nearest mW and mm before calculation
 - · The result is rounded to one decimal place for comparison
- 2. The maximum source-based time-averaged including tune-up limit is 0mW @ 2.48GHz. When the BT MODULE CW51P is used on hand/head, 5mm as the most conservative minimum test separation distance was used for evaluating,
