## Safety & Operational Guidelines

# MICA Bracelet One (1) Year Limited Warranty

#### 1. LIMITED WARRANTY

This one year limited warranty ("Limited Warranty") is provided for the MICA bracelet hardware (the "Device") by Intel Corporation ("Intel," "we" or "us") to the original Device purchaser or recipient ("you"). Subject to the terms of this Limited Warranty, Intel warrants the Device to be free from manufacturing and material defects under ordinary consumer use for one year from the date of original purchase from place of purchase. If you submit a valid claim under this Limited Warranty, Intel will, at Intel's sole discretion and within a reasonable period of time, refund, repair or replace any Device that fails solely as a result of any manufacturing or material defect. Any such repair or replacement will be made at no charge to you for parts and labor. Any replacement Device may be new or refurbished, at Intel's sole discretion.
