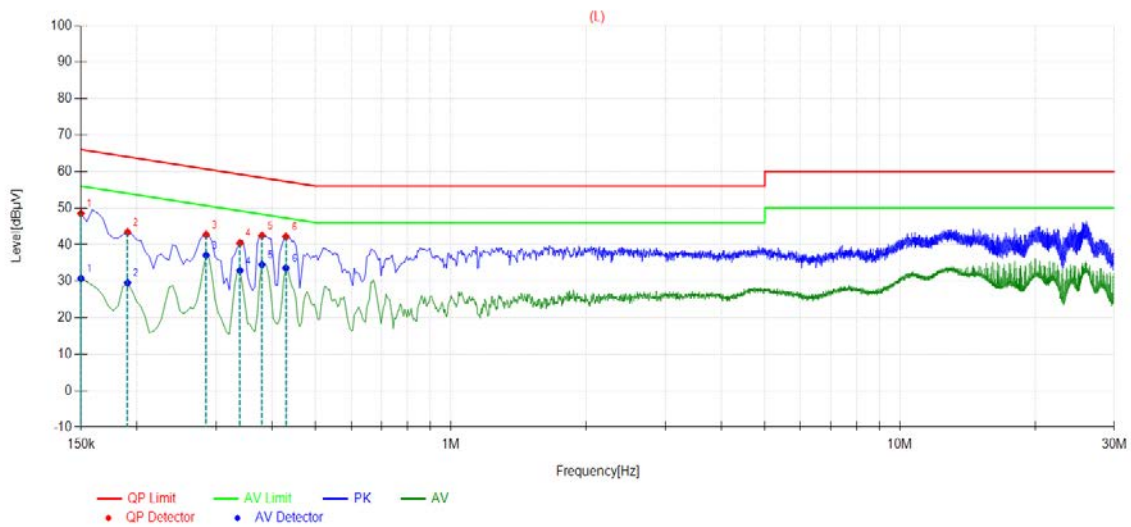
| Block diagram of Test Setup | |

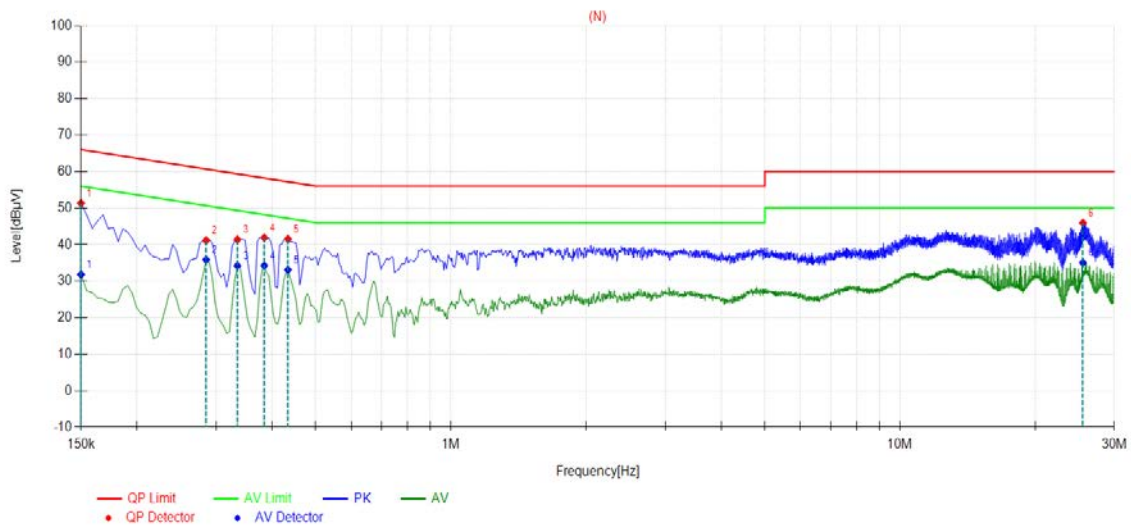
