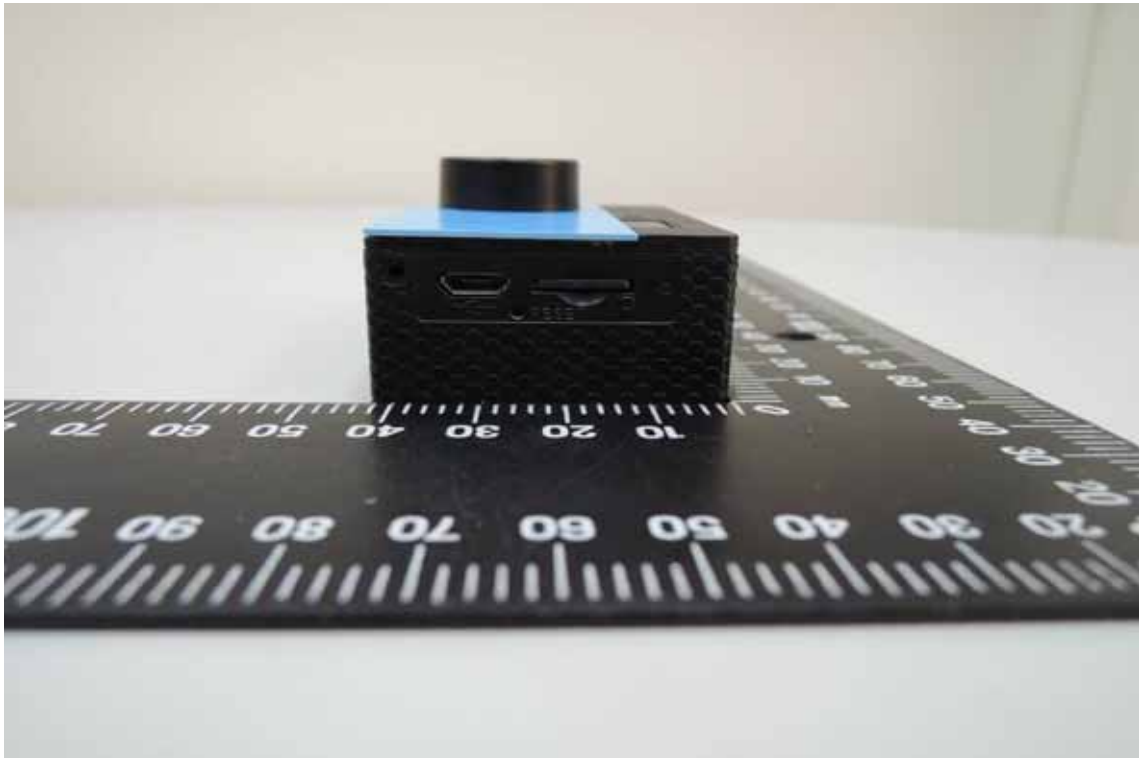
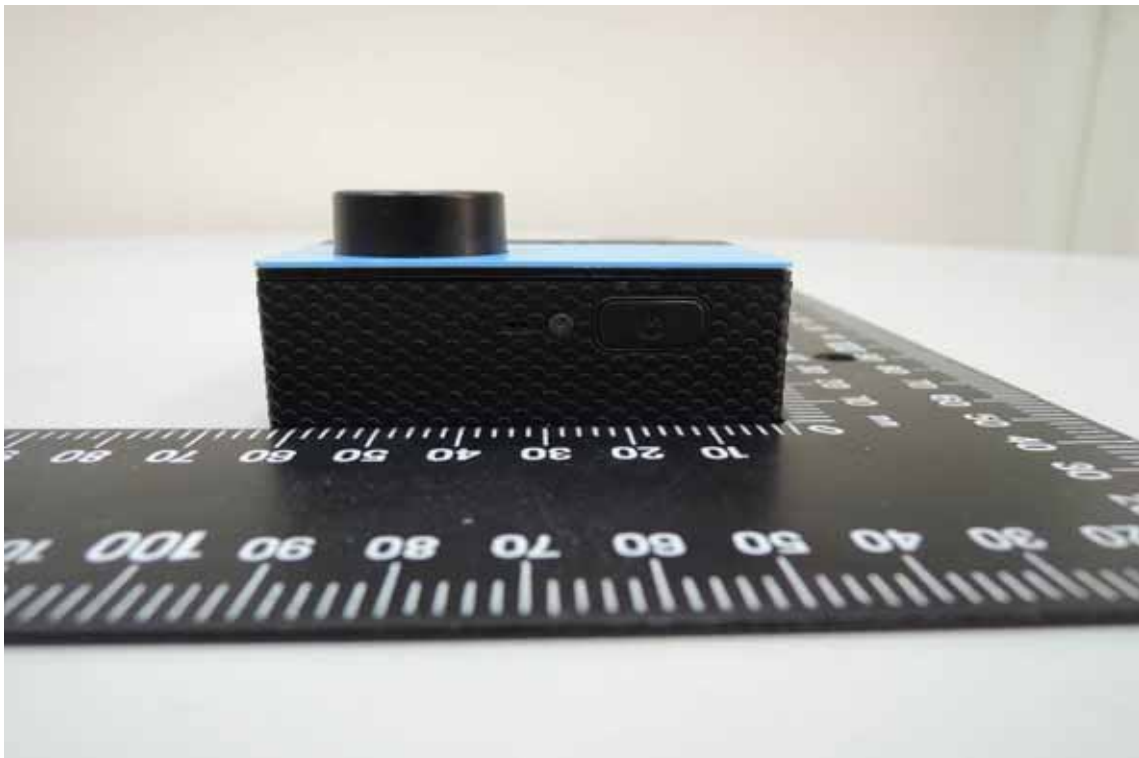
Side View of EUT – 1

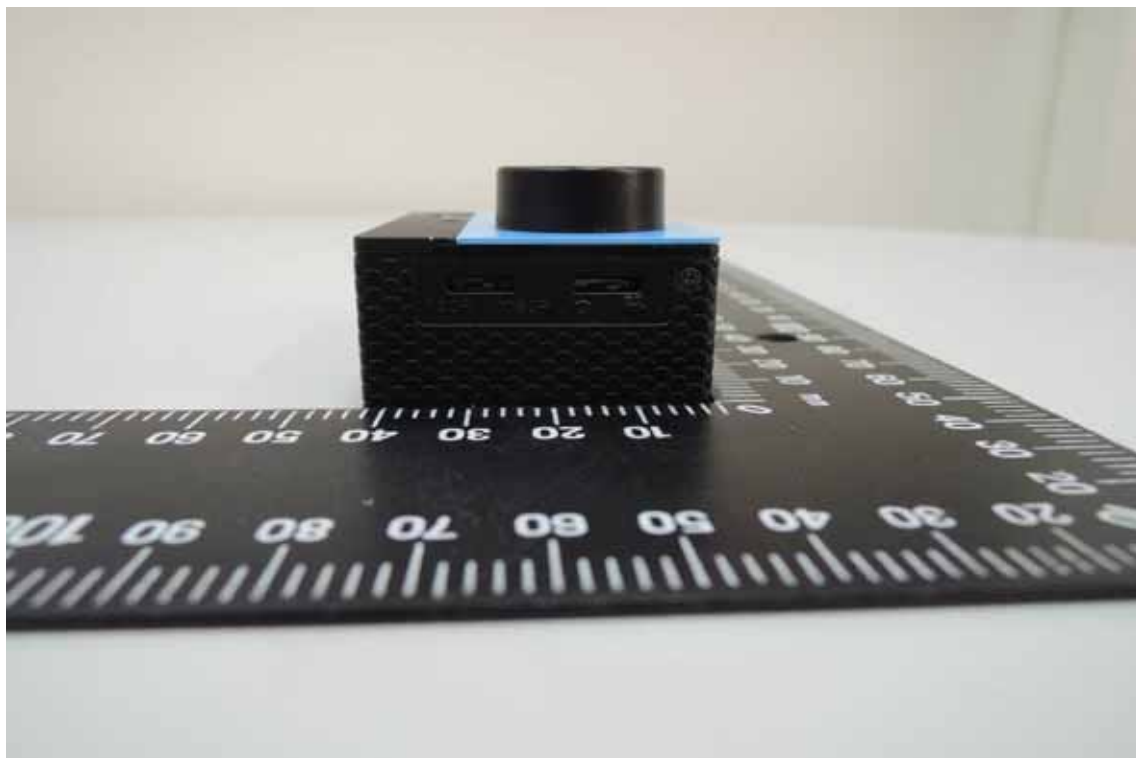
Side View of EUT – 2*Side View of EUT – 3*
