#### **Objective**

This report is prepared on behalf of Qingdao Yeelink Information Technology Co., Ltd. in accordance with Part 2-Subpart J, Part 15-Subparts A, B and C of the Federal Communication Commissions rules.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, and section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

## **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices and FCC KDB558074 D01 DTS Meas Guidance v03r05.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Kunshan). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with RF radiated emission is 5.91 dB for 30MHz-1GHz.and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.



- f(GHz) is the RF channel transmit frequency in GHz

- 3.0 and 7.5 are referred to as the numeric thresholds in the step 2 below

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $\leq 5$  mm, a distance of 5 mm according to 5) in section 4.1 is applied to determine SAR test exclusion.

#### **Measurement Result**

The maximum conducted peak output power = 0 dBm (1mW) at 2402~2480MHz [(max. power of channel, mW)/(min. test separation distance, mm)][  $\sqrt{f(GHz)}$ ] =1/5\*(  $\sqrt{2.480}$ ) = 0.31< 3.0

# FCC §15.203 - ANTENNA REQUIREMENT

### **Applicable Standard**

According to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. The structure and application of the EUT were analyzed to determine compliance with section §15.203 of the rules. §15.203 state that the subject device must meet the following criteria:

- a. Antenna must be permanently attached to the unit.
- b. Antenna must use a unique type of connector to attach to the EUT.

Unit must be professionally installed, and installer shall be responsible for verifying that the correct antenna is employed with the unit.

And according to FCC 47 CFR section 15.247 (b), if the transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

#### **Antenna Connector Construction**

The EUT has a PCB antenna arrangement for Bluetooth, which the antenna gain is 2.5 dBi, fulfill the requirement of this section. Please refer to the EUT photos.



The Corrected factor is calculated by adding LISN VDF (Voltage Division Factor), Cable Loss and Transient Limiter Attenuation. The basic equation is as follows:

Correction Factor = LISN VDF + Cable Loss

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:



# AC 120V/60 Hz, Line







## **Corrected Amplitude & Margin Calculation**


#### **Applicable Standard**

According to FCC §15.247(b) (3), for systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. # FCC §15.247(d) – 100 kHz BANDWIDTH OF FREQUENCY BAND EDGE

#### **Applicable Standard**

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. 


# Band Edge, Left Side



## Power Spectral Density, BLE Low Channel




