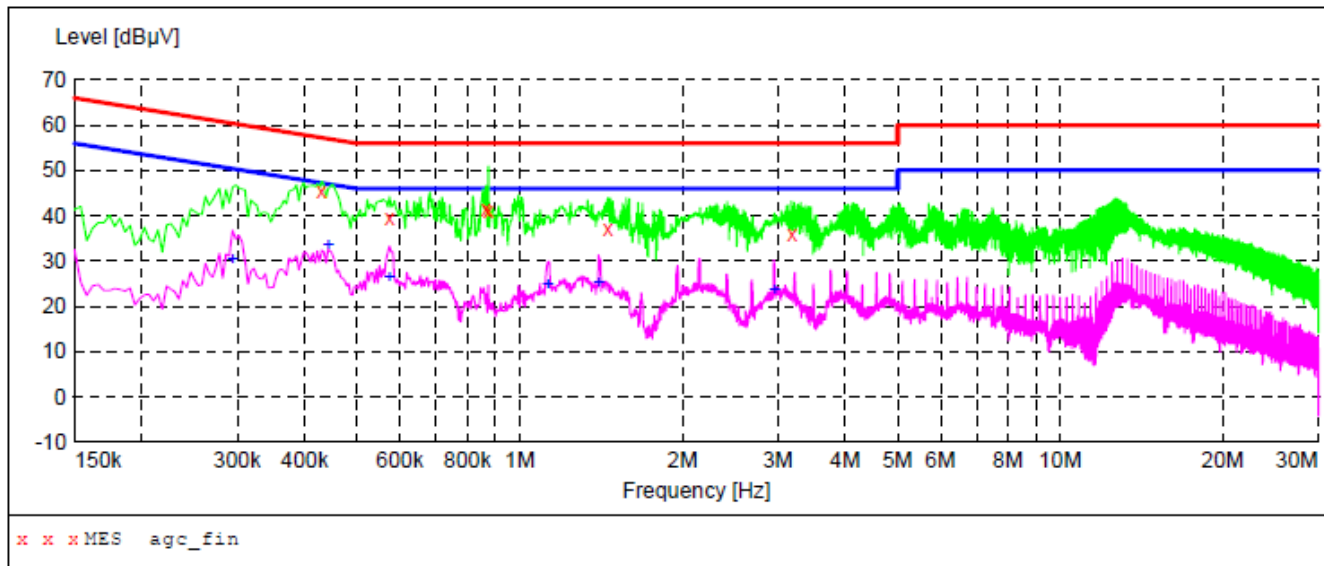

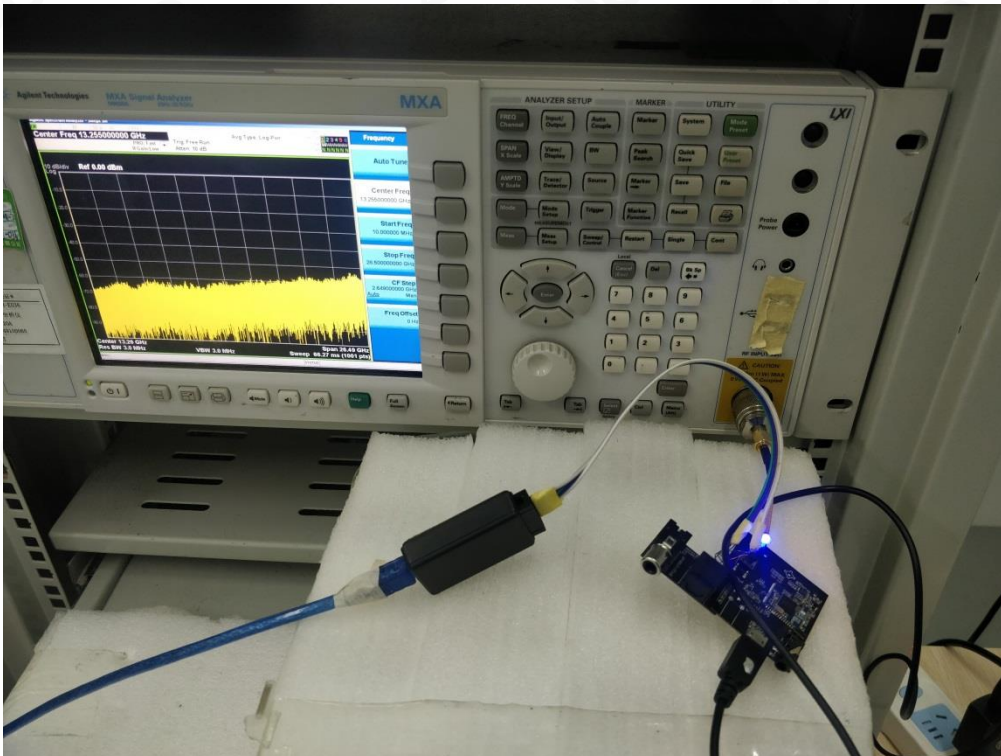

CONDUCTED EMISSION TEST SETUP

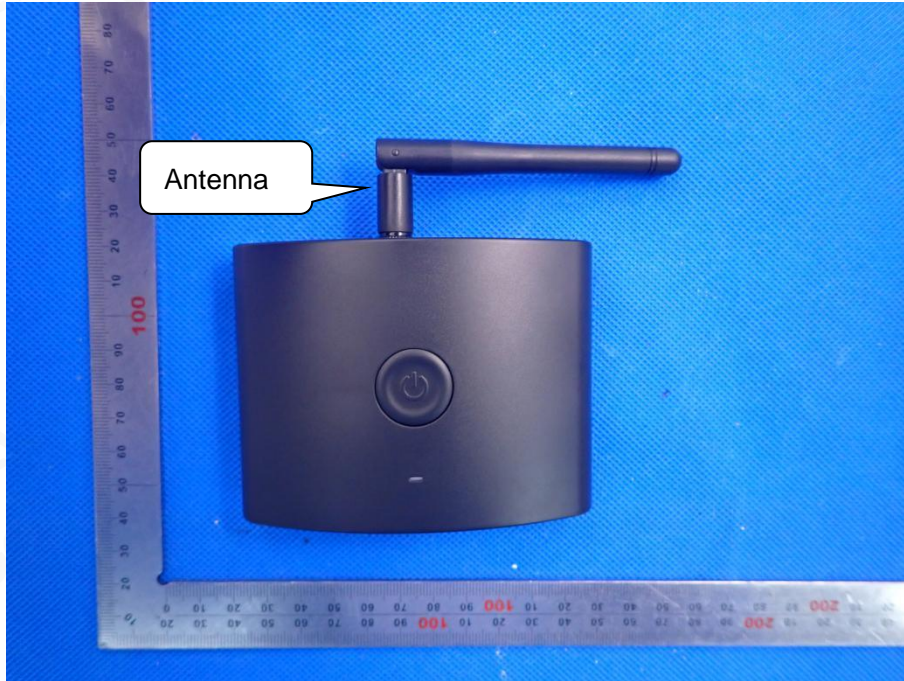

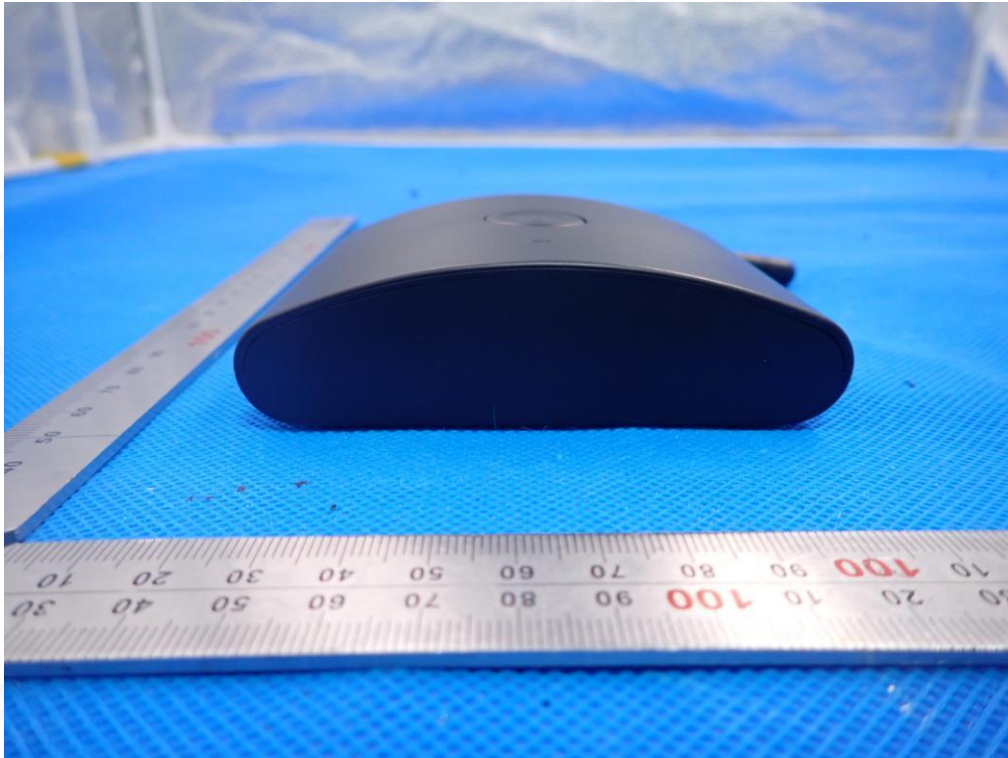

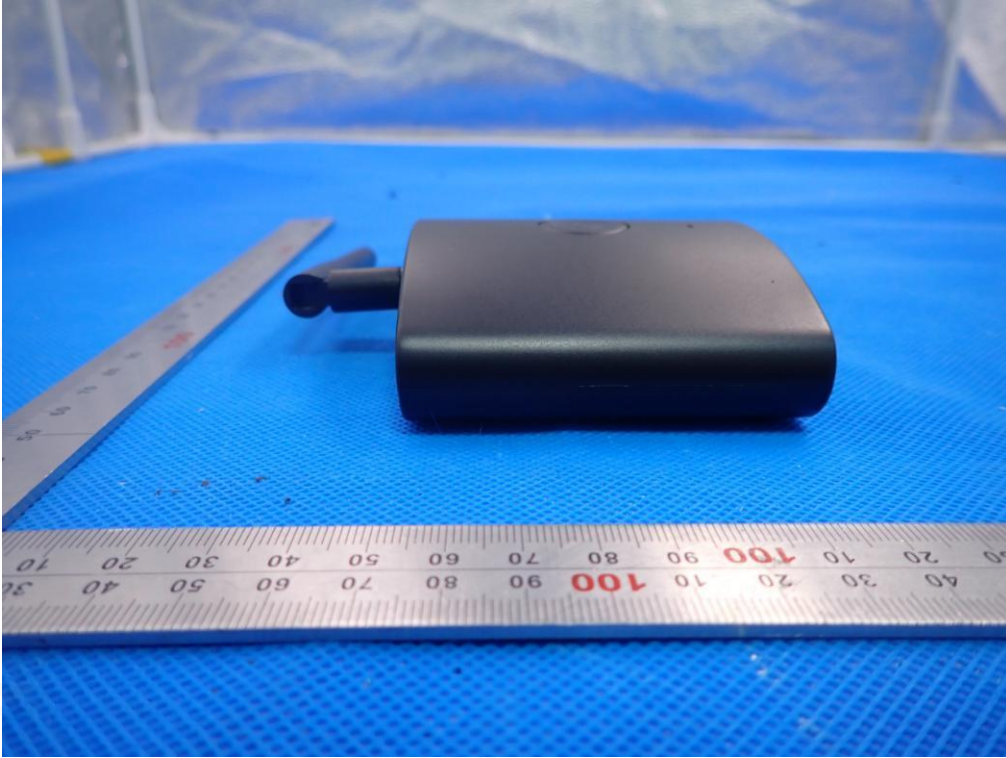

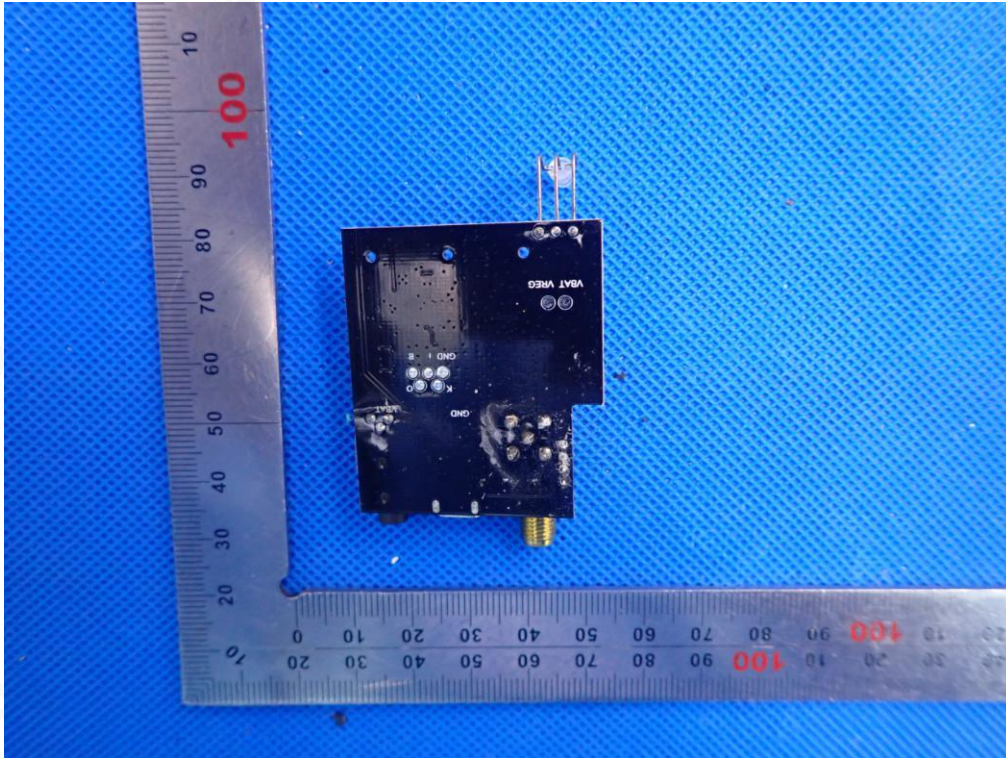

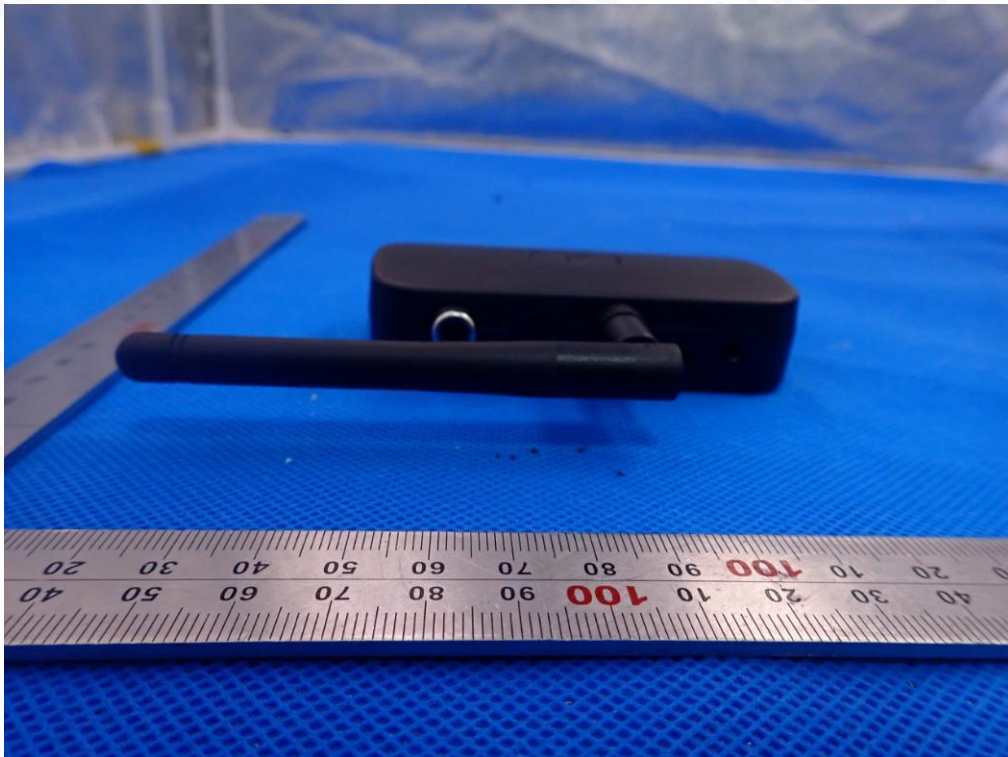

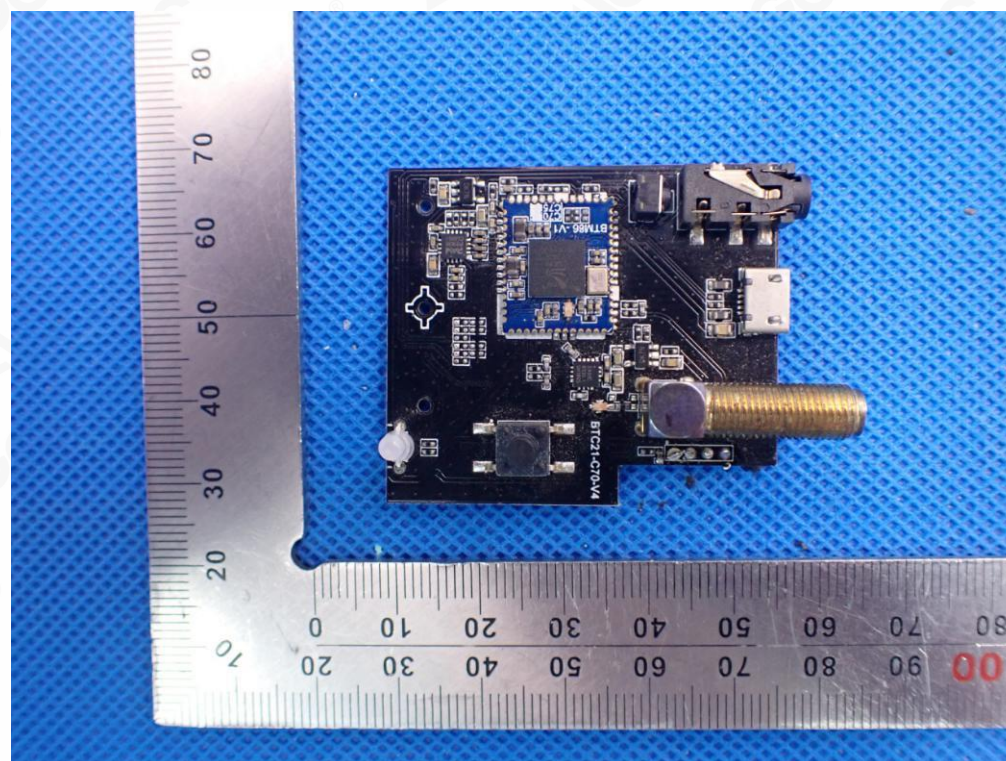




INTERNAL VIEW OF EUT-2

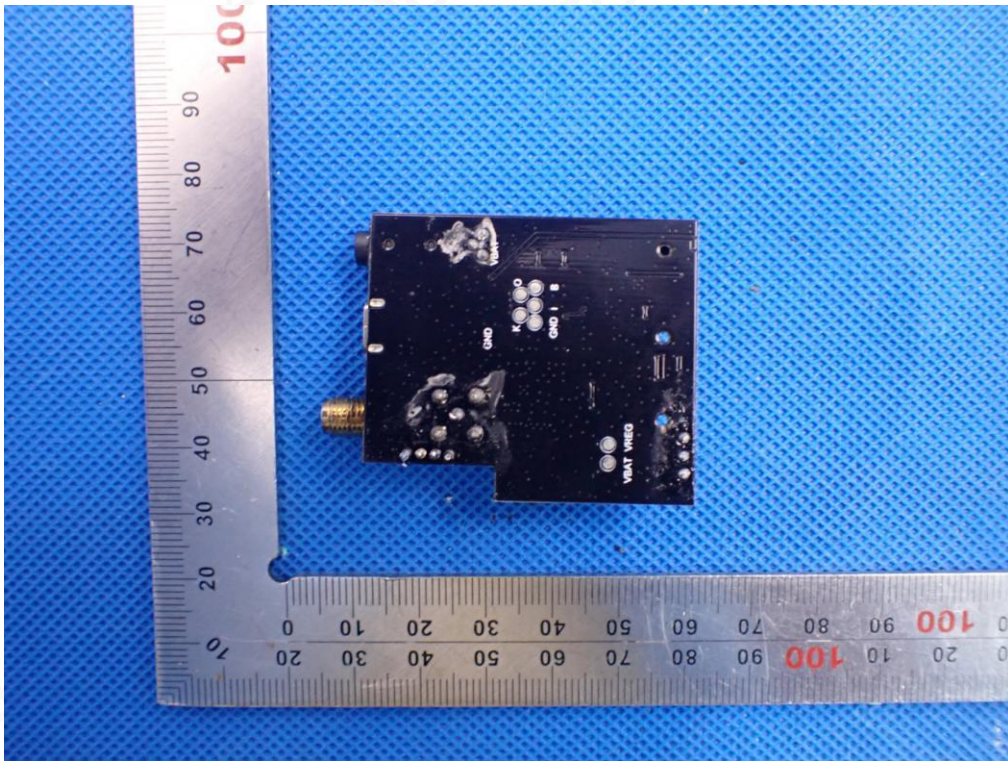

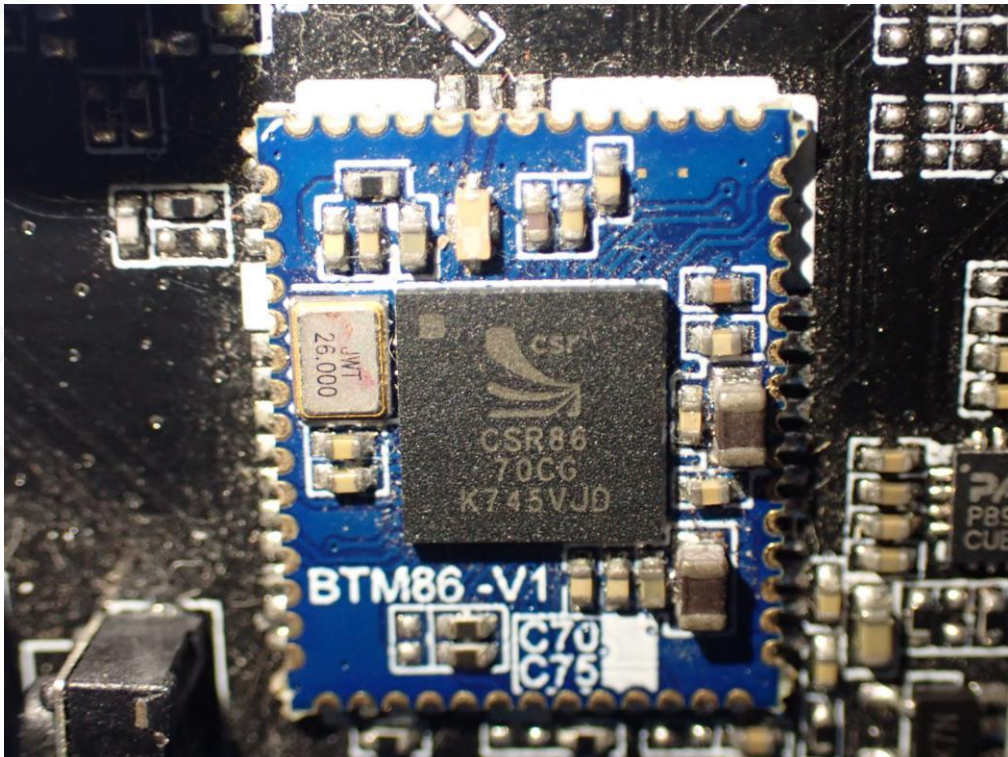
