



The diagram below shows the test setup that is utilized to make the measurements for emission from 30 Mb to 1 Gb Emissions.



2.2.2. IC

According to RSS-Gen Issue 5 8.9, Except where otherwise indicated in the applicable RSS, radiated emissions shall comply with the field strength limits shown in table 5 and table 6. Additionally, the level of any transmitter unwanted emission shall not exceed the level of the transmitter's fundamental emission.

According to B.10 of RSS-210 Issue 9, Devices shall comply with the following requirements:

- (a) The field strength of fundamental and harmonic emissions, measured at 3 m, shall not exceed 50 mV/m and 0.5 mV/m respectively.
 - The field strength limits shall be measured using an average detector, except for the fundamental emission in the frequency band 902-928 Mb, which is based on measurements using an International Special Committee on Radio Interference (CISPR) guasi-peak detector.
- (b) Emissions radiated outside of the specified frequency bands, except for harmonic emissions, shall be attenuated by at least 50 dB below the level of the fundamental emissions or to general field strength limits specified in RSS-Gen, whichever is less stringent.

The provisions of RSS-Gen regarding pulsed operation do not apply to CISPR measurement for the band 902-928 Mb.

2.3. Test Procedures

Radiated emissions from the EUT were measured according to the dictates of ANSI C63.10-2013.

2.3.1. Test procedures for emission below 30 Mb

- 1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. Then antenna is a loop antenna is fixed at one meter above the ground to determine the maximum value of the field strength. Both parallel and perpendicular of the antenna are set to make the measurement.
- 3. For each suspected emission, the EUT was arranged to its worst case and then the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 4. The test-receiver system was set to average or quasi peak detect function and Specified Bandwidth with Maximum Hold Mode.

2.3.2. Test procedures for emission above 30 Mb

- 2. During performing radiated emission below 1 %, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 %, the EUT was set 3 meter away from the interference-receiving antenna.
- 3. The antenna is a bi-log antenna, a horn antenna and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- 4. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 5. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- 6. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

Note;

- 1. For frequency below 1 $\mbox{ }\mbox{ }\mbo$
- 2. For frequency above 1 $\, \mathbb{G}_{2}$, set spectrum analyzer detector to peak, and resolution bandwidth is 1 $\, \mathbb{H}_{2} \,$ and video bandwidth is 3 $\, \mathbb{H}_{2} \,$.
- 3. To get a maximum emission level from the EUT, the EUT is manipulated through three orthogonal planes (X, Y, Z). Worst orthogonal plan of EUT is <u>Y axis</u> during radiation test.



Middle channel fundamental (Average)





Low channel Band edge (Average)





High channel Band edge (Average)





Low channel 2nd harmonic (Average)



Middle channel 2nd harmonic (Average)







High channel 2nd harmonic (Average)









3.3. Test Procedure

3.3.1. 20 dB Bandwidth

The test follows ANSI C63.10-2013.

The 20 dB bandwidth was measured with a spectrum analyzer connected to RF antenna connector (conducted measurement) while EUT was operating in transmit mode at the appropriate center frequency.

Use the following spectrum analyzer setting:

Span = approximately 2 to 5 times the 20 dB bandwidth.

RBW \geq 1 % to 5 % of the 20 dB bandwidth.

VBW ≥ 3 x RBW

Sweep = auto

Detector = peak

Trace = max hold

The marker-to-peak function to set the mark to the peak of the emission. Use the marker-delta function to measure 20 dB down one side of the emission. Reset the function, and move the marker to the other side of the emission, until it is (as close as possible to) even with the reference marker level. The marker-delta reading at this point is 20 dB bandwidth of the emission.

3.3.2. 99 % Bandwidth

- The span of the spectrum analyzer shall be set large enough to capture all products of the modulation process, including the emission skirts, around the carrier frequency, but small enough to avoid having other emissions (e.g. on adjacent channels) within the span.
- The detector of the spectrum analyzer shall be set to "Sample". However, a peak, or peak hold, may be used in place of the sampling detector since this usually produces a wider bandwidth than the actual bandwidth (worst-case measurement). Use of a peak hold (or "Max Hold") may be necessary to determine the occupied / $x \, dB$ bandwidth if the device is not transmitting continuously.
- The resolution bandwidth (RBW) shall be in the range of 1 % to 5 % of the actual occupied / $x \ dB$ bandwidth and the video bandwidth (VBW) shall not be smaller than three times the RBW value. Video averaging is not permitted.

For the 99% emission bandwidth, the trace data points are recovered and directly summed in linear power level terms. The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5 % of the total is reached, and that frequency recorded. The process is repeated for the highest frequency data points (starting at the highest frequency, at the right side of the span, and going down in frequency). This frequency is then recorded. The difference between the two recorded frequencies is the occupied bandwidth (or the 99% emission bandwidth).





Middle Channel












Middle Channel


