
Bluetooth Earbuds

What's included:

- 1 x Bluetooth Earbuds

It takes 2 hours to recharge from 0 to 100%. Playback at middle volume: up to 1 hour.

LED Indicators:

- Solid Red: Earbuds are being charged
- Solid Blue: Charging completed

ON/OFF

- Press and hold phone/music button 5 seconds

Bluetooth Set Up:

- During the connection process the Red and Blue LED will flash alternately.
- Search the possible Bluetooth connections from a Bluetooth enabled device. Select pairing name "xxxxxxx" from list of available devices.
- Once selected, the Earbuds will announce, "connected". Now you can play music.

Phone/music Button Function:

- Short press phone/music button: Play/Pause,
- Short press +/- button: Next/Previous song
- Long press +/- button: valume up/down

Phone Functions:

When a phone call comes in while the Earbuds are connected:

- Press and hold the Phone/music button to reject
- Press once to answer
- Press once to hang up when finishing the call
- Double press to redial the last Number called
