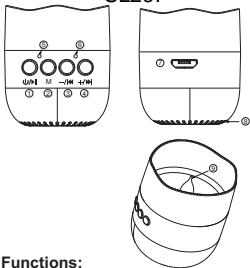


Bluetooth Speaker and Candle Light

Instruction Manual SL267



Functions:

1. Long press to power on/off+short press to pause.
2. Long press 1 times to open candle lamp brightness 50%, and then long press brightness 100%, and then long press off candle light.
3. Short press to play the last song, long press to decrease the volume.
4. Short press to play the next song, long press to increase the volume.
5. Charging indicator red LED.
6. Charging indicator blue LED.
7. Micro USB port.
8. Speaker.
9. Candle light.

What's included:

- 1 x Metal Speaker (SL267)
- 1 x USB to Micro-USB Charging Cable

- Playing time: up to 1.5hrs at max volume

Instructions:

(Be sure to fully charge the speaker before using for the first time).

1. Charging the Speaker

- Connect the provided charging cable to a power source and to the micro USB port on the speaker (7).

The LED indicator light will glow red when charging and turn off when fully charged.

3. Bluetooth Setup:

- Press and hold Power Button(1) to turn ON the speaker, Bluetooth LED Indicator(6) will flash BLUE.
- Turn on the Bluetooth function on mobile device, Select "Candle Light " pairing name. LED will flash slowly BLUE if successfully paired.
- Speaker will automatically pair if the mobile device has been paired before.
- Press and hold Power Button(1) to turn off the device.

4. Playing Music:

- Short press "Play/Pause" key to pause music. A second short press will resume playing music again.
- "Vol+/Next track":
Short press - next track.
Long press - increase volume.
- "Vol-/Previous track":
Short press - previous track
Long press - reduce volume
