

 Connect the provided charging cable to a power source and to the Type-C port on the speaker (3).
- The LED indicator light will glow red when charging and turn off when fully charged.
- 2. Bluetooth® Setup:
- Turn ON/OFF switch(4) to ON position, LED indicator(2) will flash BLUE.
- Turn on the Bluetooth function on mobile device, Select "Omni Outdoor" pairing name.
- The LED(2) will turn solid Blue and a tone will sound to confirm the speaker is successfully paired.
- Speaker will automatically pair if the mobile device has been paired before.
- Turn ON/OFF switch(4) to OFF position to turn off the device.
- ** If the bluetooth is disconnect the speaker will auto shut off after 5 mins.
