To Whom It May Concern:

SCA Hygiene Products AB (“SCA” or “Applicant”) hereby requests that the Federal Communications Commission (“Commission”) hold confidential certain portions of the application, as identified below for equipment certification for the referenced FCC identifiers. This request for long-term confidentiality is made pursuant to 47 C.F.R. §§ 0.457(d)(i) and 0.459 of the Commission’s Rules and Commission’s Guidance.<sup>1</sup> Pursuant to Section 0.459(b), Applicant requests long-term confidentiality based on the following facts:

Long-term confidentiality is sought to prevent disclosure of information pertaining to the referenced product to protect Applicant’s trade secrets. The disclosure of such information would result in substantial competitive harm to Applicant. Specifically, Applicant manufactures and sells hygiene products and dispenser systems (e.g., paper towel dispenser, soap dispensers, etc.) under its TENA® and TORK® brands. Applicant’s customer base includes companies

within the industrial, commercial, healthcare, and hospitality industries. Applicant competes with a myriad of large manufacturers for these customers.

Applicant has invested considerable time and materials in research and development to produce the referenced product. Information pertaining to the referenced product, including development and production is trade secret; access to this information is limited to authorized SCA personnel. This information is not known to the public or reasonably ascertainable and Applicant has worked diligently to prevent any disclosure to third parties or unauthorized personnel. Disclosure of the confidential portions of this application to competitors would not only give SCA's competitors significant business advantages in developing similar products, but it would also disclose successful implementation of unpublished, leading-edge technology developed by Applicant.

Pursuant to Section 0.459(e), as these materials are being submitted voluntarily, Applicant requests that the Commission return the materials without consideration if this request for long-term confidentiality should be denied.
