99% Occupancy bandwidth



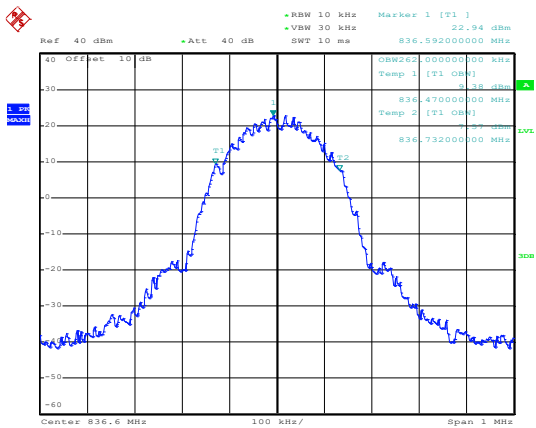
