





Body - distance between flat phantom and EUT is 0 mm




Photograph 1. Body, Top Edge, 0mm




Photograph 3. Body, Bottom Edge, 0mm




Photograph 5. Body, Left Edge, 0mm








PD - distance between the probe sensor and EUT is 2 mm




Photograph 11. PD, Top Edge, 2mm


