

Using with a Wired Device

Insert the 3.5 mm connector of the supplied RCA cable into the 3.5 mm Auxiliary Input port on the side of the subwoofer. Connect the RCA connectors to the RCA ports on your TV or other media device, matching the connectors to the ports by color.

To connect to a headphone jack, plug one end of the included 3.5 mm auxiliary cable into the 3.5 mm Auxiliary Input port on the side of the subwoofer. Plug the other end into the headphone jack on your media-playing device.

While the audio system's aux port is in use, the LED indicator will show **SOLID BLUE**, and Bluetooth connections will be disabled.

Using the Lights

• Press the **(LED MODE)** button to cycle through the LED light modes.

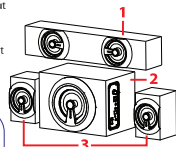
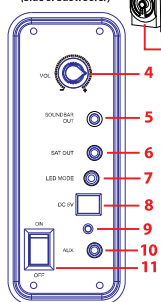

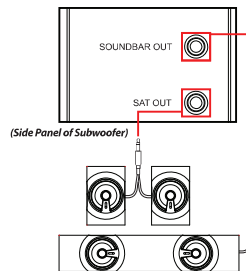
Getting Started

Powering the Speaker System

Insert the pin of the supplied power adapter into the power port on the side of the subwoofer. Plug the other end into a wall socket.

Setting Up the Speaker

Plug the single 3.5 mm connector of the two satellite speakers into the Satellite Speaker Output port on the side panel of the subwoofer. Plug the connector of the soundbar into the Soundbar Output port on the side panel of the subwoofer.



Powering ON/OFF

• Flip the [Power] switch on the side panel of the subwoofer to power ON/OFF.

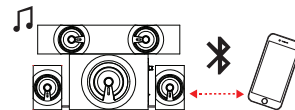


Playing Audio

To listen to audio on your speaker system, you must be paired to a Bluetooth-enabled device or connected to a device with the RCA cable. Once connected, playback can be controlled via your media-playing device.

Bluetooth Pairing

1. Power the speaker ON. A tone will be heard and the Bluetooth LED indicator will **quickly flash BLUE**.
2. Set your mobile device to search for Bluetooth devices. When it appears, select **AR3092** from the list of found devices.
3. After a successful pairing, a tone will be heard and the Bluetooth LED indicator will **slowly flash BLUE**.



Adjusting Volume

Volume can be adjusted using the Volume Dial on the side of the subwoofer, or with your connected media-playing device.
