# 2.2 Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (X plane) were recorded in this report, and the worst mode of radiated spurious emissions is Bluetooth 3Mbps mode, and recorded in this report.
- b. AC power line Conducted Emission was tested under maximum output power.






# 2.3 Connection Diagram of Test System

# 2.5 EUT Operation Test Setup

For Bluetooth function, the engineering test program was provided and enabled to make EUT connect with Bluetooth base station to continuous transmit/receive.

For AC power line conducted emissions, the EUT was set to connect with the WLAN AP under large package sizes transmission.

# 2.6 Measurement Results Explanation Example

### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 1.2dB and attenuator factor 20 dB.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB).

= 1.2(dB) + 20 (dB) =21.2(dB)

Frequency hopping systems in the 2400-2483.5 MHz band shall use at least 15 channels.

- 1. The testing follows ANSI C63.10-2013 clause 7.8.3.
- 2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
- 3. Set to the maximum power setting and enable the EUT transmit continuously.
- 4. Enable the EUT hopping function.
- Use the following spectrum analyzer settings: Span = the frequency band of operation;
   RBW = 300kHz; VBW ≥ RBW; Sweep = auto; Detector function = peak; Trace = max hold.
- 6. The number of hopping frequency used is defined as the number of total channel.
- 7. Record the measurement data derived from spectrum analyzer.



# 3.2 Hopping Channel Separation Measurement

# 3.2.1 Limit of Hopping Channel Separation

Frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater.

- 4. Enable the EUT hopping function.
- Use the following spectrum analyzer settings:
   Span = wide enough to capture the peaks of two adjacent channels;
   RBW = 300kHz; VBW ≥ RBW; Sweep = auto; Detector function = peak; Trace = max hold.
- 6. Measure and record the results in the test report.








### Channel Separation Plot on Channel 77 - 78








### Channel Separation Plot on Channel 39 - 40





# 3.3.1 Limit of Dwell Time

The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed.

- 1. The testing follows ANSI C63.10-2013 clause 7.8.4.
- The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
- 3. Set to the maximum power setting and enable the EUT transmit continuously.
- 4. Enable the EUT hopping function.
- 5. Use the following spectrum analyzer settings: Span = zero span, centered on a hopping channel; RBW = 1 MHz; VBW ≥ RBW; Sweep = as necessary to capture the entire dwell time per hopping channel; Detector function = peak; Trace = max hold.
- 6. Measure and record the results in the test report.




Spectrum Analyzer

 In normal mode, hopping rate is 1600 hops/s with 6 slots (5 Transmit and 1 Receive slot) in 79 hopping channels.

With channel hopping rate (1600 / 6 / 79) in Occupancy Time Limit  $(0.4 \times 79)$  (s), Hops Over Occupancy Time comes to  $(1600 / 6 / 79) \times (0.4 \times 79) = 106.67$  hops.





#### 20 dB Bandwidth Plot on Channel 00








#### 20 dB Bandwidth Plot on Channel 78








#### 20 dB Bandwidth Plot on Channel 39






#### 99% Occupied Bandwidth Plot on Channel 39




#### 99% Occupied Bandwidth Plot on Channel 78








#### 99% Occupied Bandwidth Plot on Channel 39

#### 99% Occupied Bandwidth Plot on Channel 78





# 99% Occupied Bandwidth Plot on Channel 00





# 3.5 Output Power Measurement

# 3.5.1 Limit of Output Power

The maximum peak conducted output power of the intentional radiator shall not exceed the following: (1) For frequency hopping systems operating in the 2400-2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725-5850 MHz band: 1 watt. For all other frequency hopping systems in the 2400-2483.5 MHz band 0.125 watts.

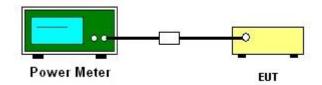

# 3.5.3 Test Procedures

- 1. The testing follows ANSI C63.10-2013 clause 7.8.5.
- 2. The RF output of EUT was connected to the power meter by RF cable and attenuator. The path loss was compensated to the results for each measurement.
- 3. Set to the maximum power setting and enable the EUT transmit continuously.
- 4. Measure the conducted output power with cable loss and record the results in the test report.
- 5. Measure and record the results in the test report.

# 3.6 Conducted Band Edges Measurement

# 3.6.1 Limit of Band Edges

In any 100 kHz bandwidth outside the intentional radiation frequency band, the radio frequency power shall be at least 20 dB below the highest level of the radiated power. In addition, radiated emissions which fall in the restricted bands must also comply with the radiated emission limits.

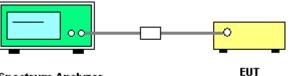

# 3.6.3 Test Procedures

- 1. The testing follows ANSI C63.10-2013 clause 7.8.6.
- 2. Set to the maximum power setting and enable the EUT transmit continuously.
- 3. Set RBW = 100kHz, VBW = 300kHz. Band edge emissions must be at least 20 dB down from the highest emission level within the authorized band as measured with a 100kHz RBW. The attenuation shall be 30 dB instead of 20 dB when RMS conducted output power procedure is used.
- 4. Enable hopping function of the EUT and then repeat step 2. and 3.
- 5. Measure and record the results in the test report.














