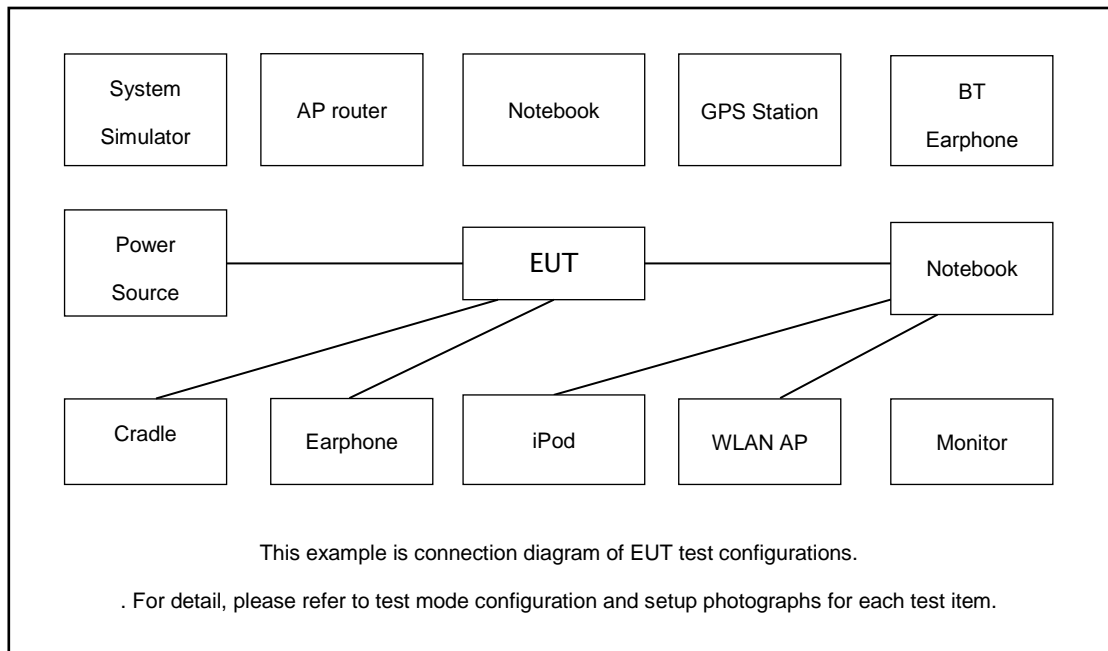

## 2. TEST RESULT

### 2.1 AC Power Line Conducted Emissions Measurement

#### 2.1.1 Limit

For a Low-power Radio-frequency device which is designed to be connected to the AC power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed below limits table.

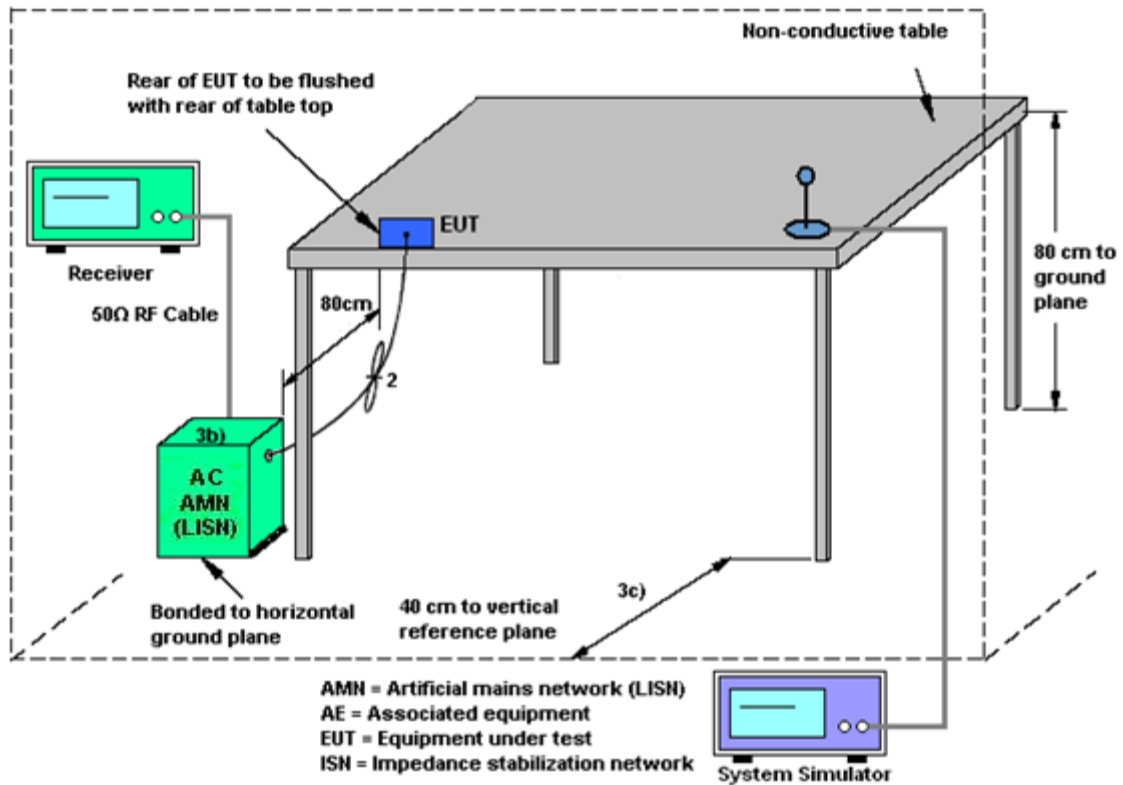

#### 2.1.3 Test Procedures

1. The EUT was placed 0.4 meter from the conducting wall of the shielding room, and it was kept at least 80 centimeters from any other grounded conducting surface.
2. Connect EUT to the power mains through a line impedance stabilization network (LISN).
3. All the support units are connecting to the other LISN.
4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
5. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
6. Both sides of AC line were checked for maximum conducted interference.
7. The frequency range from 150 kHz to 30 MHz was searched.
8. Set the test-receiver system to Peak Detect Function and specified bandwidth (IF bandwidth = 9kHz) with Maximum Hold Mode.

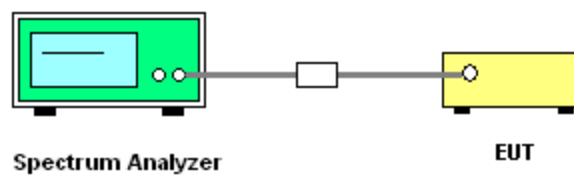

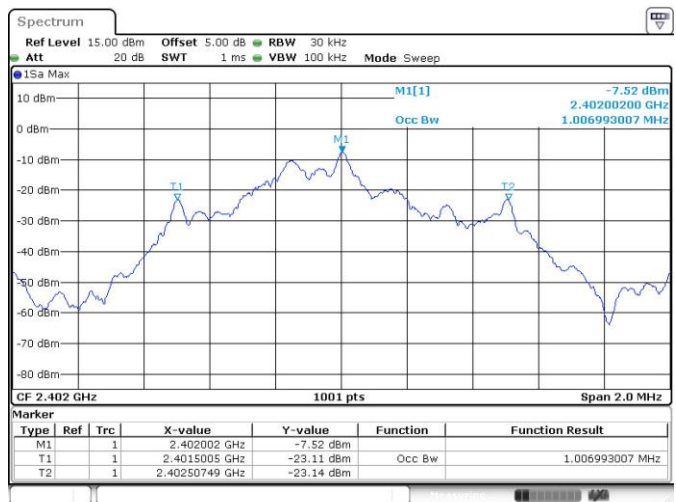

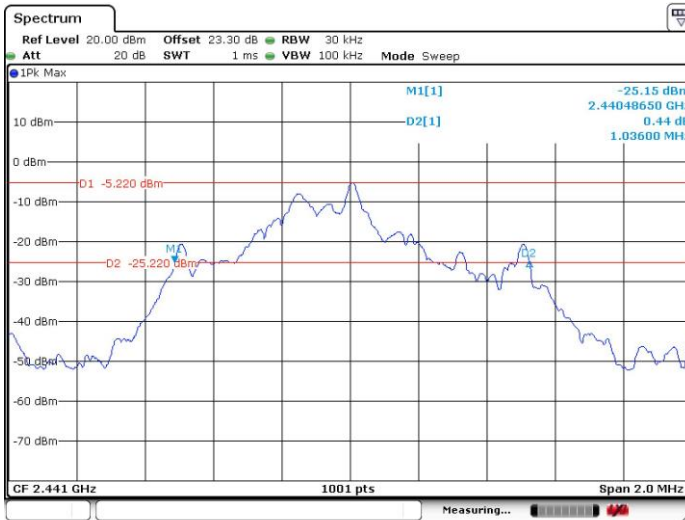

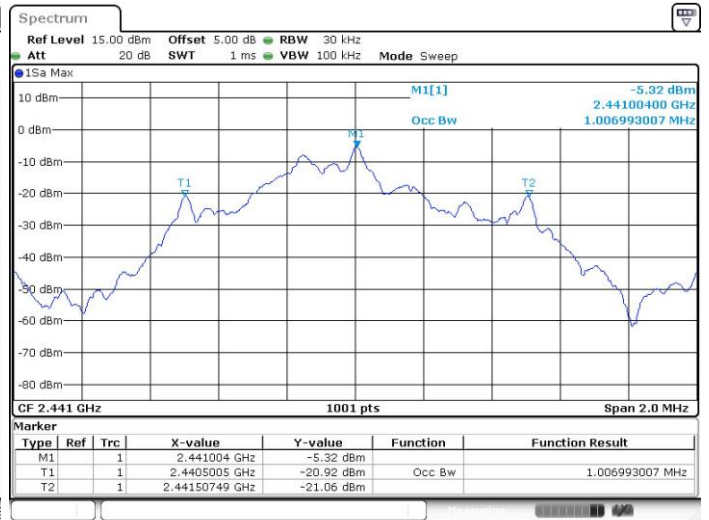


20 dB Bandwidth Plot on 2441MHz



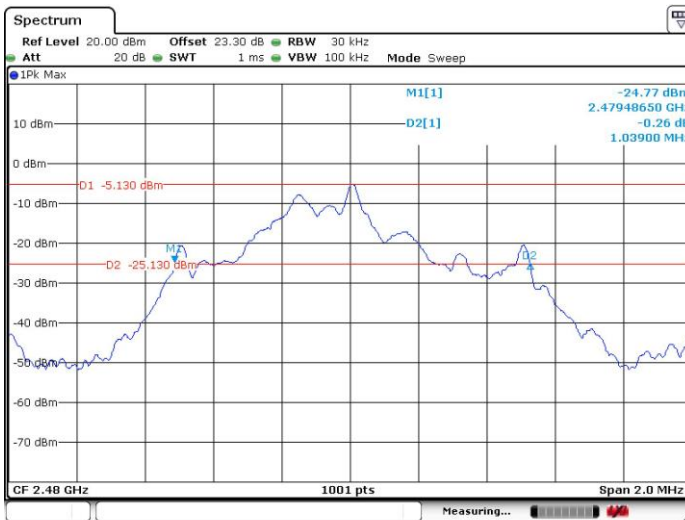

99% Bandwidth Plot on 2441MHz



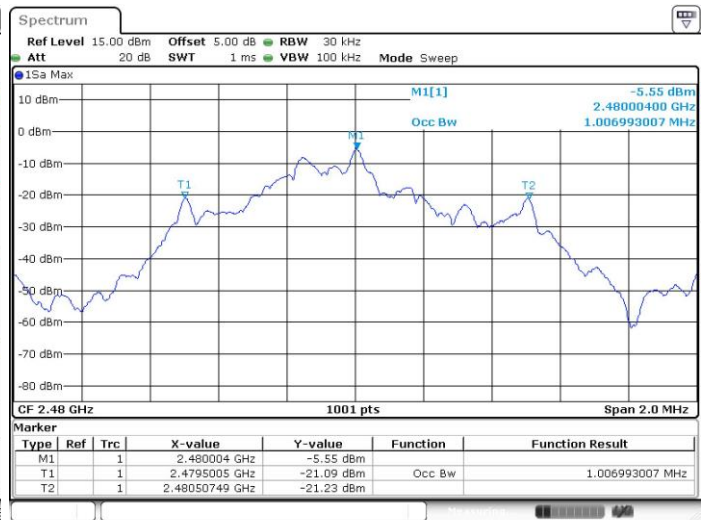

## 2.3 Field Strength of Fundamental Emissions and Radiated Spurious Emissions

### 2.3.1 Limit

The field strength measured at 3 meters shall not exceed the limits in the following table:

### 2.3.3 Test Procedures

1. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
2. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
3. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
4. Set to the maximum power setting and enable the EUT transmit continuously.

**Remark:**

1. Corrected Reading: Antenna Factor + Cable Loss + Read Level - Preamp Factor = Level
2. For average measurement: use duty cycle correction factor method per 15.35(c).

Duty cycle = On time/100 milliseconds

On time =  $N1*L1+N2*L2+...+Nn-1*LNn-1+Nn*Ln$

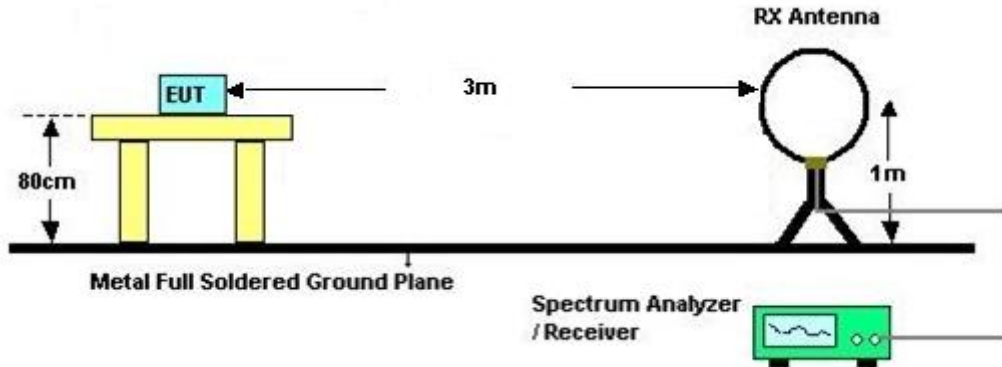

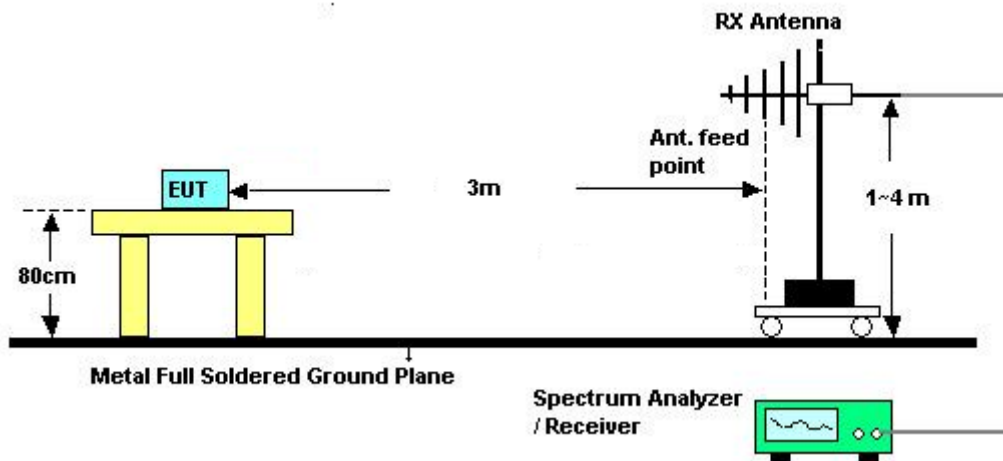

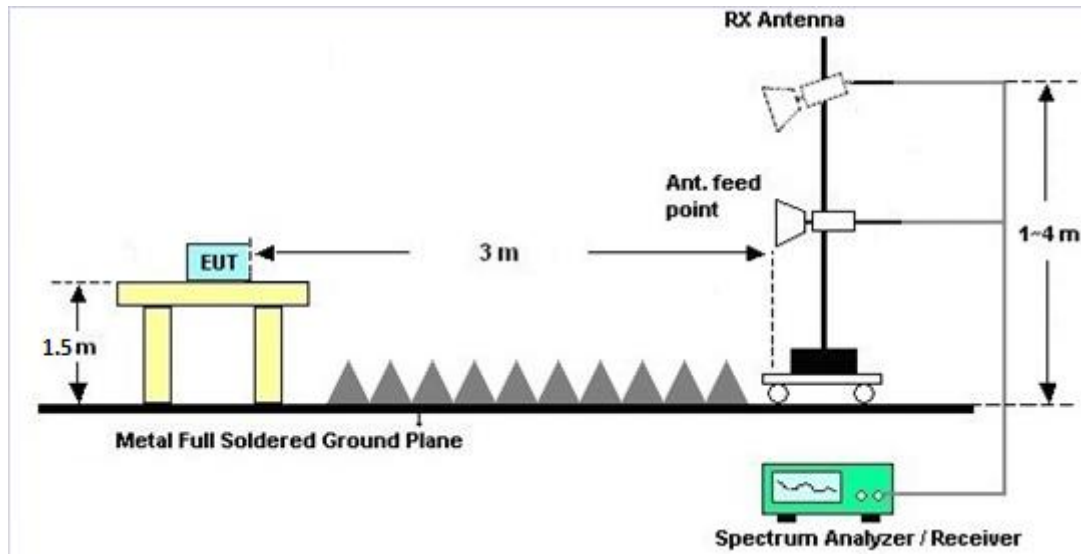
For radiated emissions below 30MHz

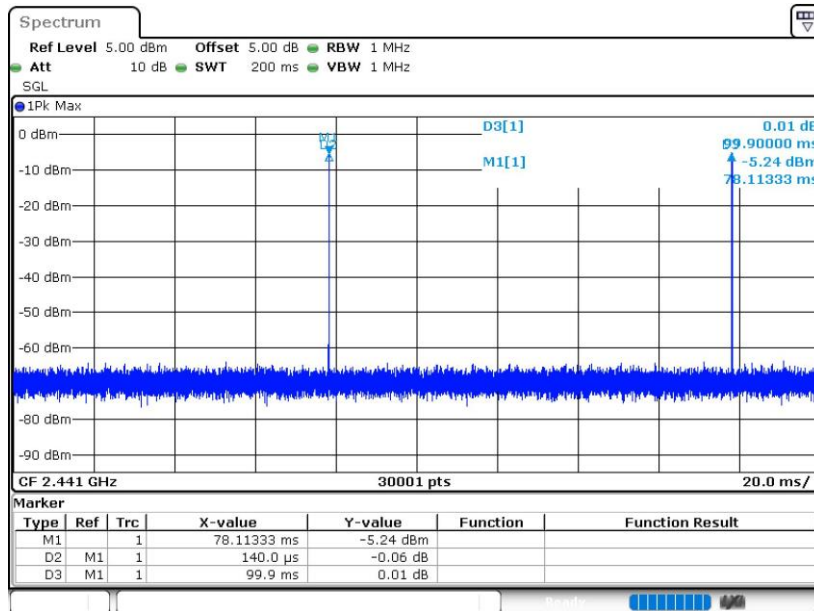
The low frequency, which started from 9 kHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line per 15.31(o) was not reported.

There is a comparison data of both open-field test site and semi-Anechoic chamber, and the result came out very similar.

## **2.4 Antenna Requirements**

### **2.4.1 Limit**

Except for special regulations, the Low-power Radio-frequency Devices must not be equipped with any jacket for installing an antenna with extension cable. An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that the user can replace a broken antenna, but the use of a standard antenna jack or electrical connector is prohibited.

### **2.4.2 Antenna Connector Construction**

An embedded-in antenna design is used.
