2.2 Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Z plane) were recorded in this report, and the worst mode of radiated spurious emissions is Bluetooth 3Mbps mode, and recorded in this report.
- b. AC power line Conducted Emission was tested under maximum output power.



2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 3.3 dB and 20dB attenuator.









Channel Separation Plot on Channel 39 - 40




Channel Separation Plot on Channel 77 - 78

Channel Separation Plot on Channel 00 - 01









Channel Separation Plot on Channel 39 - 40




20 dB Bandwidth Plot on Channel 78


99% Occupied Bandwidth Plot on Channel 78

High Band Edge Plot on Channel 78







High Band Edge Plot on Channel 78



Hopping Mode High Band Edge Plot





CSE Plot on Ch 00 between 2 GHz ~ 25 GHz





CSE Plot on Ch 39 between 2 GHz ~ 25 GHz







CSE Plot on Ch 00 between 2 GHz ~ 25 GHz





CSE Plot on Ch 39 between 30MHz ~ 3 GHz




CSE Plot on Ch 39 between 2 GHz ~ 25 GHz





CSE Plot on Ch 78 between 2 GHz ~ 25 GHz







CSE Plot on Ch 00 between 2 GHz ~ 25 GHz







CSE Plot on Ch 39 between 2 GHz ~ 25 GHz







For radiated emissions below 30MHz



3.10 Antenna Requirements






