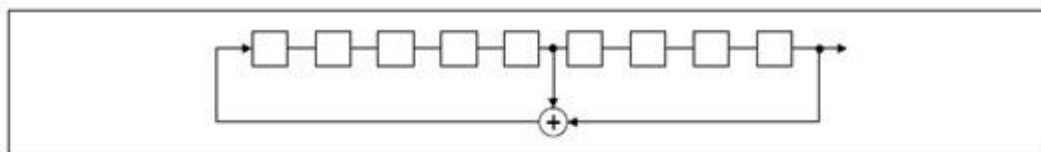

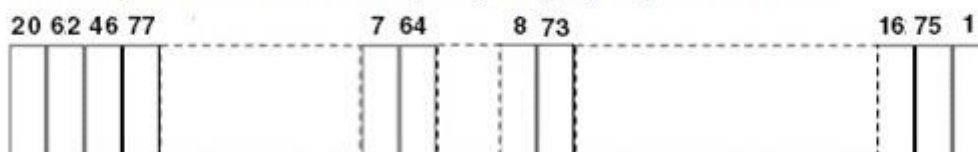
Linear Feedback Shift Register for Generation of the PRBS sequence

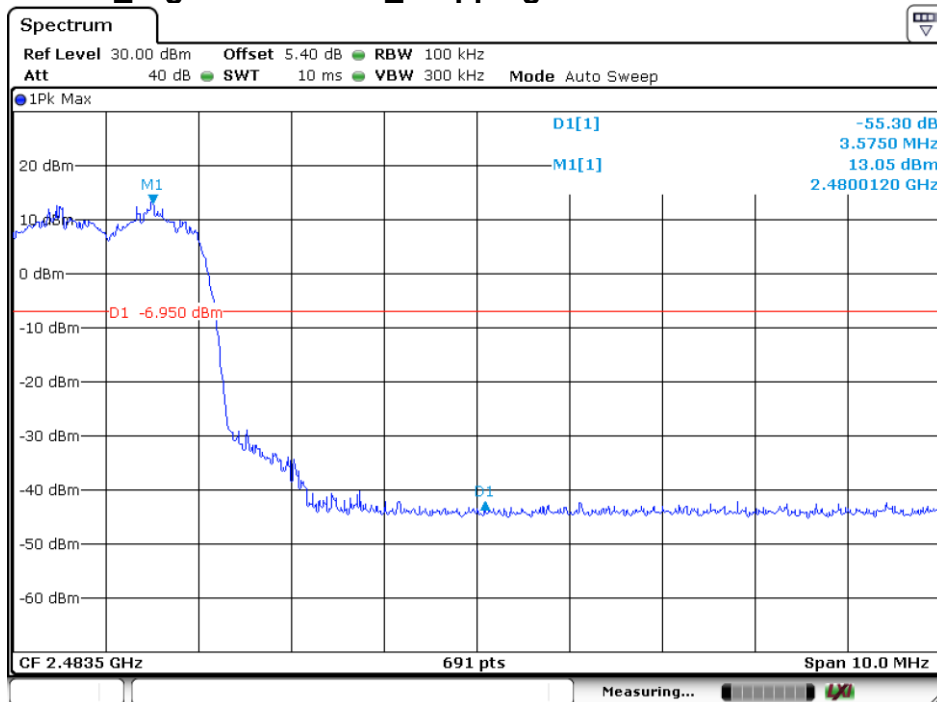


4.9.1.6 $\pi/4$ DQPSK _Lowest Channel_ Hopping OFF

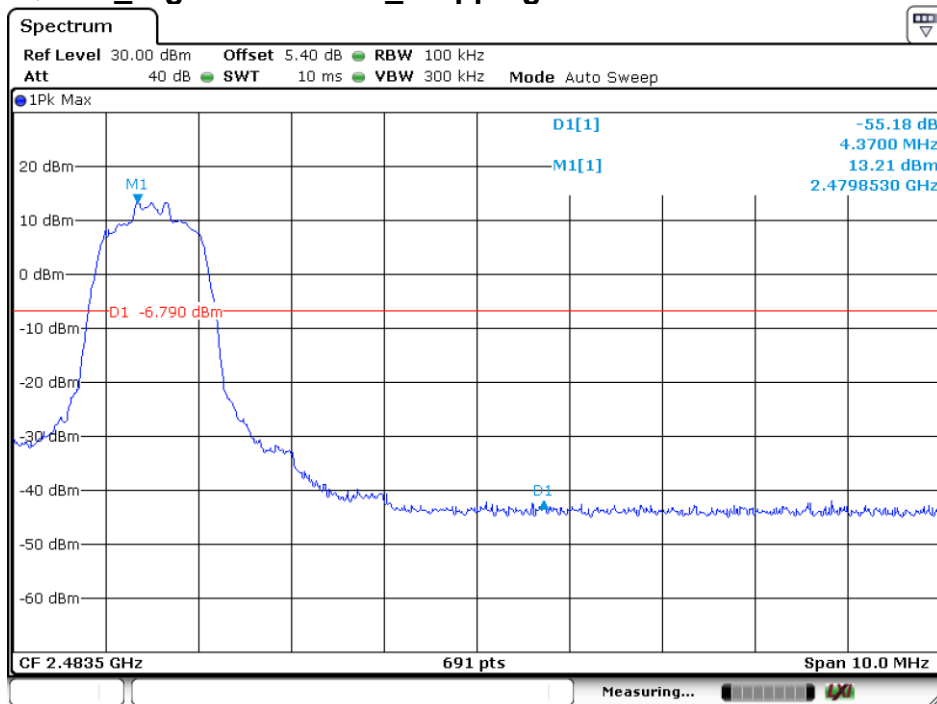
4.9.1.7 $\pi/4$ DQPSK _Highest Channel_ Hopping ON

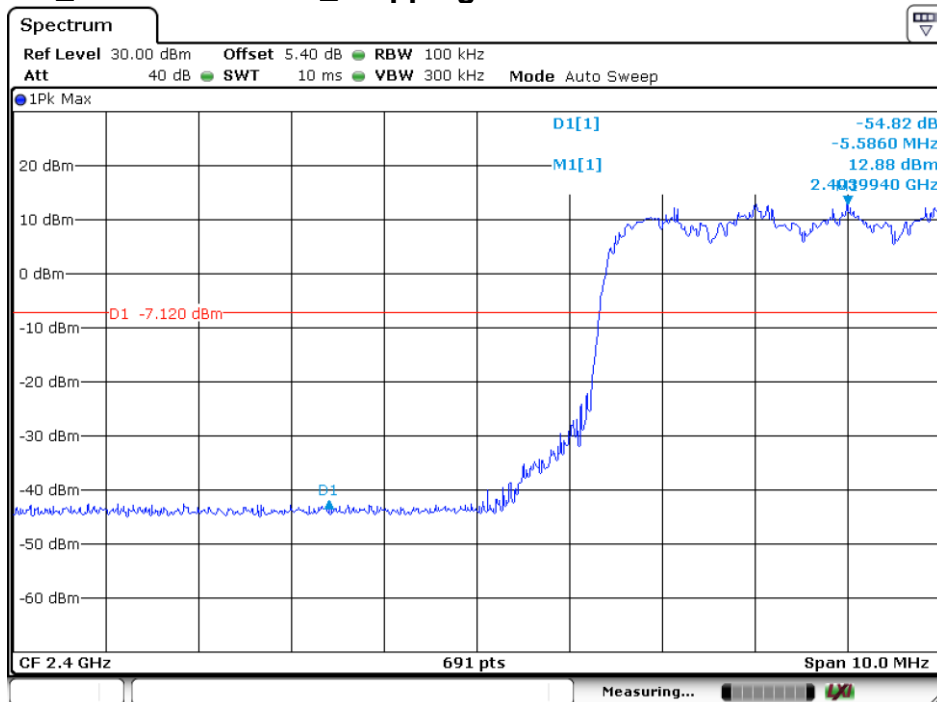


4.9.1.8 $\pi/4$ DQPSK _Highest Channel_ Hopping OFF

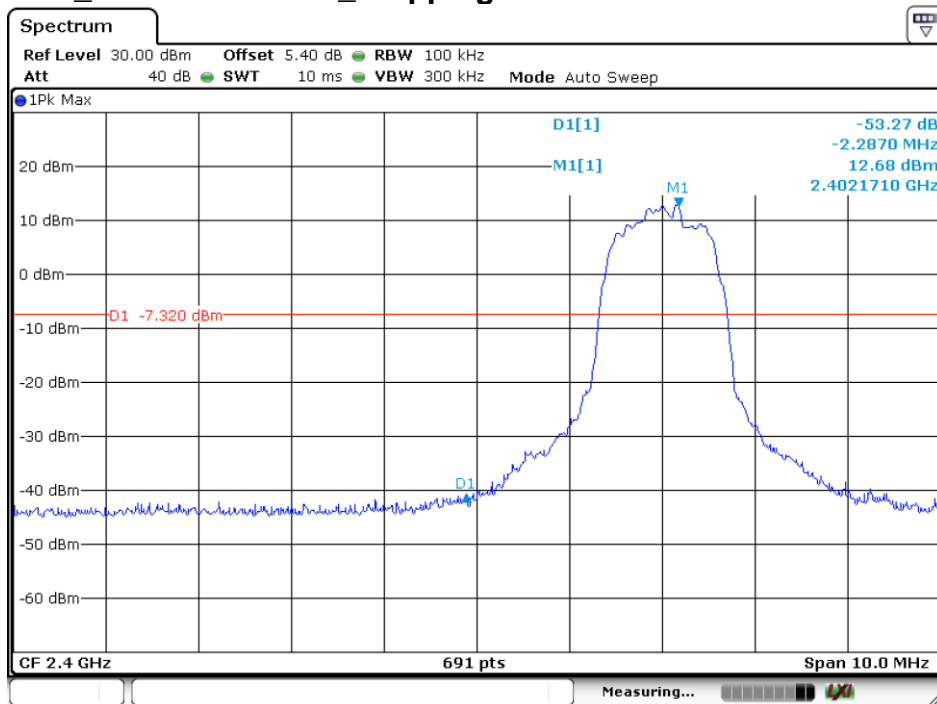

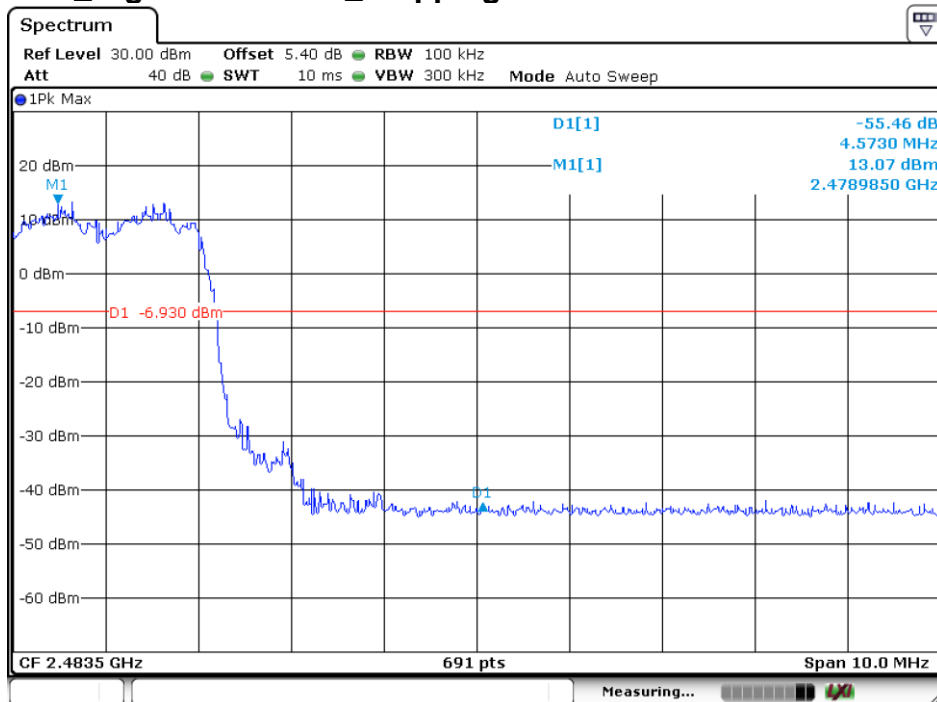


4.9.1.10 8DPSK _Lowest Channel_ Hopping OFF
