MPE Calculation Method

$$\mathsf{E}(\mathsf{V/m}) = \frac{\sqrt{30*P*G}}{d}$$
 Power Density: $Pd(\mathsf{W/m^2}) = \frac{E^2}{377}$

E = Electric field (V/m)

P = Average RF output power (W)

G = EUT Antenna numeric gain (numeric)

d = Separation distance between radiator and human body (m)

The formula can be changed to

$$Pd = \frac{30*P*G}{377*D^2}$$

From the EUT RF output power, the minimum mobile separation distance, d=0.2m, as well as the gain of the used antenna, the RF power density can be obtained.

When a number of sources at different frequencies, and/or broadband sources, contribute to the total exposure, it becomes necessary to weigh each contribution relative to the MPE.
