

The measurement uncertainty was calculated for all measurements listed in this test report acc. To CISPR 16 – 4 "Specification for radio disturbance and immunity measuring apparatus and methods – Part 4: Uncertainty in EMC Measurements" and is documented in the LCS quality system acc. To DIN EN ISO/IEC 17025. Furthermore, component and process variability of devices similar to that tested may result in additional deviation. The manufacturer has the sole responsibility of continued compliance of the device.

1.8 Description Of Test Modes

Bluetooth operates in the unlicensed ISM Band at 2.4GHz. With the introduction of the enhanced data rate (EDR) feature, the data rates can be up to 3 Mb/s. An increase in the peak data rate beyond the basic rate of 1 Mb/s is achieved by modulating the RF carrier using GFSK techniques, resulting in an increase of two to three times the number of bits per symbol. The 2 Mb/s EDR packets use a π /4-DQPSK modulation and the 3 Mb/s EDR packets use 8DPSK modulation. The following operating modes were applied for the related test items. For radiated measurement, the test was performed with EUT in X, Y, Z position and the worse case was found when EUT in X position. All test modes were tested, only the result of the worst case was recorded in the report.

For pre-testing, when performed power line conducted emission measurement, the input Voltage/Frequency AC 120V/60Hz and AC 240V/60Hz were used. Only recorded the worst case in this report.

Worst-case mode and channel used for 150kHz-30 MHz power line conducted emissions was determined to be TX Mode(1Mbps-Hopping).

Worst-case mode and channel used for 9kHz-1000 MHz radiated emissions was determined to be TX-Middle Channel Mode(1Mbps).

2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10: 2013, FCC CFR PART 15C 15.207, 15.209, 15.247 and DA 00-705.

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209, 15.247 under the FCC Rules Part 15 Subpart C.

2.3 General Test Procedures

2.3.1 Conducted Emissions

According to the requirements in Section 6.2 of ANSI C63.10: 2013, AC power-line conducted emissions shall be measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

2.3.2 Radiated Emissions

The EUT is placed on a turn table and the turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10: 2013





5.2 Frequency Separation And 20 dB Bandwidth

5.2.1 Limit

According to §15.247(a)(1), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

5.2.2 Block Diagram of Test Setup



5.2.3 Test Procedure

- A. Place the EUT on the table and set it in transmitting mode.
- B. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the Spectrum Analyzer.
- C. Set to the maximum power setting and enable the EUT transmit continuously.
- D. For carrier frequency separation measurement, use the following spectrum analyzer settings:

Span = wide enough to capture the peaks of two adjacent channels; RBW / VBW=100KHz / 300KHz; Sweep = auto; Detector function = peak; Trace = max hold.

E. For 20dB bandwidth measurement, use the following spectrum analyzer settings: Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel; RBW/VBW=30KHz / 100KHz; Sweep = auto; Detector function = peak; Trace = max hold.





The Worst Test Plot Of Frequency Separation (1Mbps)




Test Plot Of Frequency Separation (2Mbps)









Test Plot For Number of Hopping Channel(GFSK)






5.4 Time Of Occupancy (Dwell Time)

5.4.1 Limit

According to §15.247(a)(1)(iii), Frequency hopping systems operating in the 2400MHz-2483.5 MHz bands. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4seconds multiplied by the number of hopping channels employed.

5.4.2 Block Diagram of Test Setup

- A. Place the EUT on the table and set it in transmitting mode.
- B. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the Spectrum Analyzer.
- C. Set center frequency of Spectrum Analyzer = operating frequency.
- D. Set the Spectrum Analyzer as RBW, VBW=1MHz, Span = 0Hz, Sweep = auto.
- E. Repeat above procedures until all frequency measured were complete.




5.5 Conducted Spurious Emissions and Band Edges Test

5.5.1 Limit

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. 5.5.3 Test Procedure





9KHz-26.5GHz Middle Channel(GFSK)






Hopping On - (GFSK)







Hopping Off - (GFSK)









7. LINE CONDUCTED EMISSIONS

7.1 Standard Applicable

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolt (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 



8. ANTENNA REQUIREMENT

8.1 Standard Applicable

According to § 15.203, An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.
