The test anechoic chamber in UL Verification Services (Guangzhou) Co., Ltd. Song Shan Lake Branch had been calibrated and compared to the open field sites and the test anechoic chamber is shown to be equivalent to or worst case from the open field site.

For below 30 MHz, lab had performed measurements at test anechoic chamber and comparing to measurements obtained on an open field site. And these measurements below 30 MHz had been correlated to measurements performed on an OFS.

5.6. WORST-CASE CONFIGURATIONS

The EUT was tested in the following configuration(s):

Controlled in test mode using a software application on the EUT supplied by customer. The application was used to enable a continuous transmission and to select the mode, test channels, bandwidth, data rates as required.

Test channels referring to section 5.4.

Maximum power setting referring to section 5.5.

Worst-case data rates as provided by the client were:

802.11b mode: 1 Mbps 802.11g mode: 6 Mbps 802.11n HT20 mode: MCS0 802.11n HT40 mode: MCS0 802.11ax HE20 mode: MCS0 802.11ax HE40 mode: MCS0

802.11b/g only support SISO mode.

802.11n HT20/HT40/ax HE20/HE40 support SISO and MIMO mode.

802.11b/g SISO mode, Antenna 1 and Antenna 2 has the same power setting parameter at section 5.5, and we have pre-tested for two antennas, only the worst data were recorded in the report.

802.11n/ax SISO mode and MIMO mode have the same power setting parameter at section 5.5, so only the worst case power mode(MIMO) will be record in the report.

The EUT has 2 separate antennas which correspond to 2 separate antenna ports. Core WF0 and Core WF1 correspond to antenna 1 and antenna 2 respectively.

The measured additional path loss was included in any path loss calculations for all RF cable used during tested.

Conducted output power, power spectral density tests separately on each port with all supported SISO & MIMO port combinations.

Conducted bandedge and spurious emissions tests were performed with SISO mode, as this port was found to have the worst case in terms of power settings amongst all supported possible SISO & MIMO port combinations.

Radiated emissions tests were performed with the MIMO modes. These were found to be the worst modulation scheme with regards to emissions after preliminary investigations and, as this mode emits the highest conducted output power level, it was deemed to be the worst case.

The EUT support Cyclic Shift Diversity(CDD), Space Time Coding(STBC), Spartial Division Multiplexing(SDM) modes. They use the same conducted power per chain in any given mode, so we only chose the worst case mode CDD for final testing.




