








HOW TO START

1. Turn your camera on
and turn camera WiFi on.
2. Turn REMOVU on by pressing [M] button for 1 sec.




3. When WiFi list shows up,
select a SSID that you want to connect.




4. Enter 8 the password of the camera SSID.

The password is 8 digits.

If less digits, enter button will not be activated.



5. If WiFi is connected with the camera,
live view will show up on REMOVU display.
Camera's current mode is on REMOVU.
If you want to change capture mode, press [M] button.






- Plug REMOVU into a PC with Micro USB cable in the package.




- Plug REMOVU into a USB wall charger (not provided with REMOVU) to charge faster. GoPro charger or iPhone charger will work well.




