For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. 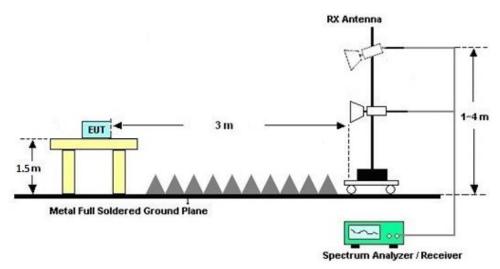
For radiated emissions below 30MHz
