### GFSK DH5 HCH 2480MHz Ant1 NTN



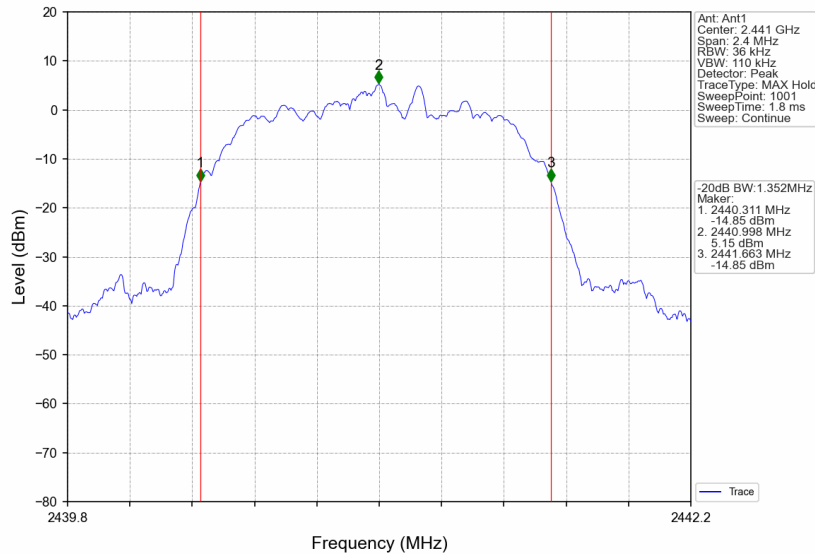

6.1.2 Test Graph

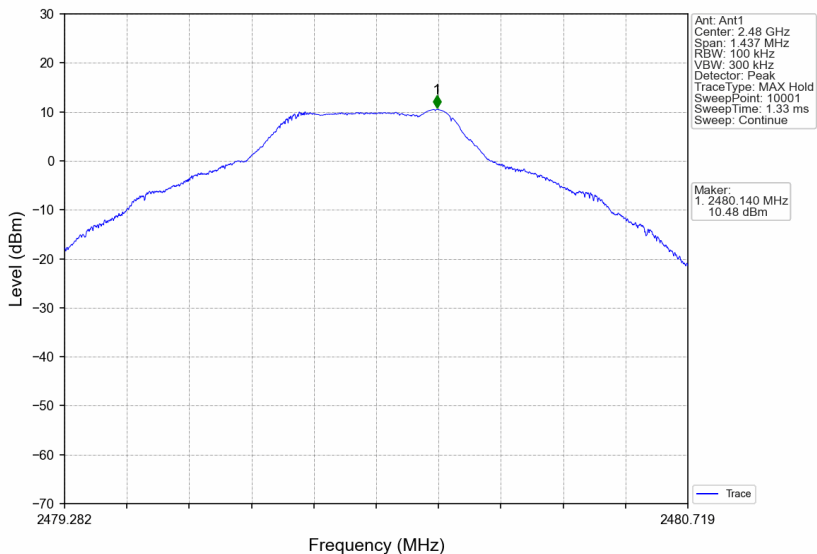
