


Fig.A.1.1.1: Test Setup Diagram for Conducted Measurements




Fig.A.1.2.1: Test Setup Diagram for Radiated Measurements




Fig.A.3.3 Power Spectral Density (802.11b, Ch 11)






Fig.A.3.4 Power Spectral Density (802.11g, Ch 1)




Fig.A.3.5 Power Spectral Density (802.11g, Ch 6)




Fig.A.3.7 Power Spectral Density (802.11n-HT20, Ch 1)






Fig.A.3.8 Power Spectral Density (802.11n-HT20, Ch 6)




Fig.A.3.9 Power Spectral Density (802.11n-HT20, Ch 11)






Fig.A.3.10 Power Spectral Density (802.11n-HT40, Ch 3)




Fig.A.3.11 Power Spectral Density (802.11n-HT40, Ch 6)








Fig.A.3.12 Power Spectral Density (802.11n-HT40, Ch 9)




Fig.A.4.6 DTS Bandwidth (802.11g, Ch 11)








Fig.A.4.7 DTS Bandwidth (802.11n-20MHz, Ch 1)




Fig.A.4.9 DTS Bandwidth (802.11n-HT20, Ch 11)




Fig.A.4.11 DTS Bandwidth (802.11n-HT40, Ch 6)




Fig.A.5.6 Band Edges (802.11n-HT20, Ch 11)

A.6. Transmitter Spurious Emission

- a) Set instrument center frequency to DTS channel center frequency
- b) Set the span to ≥ 1.5 times the DTS bandwidth
- c) Set the RBW= 100 kHz
- d) Set the VBW= 300 kHz
- e) Detector = Peak
- f) Sweep time = auto couple
- g) Trace mode = max hold
- h) Allow trace to fully stabilize
- i) Use the peak marker function to determine the maximum PSD level

Note that the channel found to contain the maximum PSD level can be used to establish the reference level.

Establish an emission level by using the following procedure:

- a) Set the center frequency and span to encompass frequency range to be measured.
- b) Set the RBW = 100 kHz.
- c) Set the VBW = 300 kHz.
- d) Detector = peak.
- e) Sweep time = auto couple.
- f) Trace mode = max hold.
- g) Allow trace to fully stabilize.
- h) Use the peak marker function to determine the maximum amplitude level.

Ensure that the amplitude of all unwanted emissions outside of the authorized frequency band (excluding restricted frequency bands) is attenuated by at least the minimum requirements specified in 11.11. Report the three highest emissions relative to the limit.
