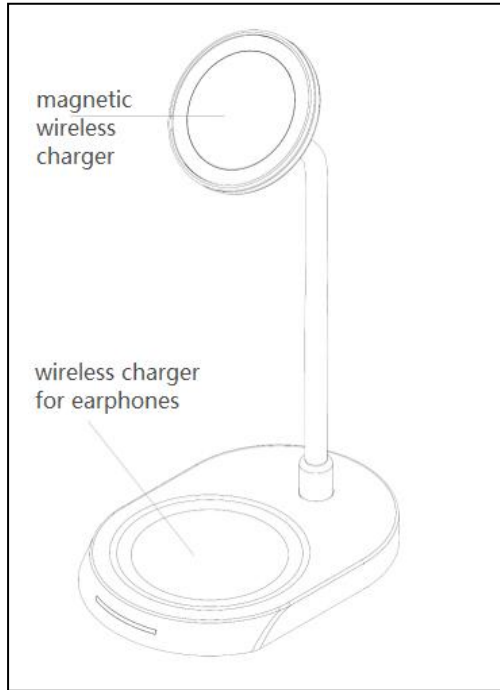

1. When wireless charging, make sure there is no metal foreign item in the wireless charging area.

3. Do not use this product in a high temperature, humid environment. Please stay away from fire and water.

4. The distance between mobile phone and wireless charger is less than 6mm when using wireless charging.
5. When using this product, please do not place metal foreign object (such as keys, coins, batteries or jewelry) on it, otherwise it will cause abnormal charging or hotness.
6. The position of the mobile phone protection case and the device on the wireless charger will affect the charging speed, the farther it is placed on the wireless charger from the central position, the slower the charging speed will be
7. Do not disassemble this product at will.
